Here are our thoughts on the order (verbal statement) expected tomorrow, as discussed in this afternoon's meeting.

WSBC guidance on mask use in workplaces

• Employers are already required by PHO order to develop a COVID-19 Safety Plan that includes protocols to protect workers from the risk of COVID-19 transmission. The protocols that employers must put in place must follow the hierarchy of controls, such that protocols that eliminate the hazard (by removing people or placing them at appropriate distances) are employed first, followed by the use of barriers where the hazard cannot be eliminated, and finally the use of masks when no other option is available.

Possible direction from PHO on masks

- If the PHO wants to issue guidance around the use of masks, that guidance could point employers back to this obligation, and require (as did the order from Nov 7) employers to review those plans and ensure appropriate controls have been selected and are functioning appropriately.
- To further highlight the scenarios where masks would be required, language such as this could be used:

"Some employers have specific guidance from the PHO and/or health authorities on protocols that must be in place at those workplaces (i.e. schools and healthcare). For all other employers, they are required to follow the hierarchy of controls described in the WorkSafeBC COVID-19 Safety Plan. This involves first ensuring that physical distancing is maintained wherever possible. Where physical distancing cannot be maintained, employers must then determine whether barriers can be

used. In cases where neither physical distancing nor barriers can be used, employers must ensure that workers are wearing masks. This obligation extends to the entire workplace, including not only shop floors but also kitchens, breakrooms, washrooms, meeting rooms, and shared worker transportation."

WorkSafeBC and public mask requirements

- WorkSafeBC does not have the jurisdiction to mandate that members of the public wear masks.
- WorkSafeBC's mandate and jurisdiction over employers requires them to ensure the health and safety of workers.
- In contexts where members of the public at a workplace are not coming into proximity
 to workers, an employer's obligation to ensure the health and safety of workers
 would therefore not require them to make those members of the public wear
 masks.
- In cases where members of the public do come into proximity to workers, our
 materials advise employers that they "may require or promote the use of masks".
 Our materials fall short of requiring the use of masks because employers have
 expressed concerns about being required to police the use of masks by members of
 the public in the absence of a public health mandate.



Re: Information on the new orders made by the PHO

Many of you likely have questions about what the new orders issued by BC's Public Health Officer, Dr. Bonnie Henry, mean for you and your work. We are committed to making sure your questions are answered and that you have the proper resources to keep your workplace, as well as your family, friends and co-workers safe

Issued due to the on-going surge of new COVID-19 cases throughout the province, the new orders came into effect as of midnight, November 19th, and will be in place until at least midnight on December 7th. They include the following:

- Masks are required to be worn in all public indoor settings and workplaces;
- Province wide travel restrictions;
- Restrictions on social gatherings that apply across the province, and;
- Employers are to make every effort to provide work from home options.

Updating COVID-19 Safety Plans

Like all of us, your employer must comply with the new public health orders. This means your worksite COVID-19 Health and Safety Plan will need to be reviewed and updated. You should expect that:

- Your employer reviews the new PHO orders and updates the COVID-19 Safety Plan as necessary
- Joint Health and Safety committee members or worker health and safety representatives participate in this process
- New worksite policies may need to be developed and implemented to meet the requirements of the orders
- Plans will include details on how to address members of the public who enter a worksite without a
 mask, and how they can be refused entry or service

Mask Requirements

Masks are now required for everyone in all public indoor settings and workplaces, and employers are expected to enforce the mandatory mask policy with both employees and customers. Key things to know are:

- A customer/ client can be refused entry or service if they do not wear a mask
- People who cannot wear a mask or who cannot put on or remove a mask on their own are exempt
- If you are unable to wear a mask for medical reasons, your employer is required to accommodate
 you. This may mean working from home or if that is not possible, exploring other options. If this
 applies to you, advise your supervisor and contact your steward or the BCGEU Area Office for
 assistance.

Remember, it is your employer's responsibility to enforce the mandatory mask policy, and a customer or client should be refused entry or service if they do not wear a mask. If someone at your worksite is not wearing a mask:

- Inform your supervisor and a member of your Occupational Health and Safety committee
- If the mandatory mask order is not being followed at your worksite, you have the right to refuse unsafe work.
 - If you choose to refuse, Notify your supervisor and your Occupational Health and Safety representatives immediately

Dear Post-Secondary Institution Presidents:

I am writing to you to acknowledge the important leadership the post-secondary sector has shown in BC's response to the COVID-19 pandemic over the past 12 months, and to support you with the critical goal of resuming safe on-campus teaching, learning and research in September 2021.

Your institutions worked in partnership with the BC Centre for Disease Control, WorkSafeBC, the Ministry of Advanced Education and Skills Training, and staff in my office to produce and update the "COVID-19 Go-Forward Guidelines for B.C.'s Post-Secondary Sector." Those Guidelines and your institutional health and safety plans helped the sector to be very successful in mitigating the spread of COVID-19. The quick adaptation to remote learning, while staying open and available for learners, played a major role in the success of B.C.'s pandemic response.

My office and our medical health officers share your concerns about the wellbeing of young adults who are disproportionately affected by the pandemic, including worsening mental health, increased financial instability and diminished future prospects. We also acknowledge this has been a difficult and stressful time for faculty and staff. It is imperative to get back on campus for everyone's health and well-being.

There are very good reasons to be confident that a return to on-campus instruction in the fall can be undertaken safely and successfully. Current projections of the COVID-19 vaccine supply in BC suggest that all vulnerable and high-risk groups should be immunized this spring, and the majority of the adult population by the summer. Young adults aged 18-24 should receive the vaccine no later than the end of July, but more likely sooner. The timing of immunization should not be a determinant of planning for a return to on-campus activities.

Given the expected timelines for immunization it is essential that we plan for a full return to inperson activities on campus in September 2021, including in-person instruction, with faculty and staff returning to campus sooner. Immunization will support what seems likely to become stable coexistence with COVID-19 as another manageable, seasonal ailment.

New variants of the SARS CoV-2 virus will likely continue to emerge. We will respond to them through monitoring, re-formulation of tests and vaccines, and through other measures as needed depending on the characteristics of the variants. Targeted testing and contact tracing by health authorities will remain key supplements to immunization in rapidly controlling transmission. These activities will be part of normal, ongoing life with COVID-19.

We have also learned over the past year that when we implement effective safety plans, large sectors can operate safely. Reducing the opportunity for infectious contacts will continue to be an important strategy. As such, safety plans will remain important, with updates as required. My team looks forward to working with you to fine-tune plans for the prevention activities we have all become so familiar with: self-administered health checks; facilitating hand cleaning through access to soap and water or encouraging people to use hand sanitizers; use of masks; early detection and rapid testing of potential cases; isolation; and case and contact management.

The experience of the past year can help with a safe return to post-secondary campuses. Above and beyond immunization, infectious contacts in group settings at post-secondary institutions can be reduced through a variety of prevention and exposure control measures. Two-meter physical distancing has been my guidance for uncontrolled group settings. Such distancing is neither practical, nor necessary, in the controlled context of post-secondary instructional settings. I am very confident that the combination of immunization and continued application of the "COVID-19 Go-Forward Guidelines for B.C.'s Post-Secondary Sector" will support the safe and complete resumption of campus teaching, learning, and research.

We also believe student housing, dining and other on-campus student services will be able to return to normal or close-to-normal capacities by following revised protocols in the "COVID-19 Go-Forward Guidelines for B.C.'s Post-Secondary Sector."

Based on what we have learned in the past year, and the important protection that immunization will provide, I, as well as the medical health officers in British Columbia, strongly support the resumption of on-campus activities in September 2021. Public health will also continue to work with post-secondary institutions to determine if measures are needed to keep activities inside and outside the classroom safe in the fall, such as public transportation, socializing outside of class, athletics, and arrival and quarantine of international students.

Thank you, again, for the important role you play in supporting the provincial COVID-19 response, and in helping British Columbians to realize the full experience and benefits of post-secondary education. I look forward to working with you to strengthen the collaboration between public health and post-secondary institutions for a full and safe return to on-campus instruction in September 2021. We all look forward to the rich campus interactions that will make learning and personal development so much more effective and supportive for students, faculty, and staff.



Dear Chris Hebb, Commissioner, British Columbia Hockey League

Thank you for your request for reconsideration of the Provincial Health Officer *Gatherings and Events* order as applied to the BC Hockey League (BCHL) for the following variances:

- 1. **Travel**: One-time variance to the *Gathering and Events* order to allow sport-related travel for teams that will be housed in hotels to travel to and from the hub locations.
- 2. **Travel**: Ongoing variance to the *Gathering and Events* order for child and youth sport-related travel for cross-hub gameplay from April 2nd and May 15th.

 Child & Youth Sport Contact & Competition: Variance to Gathering and Events order to allow child and youth sport contact and competition for pre-season and season hockey activities between April 2nd and May 15th

I have reviewed your request and Return to Play protocol, and it has been reviewed by medical health officers and public health staff in the affect regions. I have taken into consideration their input and appreciate that you are open to continuing to work with the local public health staff on further details. In particular I note that the pod concept limits the amount of team travel and teams interacting, there is a fourteen day quarantine period in place to reduce the risk of virus introduction, strict protocols are in place to limit interaction between players and the communities, strict protocols are in place to reduce the risk of transmission between players, coaches and staff, and that you have appointed a medical advisor.



Thank you for the opportunity to provide comment on this emergency order. We think it is clear that it applies to retired physicians who are not otherwise eligible for emergency registration, and to IMGs who are not otherwise eligible for any form of registration with the College of Physicians and Surgeons of BC.

We will be preparing a communication to go out to our health authority partners once this order is "live" to help the medical affairs offices understand the difference between a physician who holds emergency registration versus a retired or IMG physician that does not hold registration and must be trained, assessed as competent, and do their work under supervision.

We will also provide advice to our health authority partners as to how to get verification of medical degree and the part 1 exam.

Good Afternoon,

On February 23, 2021, the Provincial Health Officer made two orders (<u>Regulated and Unregulated Health Professionals SARS-CoV-2 Immunization Order</u> and <u>Emergency Medical Assistants SARS-CoV-2 Immunization Order</u>) to allow a range of health professionals and occupations to temporarily provide COVID-19 immunization services during the declared COVID-19 public health emergency. These orders were made in response to the anticipated high number of vaccinations required as a part of BC's COVID-19 Immunization Plan.

Attached are two draft orders for your comment and consideration. These proposed orders would replace the existing orders mentioned above. Given the urgency related to implementing the province's COVID-19 immunization plan we are requesting feedback on the proposed orders by 9am, Friday March 12, 2021, my apologies for the very short timelines. Feedback should be submitted via email to PROREGADMIN@gov.bc.ca and Christopher.Bennett@gov.bc.ca. As a part of the order development process this feedback will be shared with both the Minister of Health and the Provincial Health Officer for their consideration.

These proposed orders would make a number of changes (as compared to the existing orders), including:

- Add additional health professionals and occupations who can provide COVID-19 immunization services temporarily under the order, including:
 - Retired medical practitioners, retired licensed practical nurses, retired registered psychiatric nurses and retired midwives who are not registered with their regulatory college (intended for those who are not eligible for temporary emergency registration with the colleges). The health authorities/employer would be responsible to:
 - ensure these practitioners have completed the training,
 - assess the competence of each practitioner,
 - ensure appropriate supervision, and
 - assume liability related to these retired individuals.
 - Dental therapists
 - International Medical Graduates (not eligible for registration with the College of Physicians and Surgeons of BC) who have met specific qualifying requirements, including:
 - a medical degree from a medical school outside of Canada listed in the World Directory of Medical Schools, which includes a sponsor note indicating it is an acceptable medical school in Canada,
 - a medical degree that has been verified by physicianapply.ca, and successful completion of the Medical Council of Canada Qualifying Exam (MCCQE) Part 1
 - proof of British Columbia residence
- Streamlining training requirements—it was identified that the full BCCDC Immunization Course (C1 in the orders) and abbreviated Immunization Course (C2) encompass many of the other training components outlined in the current orders. Following this, some of the training requirements outlined in the orders have been streamlined and hyperlinks updated.
- Streamline training/tweak scope of services—minor amendments to some of the training requirements and the scope of COVID-19 immunization services that some professionals would be permitted to provide.

As these orders are subject to government review and decisions by the Minster of Health and Provincial Health Officer, please treat them as highly confidential and do not share or distribute outside of your organization and within your organization only to a few individuals whose feedback is critical for your review and response and who understand the confidential nature of these draft orders.

Note: the above list of professions does not include health professionals who are already authorized to provide COVID-19 immunization services as per their current scope of services.

As noted above, these orders are time limited and would only apply during the declared COVID-19 public health emergency and are not permanent changes to scope of practice.

I was thrilled when the vaccination decision was made, and I am extremely proud of the efforts of our entire TFW Program team in pulling this week's clinic together. Its been hours of overtime in addressing the logistics challenges.

I'm attaching a cropped picture of a worker who, like many others yesterday, was snapping pictures of himself after he got his vaccine—<u>proudly</u> showing off his little round Band-Aid. Many TFWs were quick to send photos to the consulate staff and back home to their family. They feel cared for and supported in BC. The Mexican Consul General apparently sent a note of gratitude to the Minister of Agriculture for making this happen in the quarantine program.

You should know that all of us are extremely proud to be a part of this effort and work in a Province that has led the way in protecting the health and welfare of TFWs who's work puts food on our tables.

ORDER OF THE PROVINCIAL HEALTH OFFICER

(Pursuant to section 13 of the *Health Professions General Regulation*, B.C. Reg 275/2008)

REGULATED AND UNREGULATED HEALTH PROFESSIONALS SARS-CoV-2 IMMUNIZATION – March 24, 2021

WHEREAS:

- A. On March 17, 2020 I provided notice under section 52 (2) of the *Public Health Act* that the transmission of the infectious agent SARS-CoV-2, which has caused cases and outbreaks of a serious illness known as COVID-19 among the population of the Province of British Columbia, constitutes a regional event as defined in section 51 of the *Public Health Act* (the "Emergency");
- B. Immunization against the infection SARS-CoV-2 includes one or more of the activities set out in column B of Appendix A (each an "Immunization Activity");
- C. I am of the opinion that:
 - (i) the operation of a health profession regulation is adversely affecting the timely delivery of the Immunization Activities, the scope of Immunization Activities that can be delivered, and the efficient and effective use of health human resources, throughout British Columbia, and
 - (ii) health professionals set out in column A of Appendix A (each an "Authorized Health Professional") may perform an Immunization Activity, as authorized by this order, without undue risk to the health or safety of the patient or any other person; and
- D. For the purposes of applying this order to a particular Authorized Health Professional:
 - (i) the authorized Immunization Activities are specifically set out in the entry in column B of Appendix A that corresponds to the Authorized Health Professional,
 - (ii) for greater certainty, the authorized Immunization Activities specifically exclude the services (if any) set out in the entry in column C of Appendix A that corresponds to the Authorized Health Professional,
 - (iii) the applicable specific limits (the "**Specific Limits**") are set out in the entry in column D of Appendix A that corresponds to the Authorized Health Professional,

THIS ORDER REPEALS AND REPLACES MY EMERGENCY ORDER OF MARCH 14, 2021 WITH RESPECT TO REGULATED AND UNREGULATED HEALTH PROFESSIONALS SARS-CoV-2 IMMUNIZATION.

I, Dr. Bonnie Henry, Provincial Health Officer, order that notwithstanding any requirements set out in a health profession regulation that conflict or may conflict with this order, an Authorized Health Professional is authorized to perform an Immunization Activity, subject to the following conditions:

- The Immunization Activity must be performed in the course of providing a SARS-CoV-2 immunization program approved by a medical health officer with responsibility for the geographic area in which the Immunization Activity is performed.
- 2. The Immunization Activity must be conducted in accordance with the resources issued by the BC Centre for Disease Control (the "**Resources**") posted at the following website:

http://www.bccdc.ca/health-info/diseases-conditions/covid-19/covid-19-vaccine/resources-for-health-professionals

- 3. The Authorized Health Professional must complete all Mandatory Training before performing the Immunization Activity.
- 4. The Authorized Health Professional must comply with the Specific Limits (if any).
- 5. The Authorized Health Professional's employer or a medical health officer must first assess the Authorized Health Professional's competence to perform the Immunization Activity in a manner that is safe for both the patient and the Authorized Health Professional, including by requiring the Authorized Health Professional to demonstrate knowledge and skill, in accordance with the Resources, respecting the Immunization Activity. The Authorized Health Professional's employer may only make this assessment if the employer is a registrant, or is acting on the advice of a registrant, who has assessed the Authorized Health Professional and who is authorized under a health profession regulation, and competent, to perform the Immunization Activity.

Unless repealed earlier, this order will end on the date that I provide notice under section 59 (b) of the *Public Health Act* that the Emergency has passed.

Text follows:

Dear friends,

Thank you for the patience, support and understanding you have shown to my office during the course of the Covid-19 pandemic. I have asked **Dr.** Robert Daum to reconvene our group urgently so I can discuss some discouraging news.

Since our discussion on Thursday, the course of the pandemic has become sharply more negative. Case counts, which had plateaued at a worrisome level, have now begun to climb sharply. The share of tests that are positive has also risen very quickly across the province. We are seeing more cases resulting from variants of concern and new variants causing cases. All of these factors are increasing pressure on our health care system.

For all these reasons, and with a heavy heart, I believe it necessary to take further urgent

measures to curb transmission, starting at midnight tonight, **Monday**, **March 29**, and running until **at least midnight** April 19. They include restrictions to end indoor dining and limit restaurants to take-out or patio service, the effective closure of Whistler's ski facilities, a resumption of work from home for all those able to do so and strong advice to avoid all non-essential travel.

I also much regret that I feel we must return to the more restrictive measures on **indoor** worship that were in force before last Thursday's announcement. I **recognize that these decisions will** disappoint many people, and I had hoped that they would not be necessary. But the course of the pandemic leaves me no other choice. I continue to value your judgment about the impacts of these emergency health measures on your communities.

Thank you for your continued understanding.

Addendum - Public Health Guidance for K-12 Schools

March 30, 2021

Due to the recent rise in cases of COVID-19 in BC, the Provincial Health Officer has recommended the following time-limited changes to the Non-Medical Masks and Face Coverings (Masks) section, and any other sections where mask guidance is provided, to the Public Health Guidance for K-12 Schools.

Effective immediately, all staff, adult volunteers and visitors, and all Grade 4 to 12 students should wear a non-medical mask or face covering (a "mask") at all times while indoors at school, subject to the exceptions noted below.

Exceptions:

The recommendations above should not apply as follows:

- To a person who is unable to wear a mask because they do not tolerate it (for health or behavioural reasons);
- To a person unable to put on or remove a mask without the assistance of another person;
- If the mask is removed temporarily for the purposes of identifying the person wearing it;
- If the mask is removed temporarily to engage in an educational activity that cannot be performed while wearing a mask (e.g. actively playing a wind instrument, high-intensity physical activity, etc.);
- If a person is eating or drinking;
- To a person who:
 - o Can maintain at least 2 metres from another person; or
 - Is behind a barrier;
- While providing a service to person with a disability or diverse ability (including but not limited to a hearing impairment), where visual cues, facial expressions and/or lip reading/movements are important.

Staff, adult volunteers, and all Grade 4 to 12 students should wear a mask at all times while on a bus, subject to the exceptions noted below.

Exceptions:

The recommendation above should not apply as follows:

- To a bus driver while driving;
- To a person who is unable to wear a mask because they do not tolerate it (for health or behavioural reasons);
- To a person unable to put on or remove a mask without the assistance of another person;
- If the mask is removed temporarily for the purposes of identifying the person wearing it; or
- While eating or drinking.

Kindergarten to Grade 3 students are encouraged to wear a mask at school and on buses, but should not be required to do so.

If an activity cannot be implemented in line with this guidance, it should be adapted or another activity should be selected.

Schools continue to be encouraged to support student mask use through positive and inclusive approaches, and not punitive or enforcement activities that exclude students from fully participating in school or that could result in stigma.

No student should be prevented from attending or fully participating in school if they are not wearing a mask.

This guidance has been issued along with other <u>extensive public health measures</u> announced March 29th 2021 by the Provincial Health Officer. This addendum is in place until April 19th, 2021, at which point it will be reviewed. Unless revised, the guidance in this addendum should be used in place of masking guidance in the <u>Public Health Guidance for K-12 Schools</u>.

Good morning,

I understand talks are underway with Worksafe to ensure they include mask policy in Covid workplace guidelines. I have been contacted today by Save-On and the Retail Council, who favour the mandate approach, to ensure we have clear messaging on support for staff who must enforce the mandate. Customers are confronting each other and staff on the issue of masks and expecting staff to expel those not wearing masks.

The safety of staff is also an employer responsibility in this case. Security guards could be available. Plans need to be in place for those seeking accommodation on mask wearing due to disability. ETc. Ultimately, management should close down briefly if necessary to resolve conflict. I'll leave specifics to the experts.
