YOUTH

- ImmsBC allows for registration and booking of 12+ (2009) as of Wed, May 19th
- Youth can register and book themselves individually with the same process used now
- Parents can also register their children and provide their own (parent's/guardian's/trusted advisor's) contact info on registration if preferred
- Approach is to use mass clinics, especially in large centres, although smaller communities may vaccinate outside of clinics (e.g. schools, other centres) or be done by school catchment area or as part of whole community approach

 HAs are to prioritize COVID-19 vaccinations over existing school-based immunizations for Grade 6 and 9 and ensure messaging is clear that their COVID-19 immunization is to be two weeks apart from any other immunization

#### FAMILY/HOUSEHOLD FLEXIBILITY

- Family or household units can be vaccinated together on one appointment
- Household/family units should register each member wanting a vaccine before arriving at the clinic
- However, they only need to have one appointment booked and can then can bring their eligible kids
  - They can bring them to their own existing upcoming or new appointment
  - o They can book one child to a new appointment and bring all of them
  - A neighbour or trusted adult can do all this, doesn't have to be a parent
  - o As noted above, kids can do it on their own with no parent or trusted adult

#### CONSENT

- The Infants Act allows a health care provider to immunize youth at any age (a minor) if they are deemed a "mature minor"
- Youth fall into the "mature minor" category if a health care provider has provided them with information,
  has given them a chance to ask questions and believes the youth has the necessary understanding to give
  the consent
- Mature minor authority takes precedence over parental authority (i.e. a youth can agree to a vaccine even if their parents don't want them to have it and can decline a vaccine even if their parents do)
- No written consent is required from the parent or guardian. No extra form needs to be submitted. There is a checkbox in ImmsBC that covers required documentation of mature minor consent.
- · Clinics should follow the attached checklist for obtaining mature minor consent

#### **CONSIDERATIONS**

- HAs may consider working with schools or districts on busing kids into mass clinics and blocking appointments for this purpose (COVID safety protocols would need to apply)
- HAs to determine specific messaging for First Nations communities, whole communities or school catchments in smaller communities
