B.C. COVID-19 Pandemic Update

VICTORIA – As of Wednesday, Sep. 1, 2021, 84.5% (3,915,153) of eligible people 12 and older in B.C. have received their first dose of COVID-19 vaccine and 76.7% (3,556,961) received their second dose.

In addition, 85.1% (3,682,078) of all eligible adults in B.C. have received their first dose and 77.7% (3,362,840) received their second dose.

B.C. is reporting 785 new cases of COVID-19, including five epi-linked cases, for a total of 166,853 cases in the province.

There's no question that our health system has faced increased pressures due to COVID-19. Surgery postponements are stressful for people and we want to assure these people that rescheduling all surgeries as quickly as possible is a priority.

Over the past year, we have done extraordinary work across the province, and in Island Health specifically, to increase surgical capacity. The most recent Surgical Renewal Commitment Progress Report shows that we continue to change the way we are delivering surgery in B.C. by offering surgeries during extended hours and on weekends, changing our wait list management practices, and focusing on patients most in need.

Through these efforts, 98% of the patients in VIHA whose surgeries were postponed in the first wave of COVID-19 — who still wished to have surgery — have had their surgery. Between March 31, 2020 and March 31, 2021, VIHA decreased the total waitlist size by 20% -- from 19,657 to 15,816 — and the operating rooms ran 8,892 more hours — a 10% increase — compared to the same timeframe in the previous year. During this timeframe between 2020 and 2021, VIHA completed 56,496 scheduled and unscheduled surgeries. To support completing these surgeries as soon as possible, Island Health has added 17 initiatives to increase their surgical capacity.

Across all health authorities, we've hired four surgeons (for a total of 55), eight anesthesiologists (for a total of 64) and 48 operating room registers nurses (for a total of 519) since April 1, 2020. Despite challenges posed by COVID-19, our surgical system is stronger than ever and we will continue to build on the progress we have made so far.

- In general, in situations where an individual's behaviour is impeding staff's ability to safely
 provide care to other patients with emergent health concerns, staff may seek support from
 Protection Services to take appropriate steps to ensure a safe environment for everyone
 involved.
- Island Health is committed to embedding cultural safety and humility in the delivery of health and care for Indigenous people.
- We are working in partnership with, and guided by, First Nations communities to implement the
 recommendations within the In Plain Sight report put forward by Mary-Ellen Turpel-Lafond, to
 ensure Indigenous peoples across the province have access to the safe care they deserve. We
 acknowledge that systemic Indigenous-specific racism exists, and while some steps have been
 taken to make healthcare safe and accessible, more needs to be done.
- Island Health is developing an Indigenous-specific action plan, created in partnership and guided by community, to take action to ensure safe access to care for Indigenous people, as well as supporting Indigenous staff within our health authority.
