july 29-August 4: average daily Dose 1: 4397

Aug 5-10: " 3814

Aug 11-16 " 3720

Aug 17-22 " 3447

announcement Aug 23

Aug 24-30 " 6382

Aug 31-Sept 5 " 4540

Sept 5-11 " 4320

This data is directly from the PIR report - we picked Dose 1 because it is indicative of new recruits for vaccination - once they get Dose 1 there is close follow on for Dose 2 very consistently.
