EXECUTIVE SUMMARY

Revera, the owner of Capilano Care Centre in West Vancouver, is providing 365-day written notice of closure to residents, families and staff on April 7, 2021. VCH will support residents and families in the transition to new LTC homes and VCH will work with Revera and the unions to ensure that displaced staff have other employment opportunities with Revera or VCH.

PREVIOUS DISCUSSION & DECISIONS

Revera met with Ministry of Health (MoH) on September 1, 2020 to request assistance in locating alternate land to build a replacement facility. At this meeting, Revera presented three options:

BACKGROUND & CONTEXT

Capilano Care Centre is a 50-year-old facility with 205 beds in 135 rooms. All of the beds are contracted to VCH.

Throughout 2012-13, VCH undertook an assessment of its contracted LTC homes to determine operational and capital priorities for replacement of bed stock that no longer met design guidelines to meet the care needs of complex LTC clients.

As part of this process, Capilano Care Centre was one of three North Shore facilities identified for decommissioning, along with West Vancouver Care Centre and Evergreen House at Lions Gate Hospital. West Vancouver Care Centre is closing in May 2021 and is being replaced by Creekstone Care Centre, which is opening in April.

On November 12, 2020, Revera initially verbally informed VCH that they intended to issue 365 days' notice to end their contract with VCH and cease operating Capilano Care Centre; written notice was delayed because of the significant COVID-19 outbreak at the facility.

On February 9, 2021, Revera provided verbal one-month notice of the 365-day closure period followed by a letter on February 18, 2021 confirming March 9, 2021 as the start date of their 365-day notice.

On February 24, 2021, VCH asked Revera to delay notification to residents/families to allow VCH to better plan and coordinate communications to resident/families and community stakeholders with Revera. Revera agreed and will inform residents, families and staff on April 7, 2021 with final closure April 6, 2022. VCH has worked closely with Revera on the process to announce the closure to residents, families and staff to ensure that the provincial closure policy is adhered to.

Impact of closure on residents and families

Currently, 150 people reside at Capilano Care. Intake was halted during the Covid outbreak in the Winter 2020/2021 and has not resumed. Given the one-year notice, and the opening of the new 180-bed facility at Creekstone Care, we anticipate that all of the residents can remain in the North Shore if they wish.

VCH will be following the HCC Policy Manual section 6(J) *Movement of Clients* and the Provincial Guidelines for *Closure of Residential Care Facilities* on the closure of the facility and working with residents and their families to choose alternative sites. As there will only be one funded facility left in West Vancouver, Inglewood Care Centre, it will not be possible to guarantee a West Vancouver community placement for those leaving Capilano Care Centre.

A detailed communication and information-sharing plan has been developed to ensure that residents and families are well supported on April 7th and that a transition team has been created to support resident needs. Revera will be providing notice to all residents and families, hosting town halls with residents (and staff), and VCH will be providing Case Managers to meet with every resident / family to answer questions and explore their options. Additionally, VCH will be calling all families in the first few weeks to ensure that they are feeling supported.

Impact of closure on staff at Capilano Care

Revera currently has 221 FTE of direct care staff and 12 excluded staff at the facility. The breakdown of staff FTE is a follows:

The employees are represented by the BCNU and the HEU. Revera will advise the unions of the section 54 labour adjustment on April 6th on an embargoed basis.

In addition to the direct Revera staff, Revera has contracted with Compass Marquis for Food services, housekeeping and laundry. They have approximately 36 FTE that are represented by the UFCW and 3 FTE that are excluded.

VCH will be engaging in discussions with our union local representatives to propose that Revera regular nursing and care aide staff who do not have ongoing employment options with Revera be afforded access to VCH vacancies.

VCH will be requesting our Contractors for support services (housekeeping and food services) to consider hiring displaced Revera housekeeper and food services staff.

Impact of closure on the Community of West Vancouver

With the closure of Capilano Care Centre and West Vancouver Care Centre, the community of West Vancouver will have one (1) funded facility left (Inglewood).

The closure will represent 16 % loss of bed base to the North Shore community. Existing Capilano Care residents will be able to stay on the North Shore if they desire, but future new placements may require some North Shore residents accept beds in other areas of VCH.

VCH is currently exploring options on how to replace the 205 funded beds that have been lost at Capilano Care Centre.



Dear Ms. Bedford,

As explained during our conversation on September 1, 2020 and as outlined in our follow up correspondence dated September 8, 2020, the physical infrastructure at Capilano Care Centre is quickly approaching the end of its useful life, and the building's 50-year-old design and layout are not suited for what current and future seniors, with increasingly complex care needs, expect and deserve. For those reasons, we are providing you with one year's notice under section 19 of the Hospital Act, B.C. Reg. 121/97 and section 9 of the Community Care and Assisted Living Act, B.C. Reg. 96/2009 of our intention to permanently suspend operations at the Home effective April 6, 2022. In connection therewith, we will be surrendering the Home's Private Hospital License No. 09-002 for 73 beds and the Community Care and Assisted Living License for 148 Residential Care Beds effective as of the same date.

The care and safety of Capilano Care Centre's residents continues to be our highest priority. Over the course of the last several weeks, we have been working collaboratively with Vancouver Coastal Health Authority ("VCH") on a mutually acceptable transition plan that ensures continuity of resident care. We are also pursuing a range of strategies to support our dedicated staff in transitioning to new employment opportunities. A notice is also being provided to VCH under separate cover regarding termination of the Service Agreement.

We will be providing notice of the pending closure of the Home to staff and residents of the Home, as well as the contacts and representatives of the residents, on April 7, 2021. We kindly ask that this communication be kept confidential until such time as the residents and staff of the Home have been notified.





It has been our privilege to work in partnership with the BC Ministry of Health to serve the residents and families of Capilano Care Centre for 50 years.

Dear Mr. McDonald, Ms. Prpich and Ms. Murdock,

On behalf of all of us from Revera who participated in the call on Tuesday, September 1 regarding Capilano Long Term Care Home, I want to thank you and your colleagues for a very productive conversation. We all share a commitment to the health and wellbeing of seniors in British Columbia, and we appreciate the Ministry's interest in helping us plan a path forward that best serves the long term care system in British Columbia while preserving the safe care of the 205 older citizens currently residing at Capilano.

As promised, we have attached a summary of the actions Revera has taken to date regarding this home, the options we have considered, as well as the economic investment and impact of building a new long-term care home.

Options Explored

As you know from our conversation, we have expended significant resources over the past few years and have carefully considered feasible alternatives that would allow for continued operations. Here is a recap of the options we mentioned on the call:





- Convert Capilano to CCALA Home/Redevelop Existing Site (Including housing Capilano Hospital Beds):
 Due to the structural limitations and the significant presence of multi-resident suites, without wideranging permanent exemptions from certain structural requirements and considerable governmental
 capital and operational assistance, a CCALA conversion would not be feasible. The age of Capilano and
 its configuration make redevelopment at the current site, within the construct of a CCALA conversion
 or otherwise, both cost prohibitive and irrevocably disruptive to our residents and staff and our
 operations.
- 2. Redevelop on a New Site: As we mentioned, one approach would be to acquire a new site that allows for feasible redevelopment based on reasonable land and construction costs, and preferably located closer to the areas from which Capilano draws its employees, residents and staff (within the boundaries of Metro Vancouver). The inclusion of specialty care units, including complex care units or private adult living rental units and possibly even brain health and mental wellness initiatives, may also be possible. However, redeveloping at a new site would not be economically feasible without additional funding and help with securing land at below market rates. We are not in a position to cost out the funding requirements without a more comprehensive discussion regarding the scope of development—that is, the number of beds, types of units to be included, and so forth. We are open to having this discussion.

From our previous discussions with the Vancouver Coastal Health Authority and BC Ministry of Health, we were under the impression that that such funding is not available for this effort, and that the number of beds otherwise available are assessed by them to be adequate. We respect this direction and as a result, we understood that the redevelopment option was off the table. That said, should circumstances change, we remain open to discussions but note that building a new long term care home takes at least 4 years, and we are not confident that continuing to operate the Capilano Continuing Care Home for another 4 years is in the best interest of our residents and staff. Should redevelopment be an option it is likely that Capilano will need to close before the new building is completed.

We also note that the redevelopment of a long-term care home creates economic value for a province. Hundreds of construction jobs are created, and over \$100 million dollars is invested in social infrastructure.

3. Close Capilano: As we discussed, with the building nearing functional obsolescence, the most viable option we see is to close Capilano. The result of such closure will be to reduce the number of private hospital bed licenses in the system and leave British Columbia seniors with fewer available options. However, we understand that VCH does have some available options to recoup the lost capacity, including the redevelopment of certain beds and relying on existing capacity elsewhere within the City of Vancouver. Job losses could be mitigated by the reallocation to direct care hours at other facilities.



Working Together on a Plan Forward

As outlined on the call, we are at a critical juncture regarding the continued operation of Capilano. Aging equipment like the elevators are nearing the end of their useful lives, and the building has numerous infrastructure challenges that are beyond simple maintenance or renovation. At nearly 50 years old, Capilano is also not designed for modern standards or for what today's senior, with increasingly complex care needs, expects and deserves. These challenges have been exacerbated by the pandemic, which has highlighted the long-standing challenges in long term care, including evidence that suggests aging homes with ward-style rooms may hinder infection prevention and control.

We know that you understand that we cannot put the long term safety of residents at risk. We believe that the best path forward is for the Ministry of Health and Revera to work closely together on a coordinated plan for Capilano Care Centre. I look forward to our next discussion.
