Question being asked

Statistics on patients admitted to hospitals and mental health facilities related to both mental health and substance use diagnoses.

Summary of Analysis

Inpatient hospitalizations are selected from the Discharge Abstract Database if they contain at least one substance use diagnosis recorded, and/or at least one mental health diagnosis that is not substance use.

The number of cases is reported by fiscal year and two broad age groups (<25 and 25+).

To ensure the appropriate information is availble, the data is provded in 4 different ways:

- 1) Inpatient cases with both a substance use and non-substance use mental health diagnoses
- 2) Inpatient cases with a non-substance use mental health diagnoses (may or may not also have a substance use diagnosis)
- 3) Inpatient cases with substance use diagnoses (may or may not also have another mental health diagnosis)
- 4) Inpatient cases with mental health and/or substance use diagnoses by age and fiscal year

Note that Table #2 + #3 -#1 = #4

1 This report contains case counts of hospitalizations with both a mental health and a substance use diagnosis on the inpatient record

- 2 All diagnosis codes available in the hospitalization record are used for the purposes of identifying mental health and substance use cases.
- 3 Mental health diagnoses are identified using the ICD10 diagnosis codes Schizophrenia, schizotypal and delusional disorders ('F200', 'F201', 'F202', '203', 'F205', 'F206', 'F208', 'F209', 'F21', 'F22', 'F23', 'F24', 'F25', 'F28', 'F29') Mood [affective] disorders ('F3'),

Neurotic, stress-related, and somatoform disorders ('F40', 'F41', 'F42', 'F43', 'F488', 'F489') Eating disorders ('F50')

Disorders associated with the pueperium ('F530', 'F531')

Childhood emotional disorders ('F938')

Disorders of adult personality and behaviour ('F60', 'F61', 'F62', 'F68', 'F69')

4 Cases with substance use diagnoses are identified by looking for both substance use disorders and some types of poisoning.

Substance use disorders including acute intoxication, dependance, and withdrawal are identified using ICD-10 codes beginning with 'F1'. This code includes disorders due to alcohol, opioids, cannabinoids, sedatives, hypnotics, cocaine, stimulants including caffeine, hallucinogens, tobacco, volatile solvents, and other psychoactive substances. Abuse of non-dependence-producing substances is also captured using 'F55'.

Overdose and poisonings are included using the codes 'T40' (Poisoning by narcotics and psychodysleptics (hallucinogens)) and ,'T43' (Poisoning by psychotropic drugs not elsewhere classified. This category includes antidepressants, antipsychotics, and psychostimulants with abuse potential.)

Note that alcohol poisoning is not included nor is poisoning by some other drugs like barbiturates and benzodiazepines.

- 5 Care levels Acute, Rehab, Day Surgery, and Tertiary Psychiatric (A, R, S, P) are included. Note that only a small number of Tertiary Psychiatric facilitities report to the DAD. Facilities that do not report to the DAD are not included.
- 6 Discharge date is used to define the year of each case. Only discharged cases are included.
