I am hoping you could please pass this BEA along to Doug Scott for review and approval, before also getting approval from Neilane. Wisty Chaytor and I have provided the below case to support the request. I have attached the BEA signed with Lloyd's approval, as well as the proposal from the Ramada s.16

Issue:

The requested spending approval is to support s.16
s.16 on October 17-19, 2016.

Background:

The s.16 have been meeting with BC and Canada s.16 on a monthly basis for several years. Due to the locations of these two First Nation communities, s.16 was determined to be the mid-point allowing all Parties the ability to travel to and from on a daily basis without incurring overnight accommodation costs. This has greatly reduced the overall travel budget for all Parties including BC.

In respect of spending restrictions, reasonable efforts have been made to secure the most cost effective meeting location possible. Available "free" locations have been researched and deemed unsuitable due to size restrictions, lack of services, and/or lack of availability for 3-4 full days blocks per month on a regular basis.

I have been able to secure the s.16 at the Ramada s.16 at a negotiated lower rate of \$175, down from \$250.

Good morning,

We wanted to provide you an update on the progress of the BC Family Information Liaison Unit (FILU), which is now operational. The BC FILU is a provincial frontline victim service unit for families of missing or murdered Indigenous women and girls—designed to assist them in accessing information they are seeking related to the loss of their loved one.

Our FILU Family Support Workers are ready and available to assist families of missing and murdered Indigenous women and girls across the province. With the Commission team in Smithers last week to prepare for the Community Hearing in late September 2017, our frontline FILU staff members were on the ground there to coordinate any referrals by Commission staff and best support family members.

Since our last communication, the FILU project team has completed several key activities which include:

- Completing the Phase 1 consultation process with families of missing or murdered Indigenous women and girls and Indigenous leaders to inform the design of the BC FILU;
- Hiring and training of staff, including joint training with system partners on culturally-responsive and trauma-informed practice;
- Establishing a FILU office in Prince George (located within the Prince George Native Friendship Centre);
- Prioritizing the development of information sharing processes with the RCMP and the BC Coroners Service, based on Phase 1 consultations;
- Working with the National Inquiry Commission to establish family-centred and trauma-informed processes for streamlining referrals to FILU services.

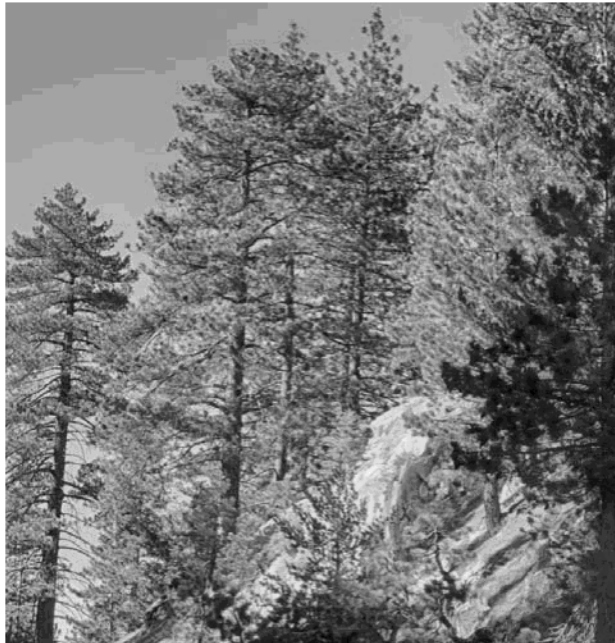

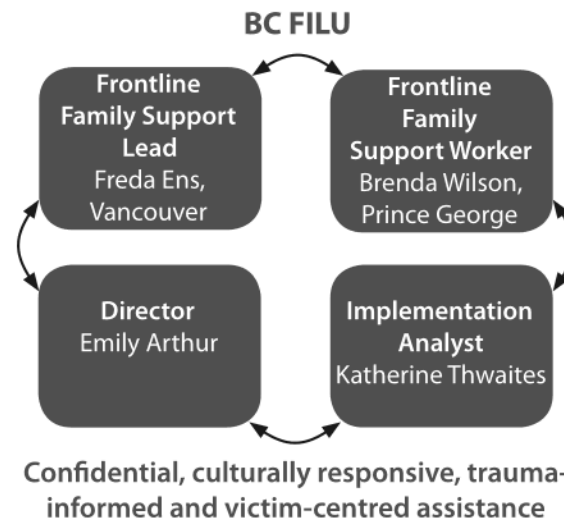

Who we are

The BC FILU is a provincial frontline victim service unit for families of missing or murdered Indigenous women and girls—designed to assist them in accessing information they are seeking related to the loss of their loved one.

Located within the B.C. Ministry of Public Safety and Solicitor General, our team is primarily located in Vancouver, with an additional office in Prince George to better support access to BC FILU services by families and communities in Northern B.C.



What we do

Our mandate is to support families of missing or murdered Indigenous women and girls by:

- Working with system and agency partners (e.g., police, coroners service, child and family services, health and social services, other FILUs) to gather case-specific and/or general information that family members are seeking
- Ensuring that the information is provided to family members in a trauma-informed and culturally-sensitive way
- Facilitating connections with available services and supports to promote wellness and healing (e.g., cultural supports, mainstream grief counselling)



Who is eligible



- FILU services and supports are available to family members of missing or murdered Indigenous women, whether or not they are participating in the National Inquiry
- Family members may include blood relations and non-blood relations, such as adopted families, cultural kin, foster care relatives and chosen family*

**Release of information is subject to privacy laws, regulations and agency policies. In some cases, information either cannot be provided or can only be shared with legal next of kin. Where this occurs, a clear explanation will be provided to the family member.*

Accessing FILU Services

BC FILU family support workers are now available to assist families of missing or murdered Indigenous women and girls across the province with their informational needs.

Family members may access the BC FILU directly, or through referrals by community agencies, National Inquiry Commission staff, and other provincial/ territorial FILUs.
