Background and support for this request:

- *Difficult to redistribute s.22 work without dropping other files.*
- *Position fully approved and financed less than a year ago*
- *Eligibility list ending imminently*
- *STO27 position integral to fulfilling South Coast Work Plan commitments and current active negotiations – specifically s.22 was playing a fundamental role in the implementation of the Sechelt Reconciliation Agreement and strong support role in the negotiation of the Sechelt Foundation Agreement.*
- *STO27 also supported the broader team and Regional Manager on numerous other files and corporate initiatives (eg. Musquem, South Coast Team Building, Workable Intern etc...*
- *s.22 was a tagged to be our lead providing negotiation support to FLNR on Cowichan Nation Alliance (urgency to negotiate CNA agreement this FY or lose 2017-18 funds)*
- *Other staff working at full capacity and negotiations are ramping up now that we're out of inter-regnum and ABA is set to pick up.*

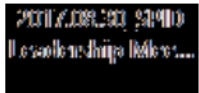

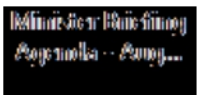

Colleagues,

On August 4, the Province extended the state of emergency a further two weeks. There are currently 148 wildfires burning and many First Nations communities remain under evacuation orders and alerts.

Further to my email below regarding engagement and consultation with impacted First Nation communities, I wanted to highlight the work that is underway to support consultation staff and statutory decision makers:

- FLNR is leading the development of a policy to provide guidance to consultation staff and statutory decision makers on how to consult with First Nations impacted by an emergency or disaster. The FLNR lead for this policy work is Charles Hunter. It is anticipated that this policy will have broad application across the natural resource sector. Recognizing that it will take some time to coordinate the review of this policy across the natural resource sector, staff can be guided by the draft document in the interim.
- MIRR's Critical Incidents and Emergency Management Branch is providing daily lists (Monday through Friday) of which First Nations are impacted and to what extent. Staff who would like to be added to this daily distribution list should contact Janice Franklin.

Subject: FN engagement and consultation during Provincial Emergency
Importance: High

Colleagues,

As you are aware, yesterday the Province extended the state of emergency for an additional two weeks to ensure a coordinated response to the wildfires, additionally, though we may have had a brief reprieve with better weather conditions in some areas, the risk of fire remains high. More than 100 fires are still active and many First Nations communities remain under evacuation orders and alerts. We ask that line agencies be mindful of, and consider modifying, consultation timelines where possible to accommodate the emergency situation that the First Nations communities are experiencing. Impacts to First Nations communities extend beyond those who are directly impacted (i.e., those under evacuation orders, those without power, loss of infrastructure such as the loss of the band office and all the equipment and records at Ashcroft Indian Band's reserve), for example there are challenges with mail delivery to areas outside evacuation areas, so those communities that you may not think are impacted are feeling the impacts as well. Many of those communities outside the evacuation areas are focusing on supporting others (ie supplies and receiving evacuees) including staff normally focused on consultation and regular business.

I'd be happy to facilitate a discussion if you have questions or require clarification, and we can provide you with current information on evacuation orders and alerts.







Vice President Nemrava - Red Cross;

I did not have an opportunity to discuss this with Kukpi7 Charlene s.22
s.22 I asked the Secwepemc Health Caucus staff – Londea and Duanna to prepare a list of the elders. This list is attached. You will see from the email below our elders are not linked into the world of technology and have limited access. The Elders with the assistance of Tahnyea Robbins have been registered on the system since the beginning but no financial assistance has been provided. I am baffled as to why this would happen as the Elders and volunteers have followed the process like all other evacuees.

We are asking the Red Cross to not do online banking but to issue actual checks to the Elders, they have been without assistance for 14 days. These Elders also should be eligible for more financial assistance as they are going into their 3rd week away from home. I understand you have sent a team to Kamloops to deal with this issues. I ask that you coordinate with our Secwepemc Health Caucus staff Duanna & Londea and FNHA staff, as they have been on the ground providing support to the Elders from the very beginning.

I ask that you as Vice President of Red Cross issue a written apology to the Elders. I have listened to how our people have been treated at the ESS in Kamloops and it angered me as a Kukpi7 (Chief) that in todays world of reconciliation that our people are still treated like we are invisible and second class. Our people especially our

Elders have endured enough trauma and racism from the colonial powers in the form of residential schools and the reserve system.

We need to have our own process as the current provincial and federal response does not look after the interests of our people and our communities. The current agreement between Canada and BC does not look after our interests nor our people. The financial resources need to flow directly to us not through other jurisdictions. It is our land, is it our title and is it our jurisdiction. As Secwepemc Chiefs we will be doing a Nation wide de-briefing to initiate a Secwepemc Nation emergency preparedness plan for all 17 communities and our 11,000 citizens.

We know that the Red Cross does excellent work throughout Canada and around the world. I spoke in support of the Red Cross and the thousands of volunteers who were helping our citizens and others while in Revelstoke last Saturday.

through for them but they haven't done that. The elders did not want gift card visa's, as they cannot get cash out of those cards and they wanted their own freedom with their own money. Hello Rachelle,

As discussed over the phone, the intention behind our seeking the meeting is to discuss some common issues, share information, and determine if there are opportunities to work more collaboratively. For instance, there may be utility to sharing information and/or coordinating approaches as we engage with First Nations regarding transboundary land claims. Between BC and Yukon, the Taku River Tlingit First Nation and Acho Dene Koe First Nation come to mind. Another instance where there may be benefit to sharing information and perhaps coordinating is with respect to our jurisdictions' involvement in Canada's Collaborative Fiscal Policy Development Process.

In addition, if others are amenable, we hope to discuss at a high level our jurisdictions' experiences - challenges, successes, and insights - with respect to matters such as Strategic Engagement Agreements, ethnohistoric research, etc.

Our hope for the meeting is to share information and/or coordinate regarding topics such as these. Below I have suggested several topics for discussion, but we are certainly open to any further suggestions you may have. We can discuss an agenda around some of these in more detail during our teleconference. I recognise that it's a lot to cover, and we may want to continue some of these discussions in more detail after our meeting on Sept 19th, but perhaps we can also discuss how we might do so.

Canada's Collaborative Fiscal Policy Development Process;
Transboundary land claims (Acho Dene Koe First Nation, Taku River Tlingit First Nation, and the Dehcho First Nations);
Truth and Reconciliation Calls to Action;
Approaches to Strategic Engagement Agreements;
Approaches to Ethnohistoric Research (and Strength of Claim Assessments);
Responsibility for Funding Tripartite Arrangements (Canada, province or territory, and First Nations);
Self-Governing First Nations' Representation at the National Level.

One topic which would likely benefit from a more detailed discussion on Sept 19th is Canada's Collaborative Fiscal Policy Development Process. In the interest of using our time in the afternoon effectively, I propose that some of us meet on the morning of September 19th for that discussion. I understand that not everyone will be available for the morning, but also that not everyone will need to be there for that discussion.
