Good morning Jen,

I have a question about a statement Premier Horgan made last week regarding Site C and First Nations. He said that the government had been informed by some First Nations that they would launch legal challenges if Site C were cancelled, while other First Nations said they would launch legal challenges if the project continues.

I checked the Site C Project Tripartite Land Agreements that BC Hydro signed with the McLeod Lake Indian Band and other Treaty 8 First Nations. The agreements have a clause that says that if Site C is abandoned the agreements can be terminated with 60 days notice.

The West Moberly and Prophet River First Nations have been clear that if Site C proceeds they will launch a suit on the basis that the project violates treaty rights - a premise not yet tested in the courts.

What isn't clear is where any legal challenges arising from cancellation could come from, especially given the cancellation clause in First Nations Site C agreements. Can you please provide some more details about this?
