Hi May and Janice. We are hearing the federal INAC Minister is seeking a call with Ministers Fraser and Farnworth next week (requesting Tuesday). Topic: wildfires. I've asked the federal DM for more info but she believes it's about FN concerns with our emergency services.

Please work with EMBC and BCWS to pull together a note for the ministers in prep for the call. If I hear more I'll let you know. This can be a short BN that I suggest include key messages: acknowledge the challenges, improvements were made, we are prepared to work with INAC and FNs to review on lessons learned, and we support FNs request for federal funding for FN emergency preparedness. Let's get that note to to the MOs by mid day Monday.

Regardless of whether the call occurs, We will need to prepare for the topic at the FN Leadership Gathering. The FNLC has already told us it will be a priority topic. [s.13](#)
