This email is being dictated by Sue Hammell, who is following-up on a January 25 meeting in Vancouver between Hon. Fraser and Brian Titus, the Chief Operating Officer of the First Nations Financial Management Board. Participating on a conference call during the meeting was the Hon. Carole James and a number of other provincial government officials.

The minister, Hon. Fraser, was scheduled to go to Ottawa the next day - and he requested that we follow-up with him so he could share with us an update on progress the federal government is making on a proposed regulation to Section 141 of the *First Nations Fiscal Management Act*.

Brian (and Sue) will be in Victoria in the evening of March 6 and for most of the day on March 7. Would it be convenient for the Hon. Fraser to briefly meet with Brian and Sue to follow-up on the minister's trip to Ottawa? Or, if not, could we arrange for another date to meet again with Hon. Fraser?
