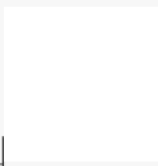

Roadside Assistance PLUS

If Renter purchases RSP, Owner agrees, subject to the actions that invalidate Loss Damage Waiver, to contractually waive Renter's responsibility for the cost to provide 24/7 roadside assistance (where available) which includes replacement of lost keys (including remote entry devices), flat tire service (if no inflated spare is available, the vehicle will be towed. Cost of a replacement tire is not covered by RSP), lockout service (if the keys are locked inside the vehicle), jumpstarts, and fuel delivery service for up to 3 gallons (or equivalent liters) of fuel if Vehicle is out of fuel. Roadside Plus services are only available in the United States and Canada. If Renter does not purchase RSP, or RSP is invalidated as set forth above, roadside assistance will be available, but standard charges will apply. RSP does not apply in Mexico. For roadside assistance call 1-800-268-9711.

Age Requirements

Minimum age to rent a vehicle is 21, except in NY and MI, where the minimum age to rent is 18.

Rental rates may be higher for renters and additional drivers under the age of 25.

Certain specialty and larger sized vehicles may not be available for rentals when the renter or additional driver is under 25.

Refueling Service

As a customer, you have a choice as to how you would like to pay for fuel.

Option 1: Prepay Fuel

This option allows the renter to pay for the full tank of gas at the time of rental and return the tank empty. No refunds will be issued for unused gas.

Option 2: We Refill

This option allows the renter to pay National at the end of the rental for gas used but not replace. Price per litre will be higher than local fuel prices.

Option 3: You Refill

This option allows the renter to return the vehicle with a full tank of gas to avoid extra fuel charges.

One Way Drop Policy

One-Way rentals are allowed within Canada and may be assessed a one-time drop charge or mileage charge in addition to the rental rate. This is also known as an 'inter-city' fee.

The return location is indicated on your rental agreement. The cost of the rental reflects the return of the vehicle to that location. Returning the vehicle to a location other than the one indicated on your rental agreement will incur a separate charge.

Cash Policy

Not all locations accept cash as a deposit at the beginning of the rental. Please review the following key points regarding cash rentals: %u2022 Renter must meet locations cash rental requirements %u2022 A deposit in the amount of the calculated rental charges plus an additional \$300 is required. %u2022 Renters may use cash as form of final payment upon return of the vehicle. %u2022 For rentals in Canada, only customers on a pre-paid tour or renting on corporate accounts that have negotiated the option to use cash are allowed to use cash as a deposit at the beginning of the rental. The following are required: verifiable proof of employment, verifiable home/cell phone and/or utilities in renter's name, verifiable return transportation ticket. A deposit of \$50 per rental day may apply.

Travel Contingency Policy

National is continually monitoring the United States national alert status. We are committed to getting all of our customers to their destinations in a safe and efficient manner. Currently, our normal One-Way rental policy and pricing remain the same. We will adapt our business policies if the United States national situation impacts the travel industry.

Air Travel Suspension %u2013 If the U.S. Department of Transportation suspends air travel, we will activate our special One-Way rental policy. National will waive all cancellation and no-show fees. For vehicles that are already on rent, we will waive any unauthorized drop fees/surcharges regardless of the National location the vehicle is returned. For new rentals, National will have no limit to the number of vehicles available for One-Way travel.

Alert Status Change %u2013 Should the U.S. Department of Homeland Security change our alert status, we will immediately make all modifications to our policies available to you on our website, or on our reservation line at 1-800-462-5266 (for reservations outside North America 1-954-522-9696).

Credit Card Guarantee

A credit card guarantee is required at certain times of the year in order to reserve a car.

Certain car types require a credit card guarantee year-round.

If your reservation required a credit card in order to book and you need to cancel, please be sure to give at least 24 hours advance notice to avoid any cancellation fees and/or penalties.

Driver's License Information

Customers who reside in the United States, U.S. Territories, or Canada

Customers who reside in the U.S., U.S. Territories, or Canada must present a valid, unexpired government-issued Driver's license which includes a photograph of the customer. Digital licenses are not accepted. The driver's license must be valid for the entire rental period.

Members of the United States Armed Forces who are on active duty may present an expired home state license under the following conditions:

- They also present an Active Military ID, and

- They are in compliance with their military extension policy of the state which issued the license. These policies vary by state and customers are encouraged to check with the appropriate department of motor vehicles for more information.

Customers travelling to the U.S. and Canada from other countries

It is important that customers check with the appropriate Department of Motor Vehicles in the States or Provinces in which they intend to travel to ensure compliance with their various licensing laws. The following practices are used to ensure the customer is presenting a facially valid license at the time of rental.

Customers traveling to the United States and Canada from another country must present the following:

- Their home country driver's license, and
- If the home country license is in a language other than English (or French, for rentals in Canada) and the letters are English (i.e. German, Spanish, etc.) an International Driver's Permit is recommended, but not required, for translation purposes in addition to the home country license.
- If the home country license is in a language other than English and the letters are not English (i.e. alphabet is not an extended Latin-based alphabet like German or Spanish but is Russian, Japanese, Arabic, etc.) an International Driver's Permit is required.
- If an International Driver's permit cannot be obtained in the home country, another professional, type-written translation may be substituted. In either case the home country license must also be presented.
- Customers may not rent a vehicle solely with the International Driver's Permit. The International Driver's Permit is a translation of the individual's home country license and is not considered a license nor is it considered valid identification.
- In some locations, including but not limited to offices in Arizona, California, Georgia, New Mexico, Nevada, and Texas, customers may be asked to provide additional valid government-issued documentation.

Other requirements

- Photocopies of Driver's Licenses are not accepted
- "Learner's Permits" are not accepted.
- Any license which, on its face, restricts the licensee to the use and operation of a vehicle equipped with a form of a breathalyzer apparatus is not accepted.
- Temporary Driver's Licenses may be refused if the renting location is unable to otherwise verify the customer's identity or verify the authenticity of the temporary license. Additional Government-issued identification may be required.

Personal Accident Insurance / Personal Effects Coverage

Personal Accident Insurance - Personal Effects Coverage - PAI-PEC - is offered at the time of rental for an additional daily charge. If accepted the PAI contained in the policy provides renter and renters passengers with accidental death, accident medical expenses and ambulance expense benefits. The PEC contained in the policy insures the personal effects of the renter, additional drivers, or any member of the renters immediate family who permanently resides in the renters household and who is traveling with the renter against risks of loss or damage. Benefits are payable in addition to any other insurance coverage the renter or passengers may have. This is a summary only. PAI-PEC is subject to the provisions, limitations and exclusions of the PAI-PEC policy underwritten by Chubb Insurance Company of Canada. The purchase of PAI-PEC is optional and not required to rent a car. The coverage provided by PAI-PEC may duplicate the renters existing coverage. National is not qualified to evaluate the adequacy of the renters existing coverage, therefore the renter should examine his or her personal insurance policies or other sources of coverage that may duplicate the coverage provided by PAI-PEC. The PAI-PEC for this branch is 6.99 CAD per day.

Forms of Payment

A credit card, with available credit and in the renter's name, must be presented. The signature on the back must match the name imprinted on the card. In addition, if the renter has an online transaction, the number and name printed on the card presented by renter must match the name and number stored for the online transaction. Credit Cards honored: American Express®, MasterCard®, VISA®, Discover®, JCB. Puerto Rico: The following credit cards are accepted for rentals in Puerto Rico: American Express, MasterCard, VISA, Diners Club, Discover.

- Canada: The following credit cards are accepted for rentals in Canada: American Express®, MasterCard®, VISA®

Cross Border Policy

Vehicles rented in Canada can be driven throughout Canada and the US.

Vehicles cannot be driven into Mexico.

Loss Damage Waiver

Loss Damage Waiver (LDW) is not insurance. The purchase of LDW is optional and not required in order to rent a vehicle.

You may purchase optional LDW for an additional fee. If you purchase LDW we agree, subject to the actions that invalidate LDW listed on the rental agreement, to contractually waive your responsibility for all or part of the cost of damage to, loss or theft of, the vehicle. LDW does not apply to damage occurring in Mexico.

When deciding whether or not to purchase LDW, you may wish to check with your insurance representative or credit card company to determine whether, in the event of damage to, or theft of, vehicle, you have coverage or protection for such damage or theft and the amount of your deductible or out-of-pocket risk.

Additional Driver

Additional drivers must meet same rental qualifications as the renter. Additional drivers must appear at the rental counter with the primary renter. An additional daily fee may apply for any additional drivers.

Toll Pass Policy

Our TollPass Program is our electronic toll collection program which allows our renters to drive through electronic toll lanes and pay tolls electronically, without having to stop and pay cash. In addition, many toll plazas have converted to all electronic tolling and removed the option for travelers to stop and pay cash at toll plazas.

> • Jonathan you were going to speak to Minister about this as you had concerns around s.13 within the list.

> 2) Minister's calendar for August

> • This is fairly straight forward as it's another one of these proactive disclosures where we automatically submit Minister's calendar to Fin Open Gov't to be posted online. How the process works is Connie sends us Minister's calendar, then Kim (Neilane's SEA) reviews it and recommends harms. Shawna French then agrees/disagrees and we send it for redlining. Once redlined we get it back and it goes through our approval process (GCPE, Neilane and MO). We look for items that are Cabinet confidence mainly or potentially harmful to negotiations / FN relationships. One thing to keep in mind is that when reviewing you will have context of the meeting, however the readers most likely will not, and if something is of interest to them, they will submit an FOI requesting information from that particular meeting.

> 3) 72448 – Consultation

> • This is a consultation and that means that other areas had records they want us to review because they either are records that are ours, or are records that contain information that pertains to our work

> • We have substantially less time to review these records than a normal request so these should be treated as the more urgent FOIs.

> • This particular one is records the PO had and Neilane, GCPE have already reviewed and provided their input. We have recommended severing which has been highlighted within the PDF doc.
