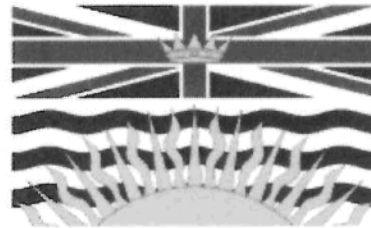

Two of the first records that will be inscribed on the Register are of paramount importance to British Columbia, consisting of the Vancouver Island Treaties (also known as the Douglas Treaties) and the Ida Halpern Recordings of Indigenous Languages and Songs. 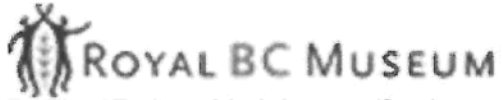
