MLA Fraser's statement re: Somass Rally is below.

"I want to thank everyone for coming out today. I first want to acknowledge the unceded traditional territory that we meet on today. This is Nuu-Chah-Nulth territory. I am unfortunately unable to attend the rally today as I am in Victoria in the Legislature.

As a government we have committed to working with communities and industry to develop a fair, lasting strategy to create more jobs by processing more logs in B.C. and to renew our forests by expanding investments in reforestation. I am excited to work with my colleague, Minister of Forests, Lands, Natural Resource Operations, and Rural Development, Minister Donaldson to make this happen right here in the Alberni Valley and British Columbia

The closure of the Somass Mill was a significant blow to our community. I had a previously scheduled meeting with affected Somass Mill workers the day the closure came out. I spoke with them about how this closure would affect them and their families. I am committed to working with Minister Donaldson to ensure that a fair and lasting strategy is developed to create more BC jobs right here in the Alberni Valley. "

**Key Messages for consideration:**

- There is a willingness to move forward to work on this and a real opportunity here
- There are some logistical issues that need resolving such as money/funding for the working group. First Nation's inclusion is important.
- There is a need to make sure all parties are on the same page and to define partnership
- Is there a plan for practical discussion?
- A short term success will be getting together to talk collectively about strategic goals and immediate steps.
- Asking for revitalization act with reconciliation included
- Examples of changes would be tenure reform and regulatory reform

**Summary:**

The meeting overall recounted past mistakes and situations that First Nations and industry are faced such as past government deregulating everything leaving stewardship of the lands to the companies.

There was a hopeful tone in where it was recognized that the raw log exports was a fine example of policy shift. There is a belief changes on the ground will come and we'll all be better off for it.

A concern at the moment is the wildfires in BC and the management of that. There was reference of the pine beetles and the on-going consequences of that.

If moving forward on this partnership there needs to be incentives in the agreement and incentives to stay invested.

In recognizing title – the jurisdiction is with indigenous people

Discussion of tenure systems won't work with title cases and the capacity of First Nations to administer those resources/tenures

**Key messages from GCSP:**

- We need to demonstrate a level of patience and understanding. We are all in this together. We have to have authentic relationships. It has to be more than signatures at the end of pages.
- Can't sign vague and ambiguous agreements.
- All of us have to become a lot more political than in the past. We've lost our strong voice that holds the government accountable. Our complacency has led us to where we are now.

**Key messages from Industry:**

- Strongly in favour in changes in policy in fully using the resource
- Also of importance is that the benefit of the resource is maximized here in BC in all three areas of forestry. There is too much waste created causing risks environmental and economically.
- There are clear opportunities to work with FN
- Pulp is a good place to be right now.



- There is a rate of change that is surprisingly slow
- If we can get this group of people together to talk about a strategy of things that makes sense to all of us collectively – we should be working on getting to a detailed action plan

## **178 new licensed child-care spaces are on their way to Mid Island – Pacific Rim**

**VICTORIA** – Local families in Mid Island – Pacific Rim will soon be able to access new licensed child-care spaces thanks to an more than \$1.1 million investment through the Province's Child Care Major Capital Funding Program, announced New Democrat MLA for Mid Island – Pacific Rim, Scott Fraser.

Purchase and assemble a modular building and develop a site.

Renovate an existing building.

The Province is now in the process of working with child-care providers to sign project agreements that include the specific requirements that providers have identified for each site, such as the need to lease or buy property, obtain local zoning permits and hire contractors to renovate the sites.
