I was wondering if your office would be willing to supply a statement from you regarding the letter and the issue that I could supplement my story with. - The majority of the Comox Watershed Group is private managed forest land, except for the western headwaters, which are in Strathcona Provincial Park.
- Forest companies operating on private land need to follow the requirements of the *Private Managed Forest Land Act*, the *Drinking Water Protection Act*, the *Heritage Conservation Act*, the federal *Species at Risk Act* and the federal *Fisheries Act*.
- Under the Private Managed Forest Land Act
   (http://www.bclaws.ca/civix/document/id/lc/statreg/03080\_01)
   and
   regulations, companies are required to protect key values including fish habitat,

water quality and critical wildlife habitat. Section 13 (1) of the *Private Managed Forest Land Act* reads as follows:

- The forest management objective for private managed forest land with respect to water quality is to protect human drinking water, both during and after harvesting.

Dear Mr Fraser,

It has come to our attention that Island Timberlands has given notice to the Union Bay Improvement District of their intention to conduct logging in the Langley Lake watershed during the 2018 harvesting season. Langley Lake is the only water supply for the community of Union Bay.

To be blunt it is no longer acceptable to conduct industrial resource extraction in community drinking water systems.

Every community requires clean, safe drinking water in predictable quantity. Most people in North America obtain clean and safe drinking water from supply areas that they own, govern and protect. They manage

them so that their citizens are safe and so that their quality of life is consistent with accepted norms in modern society. Like many on the East Coast of Vancouver Island this option is not available to the

Union Bay Improvement District who neither own nor have the capacity to protect their watershed.

This is unfair to Union Bay residents who face real health impacts that neither they nor their elected representatives can address – not to mention future financial liability to fund treatment costs needed

to remedy damage industrial resource extraction causes to drinking water supply systems. An undisputed example of this can be found in the water supply area for our neighbours to the North in Courtenay-Comox

who are facing a bill of \$165 million dollars to solve the turbidity problem caused by logging.

Langley Lake is a small and vulnerable system with nowhere near the resiliency of a larger watershed. It already faces supply challenges created by the removal of most of the surrounding vegetation. It

cannot afford to have its remaining natural boundaries further reduced.

Vancouver Island Water Watch coalition is asking the Environment and Land Use Committee of the legislature to impose an immediate temporary injunction preventing any further industrial resource extraction

activity within the Langley Lake watershed until legislative means to grant community control over water supply areas can be proposed and voted upon within the legislature.

Democratic control over something as fundamental as safe, clean, predictable

drinking water is long overdue for citizens like those who live in places like Union Bay. We would appreciate a response to our concerns.

Reconciliation is everyone's responsibility – provincial, local and federal governments, industry, the health and legal sectors, post-secondary institutions, and the public – everyone.

I encourage the City of Port Alberni to continue working with local First Nations and I look forward to seeing the results.

Local governments in my riding have been leading the way to shape what reconciliation can look like for quite some time.

For example, following the signing of their treaty, four of the Maa-nulth First Nations joined the Alberni-Clayoquot Regional District in 2012, and Ka:'yu:'k't'h'/Che:k'tl7et'h' became part of the Strathcona Regional District board the following year. A member of Huu-ay-aht First Nations, John Jack, is the the Alberni-Clayoquot Regional District board chair.

My office continues to actively support community-based reconciliation, working as community connectors to support idea sharing and create connections where and when we are welcome to participate. It's an important part of our work.

There is a growing interest in reconciliation in communities of all size. At the Union of British Columbia Municipalities convention this past September, we saw a record breaking number of meetings focused on this topic.

My Ministry is working to advance reconciliation in all communities in B.C. by listening and responding to what Indigenous leaders have been requesting for a long time.

This work will support reconciliation in all communities in B.C., including Port Alberni.

We are also continuing the Community to Community Forum (C2C) Program which enables local governments and First Nations to connect and build relationships.

As well, we provide support and advice to local governments and First Nations seeking to build relationships between their communities.

Information on background re: the Community-to-Community program:

The program provides up the \$5,000 in matching funding for events that include direct dialogue between elected officials of local governments and neighbouring First Nations. Since 1999, local governments, First Nations and Indigenous organizations have participated in more than 580 events throughout the province funded by C2C.

C2C events have enabled local governments and First Nations to better understand each other and work more collaboratively. The forums have directly led to results like communication protocols, memorandums of understanding regarding land use, and service agreements for water, sewer and fire protection.

The C2C program is funded by the provincial and federal governments and administered by the Union of BC Municipalities with support from the First Nations Summit. Earlier this year, the Ministry of Municipal Affairs and Housing provided \$50,000 to the Union of BC Municipalities for the 2017-18 program.

Langley Lake is the source of drinking water for the unincorporated community of Union Bay. I trust you've seen the letter by now, but if not, I've copy and pasted it below.

I was wondering if your office would be willing to supply a statement from you regarding the letter and the issue that I could supplement my story with. I don't necessarily have a hard deadline for this story, but I'd prefer to publish it in our Tuesday, Jan. 16 issue (which goes to print on Monday morning).

- The majority of the Comox Watershed Group is private managed forest land, except for the western headwaters, which are in Strathcona Provincial Park.
- Forest companies operating on private land need to follow the requirements of the Private Managed Forest Land Act, the Drinking Water Protection Act, the Heritage Conservation Act, the federal Species at Risk Act and the federal Fisheries Act.
- Under the Private Managed Forest Land Act
   (http://www.bclaws.ca/civix/document/id/lc/statreg/03080\_01) and regulations, companies are required to protect key values including fish habitat, water quality and critical wildlife habitat. Section 13 (1) of the Private Managed Forest Land Act reads as follows:
  - The forest management objective for private managed forest land with respect to water quality is to protect human drinking water, both during and after harvesting.
- The Private Managed Forest Land Council plays an oversight role and investigates complaints about logging on private land. The council's website is a good source of information: <a href="http://mfcouncil.ca/">http://mfcouncil.ca/</a>

Regards, Scott Strasser Letter from the VIWWC: Honourable Scott Fraser January 9th, 2018 MLA Mid Island-Pacific Dear Mr Fraser, It has come to our attention that Island Timberlands has given notice to the Union Bay Improvement District of their intention to conduct logging in the Langley Lake watershed during the 2018 harvesting season. Langley Lake is the only water supply for the community of Union Bay. To be blunt it is no longer acceptable to conduct industrial resource extraction in community drinking water systems. Every community requires clean, safe drinking water in predictable quantity. Most people in North America obtain clean and safe drinking water from supply areas that

they own, govern and protect. They manage

them so that their citizens are safe and so that their quality of life is consistent with accepted norms in modern society. Like many on the East Coast of Vancouver Island this option is not available to the

Union Bay Improvement District who neither own nor have the capacity to protect their watershed.

This is unfair to Union Bay residents who face real health impacts that neither they nor their elected representatives can address – not to mention future financial liability to fund treatment costs needed

to remedy damage industrial resource extraction causes to drinking water supply systems. An undisputed example of this can be found in the water supply area for our neighbours to the North in Courtenay-Comox

who are facing a bill of \$165 million dollars to solve the turbidity problem caused by logging.

Langley Lake is a small and vulnerable system with nowhere near the resiliency of a larger watershed. It already faces supply challenges created by the removal of most of the surrounding vegetation. It

cannot afford to have its remaining natural boundaries further reduced.

Vancouver Island Water Watch coalition is asking the Environment and Land Use Committee of the legislature to impose an immediate temporary injunction preventing any further industrial resource extraction activity within the Langley Lake watershed until legislative means to grant community control over water supply areas can be proposed and voted upon within the legislature.

Democratic control over something as fundamental as safe, clean, predictable drinking water is long overdue for citizens like those who live in places like Union Bay.

We would appreciate a response to our concerns.

# Meeting with MSF and MP Fin Donnelly/Kevin Scott re. Fraser Watershed Initiative January 12, 2019, 9:30 – 10:00am

Meeting attendees: MSF, MP Fin Donnelly, Kevin Scott, Jolleen Dick, Emily Chamberlain (staff)

- Fraser Stewardship Initiative covers entire Fraser River Basin (from headwaters in NE through to lower Fraser). This initiative has a number of themes including land use protection, land use planning (looking at Yellowstone to Yukon models of protecting corridors outside Fraser), restoration, and guardians program. The main purpose of call with MSF was to discuss engagement with First Nations with respect to 1) restoration, and 2) indigenous guardians program.
- MP Fin Donnelly previously met with FLNRD/ MDD in late 2017.
- Restoration: planning to hold a restoration conference in the Summer.
  - o Themes of conference would include: 1) fire, 2) First Nations & restoration, 3) wildlife, salmon & restoration, 4) jobs & restoration, 5) climate change and restoration.
  - Conference would explore how to get First Nations involved with restoration. Many
    First Nations returned to their communities this summer to support the wildfire
    response, but had no opportunity to stay and work within their traditional
    territories. Theme of restoration as reconciliation (healing the land, healing the
    people).
  - Have talked to the Federal Minister of Natural Resources, Canadian Forests Services is committed to attend.
  - o MDD has committed to speak at conference.
  - o Are working with First Nation leaders to speak at conference.
  - Would like to have MSF speak at this conference. MSF indicated he would like to take part in this upcoming restoration conference.
- Indigenous Guardians Program
  - Exploring idea of a watchmen program in Fraser (specially mentioned Cariboo/ Chilcotin/ Merritt)
- Have been meeting with federal government trying to secure federal funding for land use protection initiatives.
- MSF spoke to current initiatives underway with First Nations in lower Fraser (e.g. Musqueam Collaborative Management Agreement, Stó:lo Collaborative Management Proposal).
- MP Fin Donnelly / Kevin Scott would like to meet with MSF in person in February. Jolleen provided her contact info to meeting participants to follow up re. meeting scheduling.
- Emily mentioned that MIRR staff could assist in supporting relations/ linking with First Nations if needed.

Highway 4 Kennedy Lake Project Open House was from 4-7pm last night, in Ucluelet at the Community Center.

We had 86 attendees (more than double from the Tofino event), including:

 3 councillor from Ucluelet, Chief of the Fire Department, emergency management coordinator, business owners and fish truck drivers/operators and media (the Westerly News did an interview with me).

Primary Themes - similar to Tofino:

- Questions and concerns around the duration of closure windows for traffic;
- Ability to reopen the highway in the event of health emergency and/or disaster;
- Was consideration given to an alternate alignment?
- Overall support for improvements.

We received many feedback forms from both events so the PM will be reviewing those to see if /what changes we will make to the tender documents, specifically the closure windows.
