Thank you for your June 25, 2018, letter following up from the May 18, 2018, meeting with you and other Ahousaht First Nation (Ahousaht) hereditary leaders, elected Chief Councillor and staff for the annual Ahousaht Protocol Executive Committee meeting. I appreciated the opportunity to acknowledge the collaboration between Ahousaht and the Province to advance our joint reconciliation efforts through the Ahousaht Protocol, and to recognize the important government to government work that has been completed over the last year.

In your June 25, 2018, letter you asked for my support to:

1. amend the Ahousaht Protocol and Working Group Terms of Reference (ToR) to include joint work to assess the implications and options for implementing Iisaakstał;
2. hold a Working Group meeting in July or August to begin this work; and
3. confirm the amount of additional funding for this work and timing of payments.

**Amend the Ahousaht Protocol and Working Group ToR**

The Province is committed to working with Ahousaht to explore reconciliation opportunities between Iisaakstał and current public land management. I agree that a financial and operational assessment is needed to compare Iisaakstał with existing public land management, including the 1993 Land Use Decision, implementation of the

Scientific Panel Watershed Plans approved by Ahousaht and the Province, existing resource tenures, and protected area management plans. Given the overarching economic development goals of the Ahousaht Protocol, it will also be important to assess the socio-economic implications, such as employment opportunities, between Iisaaksta and existing public land management.

As I explained in our meeting, incorporating this task into the Working Group ToR will allow it to proceed in consideration of the current Protocol objectives and priorities. This is important work and the Working Group should take the time that is necessary to produce a thorough analysis for consideration by the Parties. Thank you for your suggested amendment language, and I suggest that the Working Group collectively determine the timeline to complete this assessment when they meet to confirm the Workplan.

**Hold a Working Group meeting in August**

BC Working Group members are eager to engage with Ahousaht to finalize the ToR, confirm Workplan objectives and timelines for fiscal year 2018-2019, and complete priority tasks. I understand that Ministry of Indigenous Relations and Reconciliation staff have already contacted Ahousaht representatives on the Working Group to participate in a Working Group meeting in August.

**Confirm the amount of additional funding for Ahousaht and timing of payments**

I am pleased to confirm that an additional \$200,000 is available to assist the Working Group to complete Protocol implementation priorities, as outlined in the Workplan. This additional funding will result in a total of \$450,000 being made available by the Province this fiscal year to implement Protocol objectives, following the Parties' agreement of a Workplan for 2018-2019.

I look forward to continued success in our collaborative implementation of the Ahousaht Protocol and the results of the important work completed by our joint Working Group.

As you may know, the Ministry of Indigenous Relations and Reconciliation (MIRR) is responsible for the Indigenous-led crown corporation, the First Peoples' Cultural Council (FPCC). FPCC has a mandate to revitalize Indigenous languages, cultures, arts and heritage in British Columbia (BC). In the 2018 Budget, the Province invested \$50 million in FPCC to support Indigenous communities seeking to revitalize their languages.

Minister Robinson,

I would most genuinely appreciate an introduction to the Hon. Scott Fraser, Minister of Indigenous Relations and Reconciliation with the intention of bringing to his attention the important work being done by The First Nations Education Foundation (FNEF), who have architected a technology based language revitalization program for at-risk indigenous languages and dialects using contemporary educational practices and interactive technology which will incorporate Google machine learning and virtual reality.

The FNEF has a commitment to pilot its technology based educational program with the Yuułu?if?ath Government (Ucluelet First Nation) in the fall of 2018.

The aforementioned pilot aims to test the technology and validate its methodology designed to preserve indigenous languages and dialects which are at-risk of extinction by empowering indigenous youth with interactive educational tools and content.

The pilot will engage the remaining fluent speakers of the Nuu-chah-nulth language to preserve their unique Barkley dialect and offer a basis on which the FNEF educational model can be tested and proved, then swiftly replicated within other Indigenous communities in British Columbia, as 34 indigenous languages exist within our province's borders representing over two-thirds of Indigenous languages spoken in Canada.

In recognition of **UNESCO's** decision for **2019** to be the **International Year of Indigenous Language Revitalization**, which has been supported by the **United Nations**, the FNEF has commissioned world renowned indigenous artist Tim Paul to work with other indigenous artists in BC to create the **Indigenous Language Revitalization Pole** which in high probability will be dedicated and housed at the **University of Victoria**.

The entire creation of Indigenous Language Revitalization Totem Pole, which will emphasis the importance of language in indigenous culture an history will be documented to be incorporated into the interactive content for beneficiaries of the educational program and furthermore will be utilized to produce a short film documentary to be shared as an **effective Reconciliation educational tool for students throughout the province**.

British Columbian's deeply value how the Provincial government under the leadership of Premier Horgan, have committed significant resources in an effort to achieve Reconciliation and in my considered opinion, the FNEF represents a genuine opportunity for the Provincial government to partner with an innovative charity who have developed a sustainable educational program designed to ensure that true Reconciliation will happen in our lifetime.

I have included an overview of FNEF and The Indigenous Language Revitalization Totem Pole for your review and if you would be so kind please consider an introduction to the Hon. Scott Fraser, who may already have some familiarity with FNEF from conversations with Mr. Les Doiron, President of the Yuulu?i?ath Government (the Ucluelet First Nation).

I am writing this email today to request a meeting on 2 topics:

**1. Sewer project that was submitted to UBCM with CVRD, KFN and Village of Cumberland.**

- There was a project submitted to UBCM and we (K'omoks First Nation or KFN) are part of that proposal and so was Village of Cumberland. The funds being used are Gas Tax funds of \$15 million. The Village of Cumberland as you may know has a big sewer issue and so does Union Bay. KFN has lands that we refer to as "Southlands" (Union Bay area) and has a lot of parcels that will be coming through Treaty in that area. The project was viewed as positive but then Village of Cumberland decided to go a different route but still using their portion of the Gas Tax money. This is still a solution to their sewer issues. With these scope changes UBCM seem to be wary on going ahead with this project. I am going to Victoria tomorrow with a few CVRD and the CAO for Village of

Cumberland to meet with UBCM to discuss the scope changes. CVRD seems to feel that they are not in favor. We are highly concerned because if we do not receive these funds that the health hazards in Union Bay still exist. Baynes Sound is KFN bread basket for shellfish. We need to rectify this situation and this UBCM project is a solution.

**2. Kus Kus Sum project with signed MOU between KFN and City of Courtenay. Project Watershed taking a significant role.**

- The old Fields Sawmill site is an eye soar and Project Watershed had an amazing restoration plan for that area. A similar project was done in Campbell River in which Tim Ennis was the lead and he is the lead on this too. This site a burial site that KFN used and we put the bodies in the trees there and that's what Kus Kus Sum means, tree burial. KFN and City of Courtenay have signed an MOU for this and Project Watershed has raised a lot of funds to date. Interfor want\$16 and to date a lot of funds have been found. What we are having trouble with is finding funding for purchasing this property. We are hitting a wall trying to find funds. We have met with Ronna Rae and Gord Johns and they fully support and are trying to help as well. The importance of restoration will help the salmon population and flooding in the City of Courtenay.

I am requesting to meet on both of these matters. There is an urgency because we are meeting with UBCM tomorrow and I am unsure on how that meeting will go and the feeling is they are resistant in the scope change of the project.

Re: Regional District of Nanaimo (RDN) proposed Sewage Treatment Plant (Bowser / Qualicum Bay BC)

Honourable Scott Fraser

Good day Mr. Fraser. My name is <sup>s.22</sup> and wish to take this opportunity to bring to your attention the concerns of myself, my wife, our family, local friends and neighbors with the current planning and construction of a (primary process) sewage treatment facility within the boundaries of the Vancouver Island village of Bowser, BC - inclusive of a 2 Klm pipeline running south along the shoreline and an eventual 2.2 Klm outfall into the Salish Sea.

It is understood that the tender would process sewage to minimum government standards, but potentially is positioned to endanger two sensitive salmon bearing creeks; impact on active Scallop Shell Fish leases; traditional aboriginal and commercial fisheries; the robust natural native aquatic environment and adversely impact on the dynamic tourism industry of the regions adjacent coastal communities.

The area proposed for the outfall is home to a vast and diversified variety of sea life, ranging from microscopic zooplankton to the gargantuan of the deep.

I am a strong supporter of environmentally conscience development and I believe that our community has a plethora to offer to all, but recognize that we also must be diligent and cannot again repeat the civic mistakes of our Capital City - Victoria.

Logically, any development within the area mandates undertakings such as centralized sewage treatment, but with integral criteria encompassing the long term goals of sustainability and environmental impact as critical driving factors. Any short term fix - with identified negative consequences - must not be considered. Moreover, should this endeavor not be properly financed by those poised to profit from same.

My family treats our own effluent via a Septic System, with any failure of this system isolated and therefore ours alone to resolve - inclusive of incurred costs.

The Regional District and others regulate and vet the design of new installations and changes to existing septic systems / through review and permitting processes - all implemented with public safety in mind.

Many times these designs mandate addition of "Above Grade" fill to safeguard proper filtration is achieved. So, how can the same bodies rationalize and permit a facility where effluent receives cursory screening with the balance (of the waste) expelled into a pristine Eco culture.

Rational demands that our community infra-structure be designed such that it can support controlled and appropriate growth, while preserving the unique attributes of the coastal lifestyles.

However, at least to this viewer, it would seem perhaps the desire to increase the regional tax base by development may be a governing factor with some of these decisions. Should we not have a more transparent process, involving substantial community consultation and impute. Possibly even a plebiscite restricted to the local residents directly affected. Is this not the way of democracy and our Canadian values.

I believe that Bowser Village Centre Wastewater Project (as proposed) is not a stainable model - nor truly a cost effective dynamic as a long term solution.

Furthermore, the RDN espousing the old axiom that - *"The Solution to Pollution is Dilution"* - is not only archaic but morally wrong.

Shall we mortgage our children's futures on a "stop-gap" solution which has proven time and time again to be a failure?

I am not one to take pen to paper to voice my concerns. However, this issue has motivated me sufficiently that I am doing my part, along with my neighbors, to contact our elected officials, as well as the various governmental and news agencies, to seek attention and intervention.

Finally, although it may not be proven associated, the shoreline directly south of Bowser (and the proposed primary sewage screening facility) is currently under a governmental directive preventing harvesting of the local herring roe. *Vibrio cholerae* bacterium has been identified along with a least four (4) confirmed local Cholera cases. As you are aware, cholera is usually found in raw or undercooked fish and seafood caught in waters polluted with sewage. More disturbing still - generally in 3<sup>rd</sup> World countries.

While, to my knowledge, there has been no public statement released relating this occurrence to sewage outfalls, it is a topic often discussed by locals. As residents, we are intimately familiar with the affected area - from the southern limits of French Creek (with it's effluent discharged into the Strait of Georgia at a depth of 61 m some 2,440 m offshore) to the village of Qualicum Bay - whose northern limits share the same Nile Creek proposed for the Bowser Sewage Facility effluent discharge routing and subsequent ocean outfall.

Is there a correlation... I do not know as it is not my area of expertise. However, I do feel that enough unknowns are present to revisit the subject with fresh eyes.

Thus, I beech you, please... lead by changing funding conditions and substituting permit conditions to keep Area H green by stopping ocean sewage dumping and allow time for sober reflection prior to repeating past mistakes.

On behalf of Witset First Nation requests a letter of support to accompany our funding request to undertake Phase 1 of the Planning and Design for an Witset Educational Training Campus (estimated at \$1.2 million) for our highschool and college programs and associated daycare and student housing. Please see the background information below from Kyah Wiget Education Society Executive Director Diane Mattson. In the past, Laura Nash and Nichola Manning have provided letters of support for our training initiatives. The education society here has been hugely successful. We ask that letters of support be addressed to Chief and Council and send via return email no later than August 3<sup>rd</sup>. My apologies for the tight timeframes but the deadline for applications is also tight. Missiyh, and many thanks for your anticipated support.

### Background Information:

Kyah Wiget Education Society (KWES) is an independent school that is accredited by the BC Ministry of Education and overseen by a non-profit society 8 member board of directors. KWES

provides training from Kindergarten age 4 to grade 7, daycare, I-Count high-school grades 8-12, college and university level certificates and diplomas courses. KWES has 58 employees and BC accredited professional instructors led by Diane Mattson who has a Masters of Education and 43 years of experience.

The Kyah Wiget Educational Society began operations in 1986 with only a few students and has steadily grown over the years. KWES graduated 168 students in our college programs last season and continues to maintain between an 85%-91% successful completion rates due mainly to the incorporation of culturally sensitive training and highly dedicated, experienced group of educators. Aboriginal youth travel from great distances to attend our programs. Our 10 member team of professionals at the college has a combined experience of 243 years. Considering that we operate in a community of approximately 750 people, graduating 168 students in one school year is impressive.

KWES adapts education training to meet market demands. Labour market projections by KPMG, estimate that the LNG sector alone will add another 50,000 jobs. We plan to have the Witsuwit'en youth trained and ready to take on many of these jobs. Additionally, the 2012 Skills Gap Analysis for Northwest BC highlight the 27 occupations in need and we have targeted our educational offerings to fill these gaps. In cooperation with Northwest Community College and the Nicola Valley Technology Institute, we have expanded our courses offerings to include:

Kyah Wiget Education Society works in cooperation with Witset First Nation who provides employment supports for our students and links them with businesses willing to provide work experience and hire aboriginals. Our new Discovery Program is geared to help find work experience and apprenticeships for aboriginal students. Together we have a history of training and educating young men and women and helping them find employment. (Please see the attached Schedule A that outlines our statistics and history)

KWES college programs are presently delivered on the upstairs attic and basement rooms of the Centennial Hall via long sets of stairs. Students and admin staff are crammed into tiny spaces that lack ventilation. KWES is currently making plans for temporary space to accommodate growth for next season including the use of the Health Station board room as a classroom and the use of the attic storage above the school gym for additional finance and administrative office space. Highly problematic for both teachers and students, is that the Centennial Hall also doubles as a morgue for the community when a member dies. As per Witsuwit'en custom students and staff must leave the building during the cultural wake period (of up to a week) to allow the family time to grieve. The disruption of learning creates difficulties for the students and educators who must meet curriculum requirements. The I-Count High school operates out of an old residential school and does not meet educational standards for washrooms and administrative space (it does not have any!). Training facilities that accommodates both the high school and college programs and support staff is desperately needed in Witset.

For those few students who do not successfully complete their course, the main barriers to completion is adequate daycare, housing, and income supports. Many students have children. Our daycare operates out of an old building that can accommodate only 10 babies and 14 toddlers. Presently, there are 10 additional babies on the wait list and 5 toddler aged children. However, this does not represent the total wait list for children of students as many do not bother to apply because they know the wait list is long. Secondly there is no available on-reserve student housing for youth and limited income support so youth elect to continue working in minimum wage paying jobs rather than pursue their educational aspirations as they cannot afford to go to school.

Kyah Wiget Education Society has successfully incorporated work experience into its' educational programming. Today, KWES owns and operates Kyah Professional Janitorial Services – a cleaning company that has taken on contracts for companies such as Canadian Tire and Red Apple in Smithers. We are presently working towards our own Kyah Security Guard Company to provide work experience for our ten professionally trained security guards in our community.

KWES wants to expand its course offerings to include social worker, and environmental courses in forestry, mining, fisheries so as to develop environmental monitors and technicians. However, we do not have any laboratories for science course training. Also, KWES desires to expand its trades training with a mechanical shop for welding, auto body repairs, and heavy duty mechanic training. We have the team, the accreditation, the motivation, the reputation and the talent to help this community develop a confident, competent, generation of professionals and trades people. We just need require the facilities in which, unencumbered, we can continue to provide the kinds of results that already attracts the youth, educators, and partners.

Witset First Nation has experienced radical changes in these last twelve years. Hope is present; people now dream and plan – education and training is the catalyst for these changes. With your funding assistance, we hope to build on our past success and become active partners in the development of LNG and all it has to offer our youth in terms of training and employment.

I strongly urge you to support Witset First Nation's grant application for Phase 1 of the design for an educational training campus.
