How did these negotiations come about? Who approached who first? Did the nations approach the province, or vice versa?

- The Province, BC Hydro and the Nations recognize the importance of seeking to resolve disputes through collaborative processes.
- A dialogue between the parties in the fall of 2018 created the possibility of a negotiated pathway to resolution.

Does this mean that the province is reconsidering Site C, or that there will be some sort of settlement with the nations?

- No, BC is not reconsidering Site C. This does not impact planned construction timelines.
- If successful, the parties would reach an agreement that would reset the relationship and settle the on-going litigation regarding Site C.

What format will the negotiations take?

 The parties will be seeking to achieve a resolution through structured, interest-based negotiations. The precise format and structure of the dialogue remains confidential.

Is there a limit to how much any settlement would be, based on the Site C budget?

 Given the early stage of the negotiations, the scope of any potential agreement remains to be seen and will be informed by an assessment of the issues involved.
