- 1. Why is the Blueberry First Nations the only First Nations included in the Ft St John LRMP review?
- 2. The government's roundtable doesn't seem to include the necessary public engagement and does not seem to be transparent. What is the real purpose of this roundtable? (Seems like government is speaking and not listening. All messages from government roundtable seem to be based on decisions that have already been made?)
- 3. What is the decision on the Charlie Lake lands and Red Creek subdivision with respect to the applications for Section 16 status by Blueberry?
- 4. Unfortunately, the MIRR roundtable is creating incredible divisiveness in all our communities (Indigenous and non-indigenous).
- 5. Regarding the MIRR roundtable:
  - People have been leaving in the middle of the meetings due to incredible frustrations
- I recommend that the Round Table be dissolved and a new committee created with a truly transparent mandate with meaningful consultation under new local leadership.
- 6. Finally, as I mentioned to you, I would encourage you meet with Jim Little and Andy Ackerman s.22 s.22 These two gentlemen have been very

engaged in land use in the province, specifically in the northeast. They have many strong relationships with indigenous and non-indigenous groups and could offer some incredible insight to this whole process.

At the end, we all completely understand the TLE and Site C (TLA) needs and want to see what is best for all groups. Andy and Jim have worked with Doig River First Nations and have provided incredible support to Doig's work on the TLE/TLA process. I just attended a world café hosted by Doig River on
