Background: Advancing UN Declaration

UN Declaration on the Rights of Indigenous Peoples (UN Declaration):

- Sets out the **minimum standards** for the survival and dignity of Indigenous peoples
- Indigenous rights are **human rights** in an Indigenous context
- Canada endorsed the Declaration without qualification
- BC endorsed the Declaration and committed to its implementation

The right of **self-determination** has a critical basis in UN Declaration and section 35 rights

- Indigenous peoples are title and rights holders, and are decision-makers with inherent jurisdiction
- This is the basis for meaningfully addressing 150 years of colonialism and achieving reconciliation



Context

Truth and Reconciliation Commission (TRC) – Call to Action 43:

- Call upon federal, provincial, territorial, and municipal governments to fully adopt and implement UNDRIP as the framework for reconciliation.

Commitment Document (2015) and Joint Agenda (2018):

- **Vision:** Jointly design and construct a principled and organized approach to implement the section 35 framework, UNDRIP, and the TRC Calls to Action in British Columbia - with tangible milestones to demonstrate progress.
- **Concrete Action 1/Goal 1:** Jointly develop provincial legislation to establish UNDRIP as the foundation and coherent path for Crown-Indigenous relations and reconciliation in BC, including aligning provincial law and policy with UNDRIP and Indigenous rights.

Declaration Act: The Process

- Chiefs' resolutions (FNS, BCAFN, and UBCIC) mandated FNLC engagement with the Province in 2018 to implement UNDRIP in provincial legislation, with regular reports to and engagement with First Nations at each of the subsequent assemblies
 - Action 1/Goal 1: Commitment Document Joint Agenda (Concrete Actions)
- Collaborative process to develop an UNDRIP Bill for BC:
 - A lot of technical work, supported by political dialogue
 - Formal dialogues with leaders from business, education, political groups and civil society to discuss concepts
- Prepared a consultation draft which was reviewed by 90 under non-disclosure agreement so that chiefs and leaders could view it and inform it.
- On October 24, the Government introduced legislation to bring the UN Declaration into provincial law – the *Declaration on the Rights of Indigenous Peoples Act*.
- The Act passed with unanimous support and came into force on November 28, 2019

Declaration Act: What will it do?



Confirm that UNDRIP has full application to the laws of BC.

Addresses Article 38: “States in consultation and cooperation with Indigenous peoples, shall take the appropriate measures, including legislative measures, to achieve the ends of this Declaration.”



Confirm that recognition and respect for Indigenous rights is foundation for shift in relationship and implementation must be aided by a public, coherent and transparent process where all play the role.

First Nations recognized as *governments* representing inherent title and rights holders and not simply band councils, corporations or charitable societies or organizations under federal/provincial laws



Support predictability and range of reconciliation (social, economic, etc.).

Get out of the adversarial circumstances that perpetuate conflict.



Set a new course for public and transparent action plan, as well as government accountability to implement UNDRIP.

Provincial legal foundation for BC to work with First Nations to align law with UNDRIP.

Support implementation of existing reconciliation agreements.

Core Aspects of *Declaration Act*

- Confirms self-determination, non-derogation of inherent aboriginal and treaty rights and title
- Respect for diversity of Indigenous peoples, rights and territories
- The legislation mandates the government to, in consultation and cooperation with Indigenous peoples:
 - Take all measures to bring provincial laws into alignment with the Declaration
 - Develop an action plan to meet the objectives of the Declaration
 - Submit an annual report on progress to the BC legislature
- The legislation also makes space for consent-based decision making with Indigenous governing bodies and Provincial authorities on matters that directly affect Indigenous peoples



Next Steps

Alignment of Laws

- Some initial priorities have been set out through the Commitment Document.
- The Province will be consulting and cooperating with Indigenous peoples about the priorities ahead.
- Initial conversations with the FNLC are underway.



Next Steps

Development of Action Plan

- Intent is to engage with FNLC as well as directly with nations, Indigenous organizations, and Métis people to gather input on priorities and approach.
- Currently seeking Input on approach to “cooperation and collaboration” in the development of the action plan.



Next Steps

Annual Report

- The first report regarding progress on s. 3 (alignment of laws) and s. 4 (action plan) of the Act is due on or before June 30, 2020.
- The report must be prepared in consultation and cooperation with Indigenous peoples.

Declaration Act: The Process

- Chiefs' resolutions (FNS, BCFN, and UBCIC) mandated FNLC engagement with the Province in 2018 to implement UNDRIP in provincial legislation, with regular reports to and engagement with First Nations at each of the subsequent assemblies
 - Action 1/Goal 1: Commitment Document Joint Agenda (Concrete Actions)
- Collaborative process to develop an UNDRIP Bill for BC:
 - A lot of technical work, supported by political dialogue
 - Formal dialogues with leaders from business, education, political groups and civil society to discuss concerns
 - Prepared a consultation draft which was reviewed by 90 under non-disclosure agreement so that chiefs and leaders could view it and inform it.
- On October 24, the Government introduced legislation to bring the UN Declaration into provincial law – the *Declaration on the Rights of Indigenous Peoples Act*.
- The Act passed with unanimous support and came into force on November 28, 2019

- In 2017, every minister in government was mandated to implement the UN Declaration on the Rights of Indigenous Peoples...
- And the Truth and Reconciliation Commission's Calls to Action...
- ... Which call on governments to implement the UN Declaration as the framework for reconciliation.
- In 2018, the Province and the First Nations Leadership Council identified legislation to implement the UN Declaration as a priority through the jointly developed and endorsed Vision and





Guiding Principles, and Concrete Actions of the Commitment Document.

- The Throne Speech and Budget in 2019 also committed to advance this legislation.
- The legislation was co-developed in partnership with the First Nations Leadership Council, who were mandated through resolution by First Nations leadership in BC, and engaged Indigenous legal experts.
 - ***Countless hours and many policy discussions internally;***
 - ***Set to work with FNLC;***
 - ***Keeping Nations informed along the way.***
 - ***Engaging with stakeholders.***
- On October 24, the Government introduced legislation to bring the UN Declaration into provincial law – the Declaration on the Rights of Indigenous Peoples Act.
- The Act passed with unanimous support and came into force on November 28, 2019.

- BC is the first jurisdiction in Canada to pass law to implement the UN Declaration.

- The legislation mandates the government to:
 - bring provincial laws into alignment with the *United Nations Declaration on the Rights of Indigenous Peoples* (UN Declaration), in consultation and cooperation with the Indigenous peoples in BC; and
 - develop an action plan to meet the objectives of the UN Declaration, in consultation and cooperation with Indigenous peoples and with transparency and accountability.

- The legislation requires annual reporting to the legislature to monitor progress, and to ensure accountability.
- In addition, it allows for flexibility for the Province and Indigenous governments to enter into agreements for decision-making between Indigenous governments and the Province on matters that directly affect Indigenous peoples.
- The legislation sets out actions on moving forward on reconciliation – from alignment of laws to the development of an action plan to achieve the objectives of the Declaration.
- It confirms that recognition and respect for Indigenous rights is foundational for a shift in relationship.
- It is a tool for bringing rules, transparency and accountability when the Province works with Indigenous governments, business and local governments on decisions affecting Indigenous rights.

- It recognizes a broader range of Indigenous governing bodies, not limited to band councils, corporations, charitable societies or other organizations that may be established under federal or provincial laws.
- It creates new avenues for the Province and Indigenous peoples to work together – instead of investing in conflict, court cases and concessions.
- ***Codifies a commitment to transparency – e.g. consequential amendments***
- It supports the implementation of existing reconciliation agreements.
- It recognizes that implementation must be aided by a public, coherent and transparent process where all play a role.

SLIDE 7

Core Aspects of *Declaration Act*

- Confirms self-determination, non-derogation of inherent aboriginal and treaty rights and title
- Respect for diversity of Indigenous peoples, rights and territories
- The legislation mandates the government to, in consultation and cooperation with Indigenous peoples:
 - Take all measures to bring provincial laws into alignment with the Declaration
 - Develop an action plan to meet the objectives of the Declaration
 - Submit an annual report on progress to the BC legislature
- The legislation also makes space for consent-based decision making with Indigenous bodies and Provincial authorities on matters that directly affect Indigenous peoples

- The Act provides a principled human rights foundation for reconciliation, and strong and respectful government-to-government relationships between the provincial government and all Indigenous peoples.
- It does not derogate from inherent aboriginal and treaty rights and title; it is within Canada's constitutional framework.
- The Act affirms the UN Declaration as a universal international human rights instrument with application in Canadian law.

- The Act creates a framework for reconciliation for the Province – mandating government to bring provincial laws into harmony with the UN Declaration.
- The legislation commits the Province to developing an action plan with Indigenous peoples.
- The action plan will set out how government intends to achieve the objectives of the Declaration – including setting out priorities and timelines.
- The Province and the First Nations Leadership Council have started discussions about how best to engage on development of the action plan.
- The Province will also be engaging with Métis people, treaty and non-treaty nations, and other Indigenous partners.
- The first report regarding progress on s. 3 (alignment of laws) and s. 4 (action plan) of the Act is due on or before June 30, 2020.

- The report must be prepared in consultation and cooperation with Indigenous peoples.
- The action plan and reporting will provide transparency and accountability for the work ahead.
- In addition to these core elements, the legislation acknowledges there is a broad range of Indigenous governments.
- And provides discretion for new decision-making agreements with Indigenous governments – where decisions directly affect Indigenous peoples.

Next Steps

- **Alignment of Laws**
 - Some initial priorities have been set out through the Commitment Document.
 - The Province will be consulting and cooperating with Indigenous peoples about the priorities ahead.
 - Initial conversations with the FNLC are underway.
- **Development of Action Plan**
 - Intent is to engage with FNLC as well as directly with nations, Indigenous organizations, and Métis people to gather input on priorities and approach.
 - Currently seeking input on approach to "cooperation and collaboration" in the development of the action plan.
- **Annual Report**
 - The first report regarding progress on s. 3 (alignment of laws) and s. 4 (action plan) of the Act is due on or before June 30, 2020.
 - The report must be prepared in consultation and cooperation with Indigenous peoples.
- Ongoing outreach to business, public, environmental, education and civil society groups

- While the Declaration Act sets an important framework to guide reconciliation in B.C., it is enabling legislation, and does not in itself make changes to regulatory frameworks, operational decision-making, or consultation requirements. ***(No magic switch)***
- So, now... the hard work really begins.
- Bringing provincial laws into alignment with the UN Declaration is a process that will happen over time.
- The Province will be consulting and cooperating with Indigenous peoples about the priorities ahead.
- We understand for implementation to be effective, consultation and cooperation must be inclusive, but not homogenizing, of all Indigenous peoples.
- Initial conversations between the Province and the First Nations Leadership Council are underway.
- Some initial priorities have already been set out through the Commitment Document.

- We are engaging with a broad range of stakeholders and partners to ensure businesses, industry and local governments have a good understanding of the legislation.
- An open and transparent approach helps move us forward successfully.

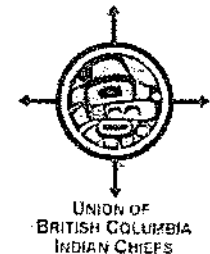

Background: Advancing UNDRIP

UNDRIP sets out the minimum standards for the survival and dignity of Indigenous peoples.

Indigenous rights are *human rights*

Self-determination is foundational for First Nations peoples

- Title and rights holders in British Columbia—First Nations—are the decision-makers and must be recognized as such to address 150 years of colonialism
- Supporting shift to relations with proper Title holders

Bill 262 was not passed despite advocacy and agreement, but the work must continue federally and in BC.

Call to Action and Mandates

TRC Calls to Action and especially Call#43

- “provincial government to fully adopt the declaration on the rights of indigenous peoples as the framework for reconciliation”.

Following presentations and dialogue at years of Chiefs Council meetings and AGAs, the UBCIC Chiefs Council has provided support through resolutions for:

- The adoption of TRC and UNDRIP and to ensure that standards of the UN Declaration support First Nations self-determination in British Columbia.
- The UBCIC to engage with the Province on the Commitment Document (2015) and a provincial legislative framework to implement UNDRIP

Other recent federal and provincial legislation affirms UNDRIP (C91, C92, C69 & C68, Provincial legislation).

Consultation Bill: Process

Following direction by the Chiefs through the resolutions at BCAFN, FNS and UBCIC, the FNLC began engagement with the Province in 2018 to carry out the mandate to implement UNDRIP in provincial legislation, and made regular reports to First Nations leadership at each of the subsequent assemblies.

Now, following a collaborative process to develop an UNDRIP bill for BC—draft ready for review by the Chiefs

Bedrock to UBCIC mandate that First Nations title and rights holders decide if any Bill meets with their respective approval and the understanding or acceptance by their governments. Political process has constraints as this is provincial legislation.

Unwinding 150 years of colonialism, with colonial approaches and denial of rights must start and be informed by the best process, respecting self-determination.

KEY IS THE ACTION PLAN ON IMPLEMENTATION in British Columbia, and shaping that by First Nations title and rights holders and their governments.

UNDRIP BC Legislation: What can it do?



Confirm that UNDRIP has full application to the laws of BC

First Nations recognized as governments representing inherent title and rights holders and not simply colonial band councils, provincial corporations or charitable societies or organizations as is now the case
