

Ш BACKGROUND:



Pacific Northern Gas Ltd (Proponent) is a natural gas utility and a component of AltaGas Corporation. The Proponent proposes to construct and operate an approximately 525km long, 610mm (24") diameter natural gas pipeline from Summit Lake to Kitimat to loop the Proponent's existing natural gas pipeline.

The proposed project is called the Pacific Northern Gas Looping Project (PNG) and is in pre-application with the BC Environmental Assessment Office as of July 2013. The proposed Project would include the replacement of four existing compressor stations and would have an initial capacity of 600 million standard cubic feet per day. If approved, the Project would supply natural gas to proposed Liquefied Natural Gas (LNG) export facilities as well as the Proponent's existing customers.

In late August 2013, MARR staff met with AltaGas officials who were requesting guidance on engaging with First Nations on the coast and a contact list of coastal First Nations.

IV DISCUSSION:

The proposed project crosses the traditional territory of approximately 16 First Nations (attachment 1). The proponent may provide an update on their proposed strategy for engaging with coastal and inland-based First Nations. The proponent may have further questions on engagement roles and responsibilities, in which case they should be referred to MARR staff and guideline documents.

MARR staff have met with AltaGas and provided them with guidance on engaging with First Nations. If requested, a contact list of coastal First Nations has been prepared for AltaGas and could be conveyed to Pacific Northern Gas representatives (attachment 2).


