

The BC First Nations Energy and Mining Council (FNEMC) is a subcommittee of the First Nations Leadership Council (FNLC). Other sub-committees include the First Nations Forest Council, the First Nations Fisheries Council, First Nations Technology Council and the New Relationship Trust.

The FNEMC's mandate is to:

- coordinate First Nations involvement in energy, climate change and mining;
- engage in relationship building with government and industry partners; and,
- develop and promote strategies to enhance investment opportunities and capacity building related to the energy, climate change and mining sectors.

### IV DISCUSSION:


The proposal contained six core requests for funding, focused on providing First Nations with the ability to capture benefits associated with the implementation of the Jobs Plan. The six requests, and comments thereon, follow:

1. <u>Development of Impact Benefit Agreement and Exploration Agreement modules</u> for workshops

Much of what the FNEMC is proposing to create and deliver to communities already exists. Proponents are already encouraged to explore Impact Benefit Agreements with First Nations. Other agencies and organizations provide similar services and tools. It should be noted in the proposal that these modules/toolkits will provide strategies for First Nations to gain and hold leverage in negotiations with resource companies and the Province.

### 2. Creation of a First Nations China Desk and 4 full time positions

Ministry of Jobs, Tourism and Skills Training (JTST) has already engaged the FNEMC's proposal in November of 2012. JTST committed to resourcing a one-year renewable contract for up to three years (attachment 2).



### 3. Support to communities that seek assistance to negotiate mining agreements

BC already provides capacity funding to First Nations through the Non Treaty Aboriginal Funding Envelope. Last year approximately \$500,000 was provided to First Nations across BC for negotiations related to mining projects.

### 4. Creation of a First Nations Marketing Group that can work with the FNLC and First Nations communities to promote economic opportunities

JTST has shared some of the material it has developed to promote First Nations involvement in economic development with the FNLC, and has received no response. There is also considerable overlap with Aboriginal Business and Investment Council's (ABIC) function.

### 5. Environmental Assessment Reforms

The Environmental Assessment Office (EAO) is always working to enhance its process, including working with the Federal Government, First Nations and industry. This involves having discussions with FNLC about future direction.

### 6. Partnership arrangements with First Nations Councils and Industry Associations

The Province has offered to facilitate meetings between the FNLC and the BC Business Council (BCBC) on multiple occasions and has not had a positive response. BCBC continues to work with ABIC to facilitate these types of partnerships.

The Province currently funds the ABIC and has developed a collaborative approach to achieving common goals. The Province's support of ABIC's goal – to advance Aboriginal participation in the economy and to promote economic certainty in the Province by encouraging economic growth in Aboriginal communities – mirrors much of what is proposed by the FNEMC. It is in the Province's interest to not duplicate such support.







- The Minister of Jobs, Tourism and Skills Training (JTST) has primary responsibility for support and funding of the ABIC; however, MARR will play an important role in facilitating the work of the ABIC.
- Congratulations to the ABIC on their "Success through Sharing"
   Symposium in December as well as their upcoming "Playbook", an
   online tool to promote best practices for doing business with
   Aboriginal communities.

### III. KEY POINTS AND BACKGROUND:

The ABIC is currently made up of eleven representatives (see attachment) from business and Aboriginal communities. The chair is Chief Ellis B. Ross (Haisla) who is also on the BC Jobs and Investment Board. The ABIC is contemplating a formal seat for a British Columbia Business Council (BCBC) representative.

ABIC members have been selected for their understanding of business, Aboriginal cultures, relationship building and successful business models.

The ABIC is mandated to help improve Aboriginal participation in the economy and to promote economic certainty in the province by encouraging economic growth in Aboriginal communities.

The focus of the ABIC is economic development. The Council will not address Aboriginal rights and title.

The ABIC's major strategic objectives are to advance Aboriginal peoples' participation in the economy by:

- · Identifying successful investment models;
- · Providing investors with tools to engage and partner with Aboriginal people;
- · Providing expert advice on Aboriginal economic development policy; and,
- Developing relations between Aboriginal communities, industry and government.

The ABIC has successfully delivered a "Success through Sharing" Symposium (December 2012) which brought together Aboriginal and non-Aboriginal leaders to showcase successful partnership ventures.

The ABIC is currently developing an online playbook which will highlight successful First Nations Business ventures and business partnerships throughout the province so other Aboriginal communities can use them as a guide to further their economic initiatives.

JTST provides secretariat services for ABIC. The Ministry has allocated \$290,000 this fiscal year for ABIC activities.

MARR is actively engaging with the ABIC. In particular, MARR is promoting stronger partnerships with the BCBC and ABIC as well as participating in development of a First Nation economic development database.


