

CEPA represents companies that transport 97 percent of the oil and natural gas produced and used in Canada, providing more than two-thirds of the country's daily energy needs. CEPA's membership currently operates more than 100,000 km of pipelines in North America. Members of CEPA include Kinder Morgan, TransCanada Pipelines, Spectra Energy, and Enbridge.

While CEPA acts as an advocate and voice of the industry on strategic issues and regulatory/policy matters, it does not speak for its membership with regards to specific projects.


