Thank you for your letter dated December 4, 2002, in which you express an interest in making an application to obtain the vacant guide/outfitter area (No. 626G0002) southwest of your territory.

Following our discussions, Wildlife Branch staff have researched this matter, and based on this I am not willing to consider allocating that territory at this time. My decision is based on the fact that members of the Taku River Tlingit First Nation (TRTFN) have expressed interest in obtaining that territory on a couple of occasions in the past several years, and that the Treaty Negotiations Office has identified ownership of that territory as an item that may be the subject of treaty negotiations with the TRTFN.

Dear Mark Williams:

The purpose of my letter is regarding the disposal of the vacant guide outfitter area south of Atlin that extends into Atlin Park on the East Side of Atlin Lake. The subject area was once held by a member of the Taku River Tlingit First Nation and I understand that he is very interested in having the decision to remove it from him reversed.

The Taku River Tlingit First Nation as well as individual band members have expressed an interest in obtaining the guide outfitting rights to the area on a number of occasions. Due to the First Nation's strong interest we expect to be discussing the future ownership of this area at the table as the negotiations unfold.

Therefore, I am requesting that the Regional Manager of Fish, Wildlife and Habitat not assign the subject area to a third party until the land claim negotiations have been resolved.
