IN THE HOURS PRIOR TO THE TIME OF THE FIRE THE HOME OWNER HAD BEEN STAINING CABINETS IN THE GARAGE OF HIS RESIDENCE. HE HAD THE CABINETS LAYING ON TWO 2X4'S BETWEEN SAW HORSES. THE FLOOR BELOW THE CABINETS WAS COVERED WITH CARDBOARD TO PROTECT THE FLOOR FROM STAINING MATERIALS. AT THE TIME OF THE FIRE THERE WHERE TWO NEW HEATERS (HONEYWELL CLASSIC HEATER FANS 1000/1500 WATTS SKU 3836-023 SOLD AT HOMEHARDWARE STORES) BEING USED SITTING ON THE FLOOR NEAR THE AREA OF STAINING. ONE OF THE HEATERS WAS PLUGGED INTO A EXTENSION CORD AT THE TIME OF THE FIRE . THE MANUFACTURES INSTRUCTIONS ADVISED TO NEVER USE HEATER WITH A EXTENSION CORD OR POWER BAR. THE HOME OWNER COULD NOT REMEMBER IF THE HEATERS HAD THE PROPER CLEARANCE DISTANCE (3 FT ALL AROUND) BETWEEN COMBUSTIBLES. THE HOME OWNER ALSO STATED THAT HE HAD USED STAINED RAGS WHICH WERE LAYING IN AND AROUND THAT AREA. DUE TO THE EXTENSIVE FIRE DAMAGE TO THAT GARAGE AREA WE CAN ONLY SPECULATED THAT THIS MAY HAVE BEEN THE CAUSE OF THE FIRE.
