



Cooking up a batch of wort (what beer is called before fermentation) takes approximately one and a half hours. Following this, all beers take at least three weeks to go through the stages of fermentation, settling out, and being filtered & carbonated before they are ready to drink. We require at least 24-hours notice for bottling appointments. You can expect to be here for just over an hour to get your bottles washed, get the beer inside of them, then capped and ready to go!

Your options for the start of the beer-making process are a little more flexible. If you want to take part in the fun of creating beer, be prepared to spend around 90 minutes in the store with us on day one. During this time, at least one staff member will guide you through the entire process. From recipe selection to gathering ingredients, all the way to pulling off the beer and pitching the yeast, one of us will be there to see you through.

Alternately, with 48 hours notice and a \$6 fee, we can prepare the wort for you ahead of time. This means you need only spend five minutes in the store on day one, during which time you will pitch the yeast and do the paperwork. Your presence is non-negotiable in regards to adding the yeast. We maintain a special

license that allows us to produce wort, but by law this wort cannot become beer until YOU pitch the yeast.

#### Batch Size & Bottling

Each batch of beer is equivalent to 12 cases of commercially bottled beer. This means you will need enough bottles for 48L of Caribou's finest. You can use either glass or plastic bottles. Please choose one, there is no mixing and matching.

As with wine bottling, you can save some money by recycling commercial containers for your beer bottling needs. Ask the staff for a complete list of acceptable brands and washing guidelines. But remember, you don't want to ruin great beer by putting it in dodgy bottles - if you're not prepared to do some serious cleaning, the recycling route is not for you.

New bottles are available for purchase in-store. We generally stock two sizes of both glass and plastic (P.E.T.) bottles. Brown P.E.T. bottles are available in 500mL and 1L sizes; including tax, they cost 50¢ and \$1.00 respectively. Glass bottles are also brown ('tis better for the beer) and come in 341mL and 650mL sizes. Although a bit pricier (65¢ and \$1.34 respectively) we recommend glass bottles for ease of maintenance and better tasting beer.

- 1. You must submit a complete application package (all required documents are listed in Part 8) and application fee to Victoria Liquor Control and Licensing Branch Head Office.
- 2. The Liquor Control and Licensing Branch (LCLB) staff will review the application package for completeness and will advise you of any information/documentation required before the application can be considered complete. A review of the floor plan layout, site plan and business proposal will be conducted as well as applicant eligibility assessment. If all is in order, an Approval in Principal (AIP) letter will be sent to you.
- 3. When the construction/renovations have been completed and you would like to begin the manufacturing process, you must contact the local liquor inspector for a final inspection and interview.
- 4. If the facility passes the inspection and the applicant has signed an agreement with the Liquor Distribution Branch, a (prorated) annual licence fee will be requested.
- 5. The licence will be issued with an expiry date of March 31.

**IMPORTANT NOTE**: Your COMPLETE application package must contain this application form with responses in all the applicable fields, all the required documentation AND the full fee. 




