

### **April 2015 Victoria County Benchers Report**

### An Untimely Passing:

We are saddened to report that one of the Law Society's appointed benchers Benjimen (Ben) Meisner died on 2 April 2015 following a brief illness. Ben was known as the "Voice of the North" for his significant contributions to the radio broadcasting industry and other pursuits. He was appointed a bencher in 2010 sitting on various committees and numerous credentials and discipline hearings. In 2015 he was made a Life Bencher by LSBC President Ken Walker, Q.C.

Ben was known for his candid, forthright, and well considered opinions. He spoke passionately about the importance of the role of lawyers, the rule of law, and the protection of the public interest as a primary obligation of the profession.

When not making contributions as a bencher, Ben enjoyed fishing (including the truly Canadian version known as "ice fishing"), and was a classic automobile enthusiast, striking a particularly cool image while driving his beautiful 1961 Chrysler 300.

A one-time bursary in Ben's memory is being established by the LSBC at the Thompson Rivers University Faculty of Law. Ben said he wanted to make sure that any contributions went to a deserving person with financial challenges while attending law school. ### Revised Law Society Rules: EFFECTIVE on JULY 1, 2015

Another reminder to all that the revised Law Society Rules will go into effect on 1 July 2015. There will be informational sessions arranged to assist members in familiarising themselves with the revised Rules. Particulars on these sessions will be communicated in the near future.

### Work of the Lawyers Assistance Program of B.C. (LAP):

Derek Lacroix, Q.C. was a guest at the 10 April Benchers meeting, providing insights and a discussion of the history and objectives of the LAP. s.22 s.22

LAP has 5 full time counselors who are or have been lawyers, and an additional group of 300 volunteers around the province who provide support and outreach. Over 450 people a year receive one-on-one counselling or assistance; the program extends beyond lawyers needing assistance to include law students, judges, colleagues, family members, and staff who may have concerns for a lawyer or need for assistance themselves.

Derek emphasised that the services provided by LAP are confidential; in particular the LSBC is not informed of conversations with lawyers seeking assistance or the counselling they may receive. Although Derek may initiate contact with a lawyer, he will not do so - except in urgent circumstances - unless he receives at least two calls from others concerned about the lawyer's welfare and the impact it may be having on his or her practice and client obligations.

### LSBC Staff Calls to LAP:

Derek Lacroix's presentation was helpful background to an agenda item at the April 10 Benchers meeting presented by Deborah Armour, Chief Legal Officer for the LSBC, (with the assistance of Michael Lucas, Manager, Policy and Legal Services). Ms. Armour provided a history of circumstances where she relayed that LSBC staff often witness lawyers experiencing issues where it is believed the LAP could provide meaningful assistance. Ms. Armour said that in some cases staff believe there is a significant threat to the lawyer including risk of suicide. This puts additional stress on staff who currently have no way to immediately address such issues other than calling law enforcement in cases of imminent danger.

LSBC Rules as presently drafted prevent staff from providing information to LAP about individuals in need of assistance. Ms. Armour suggested it would be

appropriate to consider a Rule change to permit staff to call LAP if they have significant concerns in a particular case. The suggestion is that staff would not be doing any more than another lawyer might do in calling LAP with a request for assistance for a colleague or family member. In this context Ms. Armour noted that calls to LAP by the LSBC would in many cases be in situations where disciplinary steps were not seen to be appropriate, but there could be some cases where disciplinary action is being or may be pursued.

The Benchers then had an open and focused discussion on the question. Generally speaking although the benchers recognised the benefit of early assistance being provided to lawyers to provide them with needed support, and also how such an approach could serve the public interest, Benchers were also concerned about the impact such a change in the Rules might have in creating an administrative "link" between the LSBC and LAP, and its impact upon, and balancing of, privacy interests. Benchers wished to ensure that before any potential Rule change occurred, the membership be invited to provide their views and input on this question.

As a result, the proposed Resolution in the agenda materials to approve in principle an amendment to the Rules did not proceed; instead the Benchers directed that CEO Tim McGee, Q.C. and Ms. Armour provide a further staff report and "work up" to Benchers on this question, including the need for consultation with our membership, consultation with lawyers representing members in discipline matters, and enquiries of regulators of other professional bodies about what if any models they have in place for similar objectives.

Pinder and Dean invite your feedback and ideas on this issue. The full text of Ms. Armour's submission on this agenda item is available on the LSBC website under the heading of Bencher meeting agendas for 10 April 2015.

### Strategic Plan Progress Report – Family Law Legal Aid:

New Westminster County bencher Phil Riddell gave a report on alternate models for the delivery of family law legal aid, with a particular focus on the Manitoba pilot project for family law legal aid funding.

The discussion examined some of the challenges to the existing Manitoba model and whether any features of it would be realistically transferable to B.C. The increased use of mediation was also discussed. There was emphasis on the importance of lawyers playing a significant role in seeing that cases are properly prepared for mediation in order for ADR to have a greater likelihood of success thus reducing expense and turmoil for family law clients.

### President's Report:

Ken Walker, Q.C. spoke on the progress of our legislative request for the authority to regulate non-lawyer legal service providers. The request has also been looking at merging our regulatory regimes of that of the Notaries. This is part of government's request that we work with the Notaries to see if we cannot create one governance authority to deal with the delivery of various forms of legal services in the province. If we can reach agreement with the Notaries, the new legislation would provide the jurisdiction to deal with credentials, enrolment, and discipline of lawyers and notaries. There are approximately 320 Notaries in BC, practicing throughout the province, with the great bulk of their work in the areas of conveyancing and the drawing and supervision of the execution of wills.

Discussions are ongoing between the LSBC and the Society of Notaries Public of BC concerning the possible legislative change and the governance model to be created. The Benchers passed a resolution at the 10 April 2015 meeting providing for two working groups to assist with those discussions. The first working group will clarify the expanded scope of practice the Notaries have been seeking and will make recommendations to the Benchers regarding the education and qualifications that would be required for the additional legal services sought. The second working group will look at the governance issues that would arise if lawyers and notaries were regulated under a unified regulatory regime. The

creation of the two working groups was contingent upon publishing the Memorandum of Understanding now in place between LSBC and the Notaries Society. The Benchers believe the MOU should be made available to the membership of both societies and the public to permit a full understanding of the anticipated model and to demonstrate the co-operation existing between the LSBC and Notaries on this significant change to legal service governance. For more information, please see President Ken Walker's blog posting on the Law Society website where you can also find a link to the MOU.

We shall report further on developments concerning this new legislation and its implementation in the months ahead.

### Law Day:

Law Day takes place on Saturday 18 April 2015. There will be various events scheduled at the Courthouse in Victoria. Please contact the VBA or CBA for more information and the opportunity to volunteer. Pinder and Dean will have a portable booth set up at the Courthouse to represent the LSBC.

We are very pleased to announce thanks to the organisational support of the VBA, that on **Friday 29 May 2015 from 11:30 a.m. to 1:30 p.m.**, Chief Justice Hinkson of the BCSC and Chief Judge Crabtree of the Provincial Court of BC will be our guests at a two hour lunch time symposium addressing lawyer ethics. Location is the Union Club. Registration space limited to 50 attendees. The cost is a modest \$35 designed to cover expenses including lunch.

The LSBC has accredited the programme for two hours of CPD and will fulfil members' ethics requirement for the year.

### Articling and PLTC:

One of the objectives for the new three year LSBC Strategic Plan is for the Lawyer Education Advisory Committee to provide a report and recommendations on the effectiveness of PLTC and articling as credentialing requirements for call and admission in B.C. Dean is a member of this committee and will be working with Lesley Small at the LSBC to move forward with a system to approve proposed joint articles. This initiative has the objective of permitting sole practitioners or small firms to share the benefit and obligations of acting as principles for an articling student.

### Magna Carta 1215:

For those with an interest in legal history, this year marks the 800<sup>th</sup> anniversary of the signing of the Magna Carta by King John near Windsor (no, not Ontario) on 15 June 1215.

There will be a number of events held in B.C. to recognise this celebration, including lectures by legal scholars and respected jurists. The LSBC plans a high school essay contest with a meaningful prize to the winner.

Hi Nancy. Yes, this likely relates to the December 5, 2014, "Report of the Legal Services Regulatory Framework Task Force". The work of the Legal Services Regulatory Framework Task Force flowed from the recommendations made by the Legal Service Providers Task Force, who issued a "Final Report of the Legal Service Providers Task Force" on December 6, 2013.

The recommendations of the first task force report (Dec. 2013), which were unanimously approved in principle by the Law Society's Benchers, were:

- 1. That the Law Society seek to merge regulation operations with the Society of Notaries Public, so that the Law Society would become the regulatory of both lawyers and notaries.
- 2. That a program be created by the legal services regulatory to provide for certified paralegals.
- 3. That the Law Society develop a regulatory framework by which legal service providers, who are not lawyers or notaries, could provide credentialed and regulated legal services to the public.

The second task force report (Dec. 2014) reports on the further work that was done to follow up on the third recommendation (i.e., permitting non-lawyer, non-notary legal service providers to provide limited legal services to the public in a credentialed and regulated manner), including identifying the areas where there might be gaps in access to legal services that could be filled by new limited legal service providers. The task force recognized that in order to create, credential and regulate new categories of legal service providers, an amendment to the Legal profession Act would be necessary, and recommended that the Benchers seek such an amendment.

As Tyler noted, we are looking at the requested amendments, so there may not be a lot we can specifically in this regard.



### Benchers establish working groups to examine possible regulatory merger with the Notaries Society and legislative amendments

At the April meeting, the Benchers established two working groups to examine preliminary matters regarding the possible regulatory merger with the Society of Notaries Public of BC, and a proposed legislative amendment to the Legal Profession Act on the scope of the Law Society's regulatory function. This follows the endorsement of the recommendations set out in the Legal Service Providers Task Force Final Report (December 2013), and the Report of the Legal Services Regulatory Framework Task Force (December 2014). One working group will examine the skills and knowledge required to provide the additional legal services the notaries would like to provide and make recommendations about the educational and experiential requirements. The second working group will be looking at issues of governance. It is expected that both working groups will report back to the Benchers in June. To read the Memorandum of Understanding with the Society of Notaries Public of BC, and other related material, please refer to the President's blog.

### Update from the Law Firm Regulation Task Force

The Law Firm Regulation Task Force, whose mandate is to develop a framework for the regulation of law firms, has begun its work. The lawyer-firm relationship involves aspects of proximity, responsibility and interdependence. As such, law firms can be especially significant entities for effective regulation of the legal

profession. At the same time, some activities of law firms may transcend the responsibility of any individual lawyer and thus need to be regulated separately. The task force recognizes that in developing a framework for law firm regulation, it must be responsive to the realities of legal practice in firms of various sizes, geographical locations and practice areas. Before any final decisions are made, the profession will be consulted to assist the task force in developing an appropriate and practical framework for regulation of law firms.

### Revision and consolidation of Law Society Rules

At their April meeting, the Benchers adopted revised and consolidated Law Society Rules, to come into effect July 1, 2015. The revision will eliminate decimal numbering, verify and update cross-references, add marginal notes to cross-references to aid recognition, and ensure consistency and economy of language, among other changes. A draft copy of the rules can be found here.

### In memoriam: Senjimen Meisner

On April 2, Appointed Bencher Benjimen Meisner passed away after a short battle with cancer and pneumonia. He was 76. Ben was a valued member of the Law Society Bencher table. During his tenure, he was a member of the Law Society's Credentials Committee and Unauthorized Practice Committee. Originally from Saskatchewan, Ben worked for nearly 60 years in the media as a news reporter, writer and, for much of his career, a talk show host. In his final days Ben had said that he would be greatly honoured by a "Life Bencher" designation, given his strong attachment and love for his Bencher colleagues and the Law Society. President Ken Walker, QC bestowed that honour on Ben the day before he died.

### Don't get caught – first limitation under the new *Limitation*Act expires June 1, 2015

The first limitation under the new *Limitation Act* will expire in less than two months. Act now to protect your clients so that you don't get caught. Read the <u>information</u> on our website, and incorporate the "Ten tips to beat the <u>reset</u> clock" into your practice. And don't forget to refer to our <u>Quick Reference List</u>, a convenient three-page chart that will help you flag and diarize a variety of limitations for all of your client matters. A total of 64 lawyers have already reported a missed limitation this year. Don't let the new *Limitation Act* turn you into another statistic.

### BACKGROUND:

- The Society of Notaries Public has requested an expanded scope of practice for a number of years. However, significant consumer protection concerns with the expanding notaries areas of practice were raised by the Law Society and the Canadian Bar Association (BC Branch).
- In the context of the ongoing requests for an expanded scope of practice
  for notaries, and initiatives of the Law Society relating to paralegals, the
  former Attorney General requested the Law Society and the Society of
  Notaries Public to develop a proposal regarding regulatory reform of legal
  services in the province.
- In December 2013, the Law Society Benchers unanimously approved in principle recommendations made by a Law Society Task Force, which was established to consider the former Attorney General's request. The recommendations included that the Law Society become the regulator for both lawyers and notaries, and that a framework be developed to enable regulation of new categories of legal service providers.



### BC Code change: Lawyers' notification obligations on withdrawal

At their July 2015 meeting, the Benchers amended <u>rule 3.7-9</u> of the Code of Professional Conduct for British Columbia. The change requires that a lawyer *promptly* notify the client, other counsel and the court or tribunal of the lawyer's withdrawal from a file.

### Electronic communications for annual general meetings and Bencher elections

Also at their July meeting, the Benchers discussed using electronic voting for Bencher elections, webcasting of and electronic voting at general meetings (annual general meetings and special general meetings), and electronic distribution of the material for general meetings. They resolved to put a motion before the membership at the 2015 Annual General Meeting permitting the Benchers to amend the Rules to provide for electronic communications for general meetings.

### Articled students permitted to act as commissioners under Evidence Act

Regulation 142/2015 comes into effect September 1, 2015. It prescribes articled students and temporary articled students as persons who are commissioners for taking affidavits in British Columbia, pursuant to  $\underline{s}$ ,  $\underline{60(i)}$ . By virtue of this Regulation, students will be able to do all the things that lawyers may do acting as a commissioner for taking oaths. Principals will need to ensure that students understand the effect of acting as commissioner, and principals remain responsible for students'

actions.

Discussions continue on possible regulatory merger with the Notaries Society

The Benchers received reports from the two working groups assigned to consider aspects of a possible regulatory merger between the Law Society and the Society of Notaries Public of BC. The working groups are examining educational and experiential requirements and issues of governance. The Benchers will continue their consideration of the possible merger at their September meeting.

Mid-year report: New ideas for improving access to justice The Access to Legal Services Advisory Committee presented its mid-year report to the Benchers. After a review of the Manitoba Family Justice Program, the committee advised the Benchers that they had concluded this model would not work in BC. The committee also reported on the merits of encouraging retired lawyers and judges to offer pro bono services and how to support improved access to justice for BC Aboriginal people.

Mini-year report: Diversity in the practice of law
The Equity and Diversity Advisory Committee monitors and
develops effective equity and diversity in the legal profession and
the justice system in BC. Three areas of particular emphasis
include Aboriginal lawyers, women lawyers and the overall
diversity of the profession. The committee reported that it is
looking to meet with BC law schools to create more opportunities
for Aboriginal lawyers and to discuss implementation of Truth and
Reconciliation Report recommendations.

Fild-year report: Sharing a fundamental principle of Canadian democracy

The <u>Rule of Law and Lawyer Independence Advisory Committee</u> reported it is planning to engage the public on the concept of the rule of law through a series of articles and other public-facing initiatives.

Mid-year report: Reviewing the education process for new lawyers

The <u>Lawyer Education Advisory Committee</u> reported on the work it is doing to review the articling process and PLTC. The findings from a survey of lawyers with two to three years of call supported the conclusion that PLTC is a positive experience. The committee continues to research the effectiveness of the program.

### Research grants available

BC lawyers are invited to apply for research grants from the Law Foundation by submitting a letter of intent before September 11, 2015. The Law Foundation makes \$100,000 available annually for legal research. More information can be found here.

Trinity Western University (TWU) update
The Ontario Divisional Court <u>dismissed TWU's application</u> for judicial review of the Law Society of Upper Canada's decision to

deny accreditation of TWU's proposed law school. As a reminder, TWU's petition against the Law Society of BC will be heard next month. TWU has filed its written argument with the court and the document and further information on TWU's proposed law school are available <a href="here">here</a>. Chief Justice Hinkson will hear the case, which is set for five days commencing August 24.

The Land Title and Survey Authority of BC (LTSA) is implementing new fee listings for its land title and survey services, coming into effect in early November 2015.
