## MINISTRY OF JUSTICE LIQUOR CONTROL AND LICENSING BRANCH BRIEFING NOTE

PREPARED FOR: Hon. Suzanne Anton FOR INFORMATION

ISSUE: Meeting on May 20th with representatives from the H.Y. Louie company.

## **BACKGROUND:**

H.Y. Louie is B.C.'s second largest family business. It owns the London Drugs chain and operates many IGA, Marketplace IGA and Fresh St grocery stores. It also acts as a wholesaler to other IGA stores.

H.Y. Louie will be represented at the meeting by:

- Gary Sorenson, Executive VP and COO
- John MacNichol, VP Marketing

The company is interested in how it can obtain liquor licences for the sale of VQA wine in their grocery stores, given the recent approval of a VQA store in Surrey.

There are 21 VQA store licences issued to the BC Wine Institute. They contract the operation of these stores to 3<sup>rd</sup> party operators. The licence class is subject to a moratorium but the Government will be issuing a limited number of new licences for the sale of 100% BC wine on grocery shelves.

#### DISCUSSION:

There are different options for a grocery store interested in selling wine or liquor:

- The "store within a store" model allows for licensee retail stores, LDB stores and independent wine stores to relocate to an eligible grocery store for same-cart shopping and the sales of beer, wine and spirits through separate cashiers.
- The "wine on shelves" model (part 1) will allow existing VQA and independent wine stores to relocate to an eligible grocery store to sell 100% B.C. wine.

To coincide with the grocery model:

- The five-kilometre rule has been eliminated, allowing for more flexibility around the movement of licences.
- The one-kilometre rule remains in place for LRS's and has been expanded to include LDB stores.

- Independent wine stores, liquor manufacturer stores and VQA stores will continue to be exempt from the one-kilometre restrictions under B.C.'s new grocery model.
- Grocery stores must meet minimum size requirements (10,000 sq ft) and be focused on food service (70% of sale revenue).
- In regard to the sale of 100% BC wine on grocery store shelves, only a very limited number of new store licences will be issued and this will happen later this year.

## **SUGGESTED RESPONSE:**

In regard to VQA stores, the BC Wine Institute is the licensee and they determine where the stores will be located, subject to LCLB approval. There are 21 VQA store licences and the government is not issuing more. Miles Prodan, CEO of the BCWI, is your best contact for more information on how you might obtain these stores.

In the Fall of 2015 Government will conduct an auction to win the right to apply for a limited number of new wine store licences for the sale of 100% BC wine from grocery store shelves.

Grocery stores meeting the size and food focus requirements will be eligible to participate in the auction. Auction winners will then be invited to apply for the wine store licences.

Enabling legislation has been passed by the Legislature this Spring. We are in the process of developing the policies, procedures and regulations to enable the auction and issuance of the licences. This information will be publicly available prior to the auction.

We expect to issue no more than two dozen of these licences, and perhaps less, in order to remain compliant with our international trade obligations.
