**ISSUE**: Anticipated s.13 announcement regarding the City of Richmond's

#### SUMMARY:

• The City of Richmond has requested that the Ministry of Justice review and approve their request to transition to an independent Police Force.

#### SUGGESTED RESPONSE:

- It is the Minister's responsibility under the Police Act to ensure adequate and
  effective policing is in place across the province for the safety of British Columbians.
- The City of Richmond signed the RCMP Municipal Unit Agreement which ensures
  they have effective policing in place, as required by the Police Act, while they
  consider their future plans.
- It has always been an option for municipalities to consider another policing option.
   The Police Act allows policing alternatives which includes policing provided by the provincial force, the municipality having its own police force, or contracting with an adjacent independent police force.

#### BACKGROUND:

- Under the Police Act, part 2, section 3 (2) a municipality with a population of 5000 or more persons must provide policing and law enforcement in accordance with the Act by choosing one of the three options:
  - "Establishing a municipal police department;
  - Entering into an agreement with the minister under which policing and law enforcement in the municipality will be provided by the provincial police force;

o With the approval of the minister, entering into an agreement with another municipality that has a municipal police department under which policing and law enforcement in the municipality will be provided by the municipal police department of that municipality."<sup>1</sup>

- In 2007, the City of Richmond contracted Perivale and Taylor consulting to review the characteristics of a well-functioning police service.
- In 2012, the Richmond City Council requested the Vancouver Police Board to
  provide assistance into analyzing the transition to an independent police service,
  providing the Council with a detailed analysis entitled "Estimating Police Costs for
  the City of Richmond".

- Since meeting with Minister Anton (the Minister) in March 2015, the City of Richmond has made known their intention to simultaneously announce s.13 a community consultation process, as well as release a new report, not yet shared with the Ministry of Justice.
- North Vancouver has also conducted research into studying policing alternatives but at this time has opted to maintain the Municipal Police Unit Agreement (MPUA) with the RCMP.
- For Richmond's proposal to be viable, it will need to clearly demonstrate how the new force will be fully integrated into the region, to avoid the "silo effect" as was the Solicitor General's concern.

- The MPUA termination provision, stipulates that 1) the Agreement may be terminated on March 31 in any given year and that the Municipality must provide 25 months of notice prior to the date of the intended termination.
- The earliest date the City of Richmond could terminate their MPUA is March 31, 2018.
