For your immediate info though, I can tell you that our goal is actually make a more meaningful presence in BC. While we have a staff of 10 presently, they are hidden in a strip mall in Surrey.... hardly a presence in the province. As the

national call centre, they provide little connection with BC other than a physical presence. We have several initiatives aimed at working closer with Stan Lowe, have appointed a vice Chair in Victoria and will continue to use BC based investigators.
