Your email of February 2, 2014, has been forwarded to the Criminal Justice Branch for a response. The Criminal Justice Branch is responsible for the conduct and supervision of criminal prosecutions in British Columbia.

The Ministry of Justice cannot provide you with legal advice in regards to the matter you have addressed in your correspondence.

However, if you have reason to believe an individual has committed a crime against you, the proper course of action is for you to report such allegations to the police. It is the role of the police, in the independent exercise of their discretion, to conduct an investigation into alleged criminal wrongdoing.

If the police determine that there is sufficient evidence to warrant a criminal charge, they may forward a report to Crown Counsel requesting that a charge be approved. Crown Counsel review the report and decide whether there is a substantial likelihood of conviction on the evidence and whether a prosecution is required in the public interest. If this test is met, a prosecution is then initiated.

If you have not already contacted victim services, you may wish to contact VictimLINK, a service available to victims of crime in British Columbia, providing help and information 24-hours-a-day. It is accessible from anywhere in the province, and can be accessed by telephone at 1-800-563-0808, or through their website: www.victimlinkbc.ca/.

If you would like to know what legal options, if any, may be open to you, you may wish to seek advice from an independent lawyer in that regard. The Lawyer Referral Service is provided by the Canadian Bar Association, and can refer you to a lawyer in your area who will meet with you for up to 30 minutes for a fee of \$25 plus applicable taxes.
