ISSUE: Meeting with Chief Crystal Smith - Haisla Nation

BACKGROUND:

The Cedar LNG project is a proposed Liquefied Natural Gas (LNG) facility and export terminal located in Kitimat, British Columbia (BC) within the traditional territory of the Haisla Nation. Cedar LNG is located on Haisla-owned land in the Douglas Channel. The project is planned as a floating liquefaction facility that would operate with electricity from the BC Hydro grid. s.21 s.21

Cedar LNG was initially proposed by the Haisla Nation. In November 2020, the Haisla Nation approved Cedar LNG's partnership with Pacific Traverse Energy (PTE), a Vancouver-based energy infrastructure development company, and Delfin Midstream, an LNG export development company specializing in low-cost floating LNG technology. On June 8, 2021, Pembina Pipeline Corporation (Pembina) and the Haisla Nation announced their partnership on the Cedar LNG Project. Pembina will assume the equity interests currently owned by PTE and Delfin Midstream and operatorship of the Cedar LNG project going forward.

Cedar LNG would be the largest First Nation-owned infrastructure project in Canada. In an interview published in the Financial Post (June 30), Chief Smith is quoted as saying that the addition of Pembina to the team has added a lot of credibility in terms of the reality of the success of the project.

Cedar LNG entered the environmental assessment process August 2019. In January 2020, Cedar LNG was granted substitution by the federal Minister of Environment and Climate Change. This allows the project to undergo the provincial environmental assessment process to satisfy federal environmental assessment requirements. Cedar LNG was issued an export license from the Canada Energy Regulator in 2016.

Cedar LNG is working with BC Hydro to explore options to power the project with electricity from the provincial transmission grid. s.21

To minimize impact to the local environment, Cedar LNG is planned as a floating liquefaction facility that would fully utilize electricity from the BC Hydro grid as the power source for the liquefaction of natural gas for export. s.21

Since the ownership change announcement in June 2021, Cedar LNG has continued to move through its environmental assessment and community engagement activities.

Pembina

Pembina is a leading transportation and midstream service provider, owning an integrated system of pipelines that transport various hydrocarbon liquids and natural gas products produced primarily in western Canada. Pembina also owns gas gathering and processing facilities, an oil and natural gas liquids infrastructure and logistics business and is growing an export terminals business. Pembina brought a propane export terminal in Prince Rupert into service earlier this year.

Pembina has spent several years working to advance the development of the Jordan Cove LNG project in Oregon. In April 2021 Pembina announced they would pause its development to reassess the impact of recent regulatory decisions.^{s.21}

expects to invest US\$90 million in Cedar LNG over the next 24 months on pre-FID development costs and costs to acquire its interest in the partnership.

Environmental Assessment and Permitting

The project is engaging with BC's Environmental Assessment Office on its EAC application following its initial project description submission in August 2019. s.21 s.21

A public comment period regarding its application information requirements is currently open until July 19, with limited comments submitted to date.

Feedstock Gas and Connecting Pipeline

Cedar LNG has been working with TC Energy to develop the Cedar LNG pipeline that would connect CGL to the Cedar LNG facility. This pipeline does not trigger the requirements for an EAC and all required permitting would be through the Oil and Gas Commission.

MINISTRY RESPONSE:

Projects such as Cedar LNG open the door to global markets for BC, while creating sustainable jobs and economic development that makes meaningful partners with Indigenous peoples. The Province is supportive of Cedar LNG as it moves through its regulatory process and commercial activities.


