ISSUE: Meeting to discuss how Amazon Web Services can support the growth of BC's innovation ecosystem and align to government's COVID-19 recovery efforts.

BACKGROUND:

Amazon Web Services (AWS) is a subsidiary of Amazon providing on-demand cloud computing platforms. AWS has a growing tech hub in Vancouver at "The Post" which is the old Canada Post building on West Georgia Street in Downtown Vancouver which is being redeveloped.

Throughout the COVID-19 pandemic, AWS reports they've been deploying people and technology to support B.C. and to enable remote learning and working, both in the public sector and with small and medium-sized business.
