**ISSUE(S):** Introductory meeting with Rogers Communications and an update on Rogers' investments in 5G and innovation.

### **KEY POINTS:**

- Founded in 1960, Rogers Communications is a leading Canadian communications and mass media company. It is Canada's largest provider of wireless communications services and one of the leading providers of cable television, high-speed Internet, information technology, and telephony services to consumers and businesses.
- Rogers has Canada's largest 5G network.

### BACKGROUND:

Rogers has a highly skilled and diversified workforce of approximately 23,500 employees in 2020. The company's head office is in Toronto, with numerous offices across Canada. Rogers' shares are publicly traded on the Toronto Stock Exchange and on the New York Stock Exchange.

Rogers Communications reports that it directly contributed \$14.1 billion in economic value to the Canadian economy in 2019, through investments in Canadian jobs, content, communities and networks. According to a PwC Canada study, Rogers' economic output footprint in British Columbia (B.C.) was roughly \$1.7 billion in 2019, including over 5,500 full-time jobs generated and supported.

Rogers Communications has several areas of contact with the B.C. Government, managed through the Ministry of Citizens' Services:

- Rogers enables connectivity in B.C.:
  - Rogers is one of three service providers that have a substantive cellular footprint in the province, the others being TELUS and Shaw.
  - s.13 expand cellular services to smaller communities and along primary and secondary highways. This is particularly important for emergency alerting capabilities.
- Rogers as a vendor:
  - The Province has a Corporate Supply Arrangement (CSA) with Rogers, available to government ministries and the broader public sector, for cellular equipment and service rate plans.
  - The CSA contract was initially signed on June 1, 2012, and will end on May 31, 2021.

  - The Information Communications Technologies Branch within the Office of the Chief Information Officer Division (OCIO) regularly meets with Rogers in the management of the cellular CSA.

### **DISCUSSION:**

With the internet embedded into all aspects of our day-to-day lives, connectivity is critical for British Columbians and Government encourages its expansion in rural and remote areas across the province, enabling a broad spectrum of possibilities, including healthcare, education, culture, public safety and economic activity.

The Rogers-University of British Columbia (UBC) partnership announced in November 2019, is an example of Canada's first 5G network as a 'living-lab' testbed for 5G innovation. With funding from Rogers, a round of research projects, including an earthquake-early warning system of 5G and a 5G-enabled-digital-mine, were also announced. UBC brings world renowned researchers and facilities to co-develop applications.

In December 2020, Rogers announced it had expanded its 5G network to 26 cities and now reaches 160 communities across Canada.

In March 2021, Rogers announced a \$26 billion partnership with Shaw, creating new jobs and investment in Western Canada and accelerating Canada's 5G rollout. Rogers also committed to the establishment of a new \$1 billion Rogers Rural and Indigenous Connectivity Fund to connect rural, remote and Indigenous communities across Western Canada to high speed internet.

### Connecting BC:

The Connecting BC program is funded by the Province and administered by the Northern Development Initiative Trust. The program helps fund infrastructure required to deliver high-speed internet connectivity to rural and remote areas of the province.

In April 2020, Government invested \$50 million for Phase Three of Connecting BC – the largest single allocation since the creation of the program in 2015 (Phase One totalled \$10 million, followed by \$40 million in Phase Two). Connecting BC is currently accepting applications for Phase Three, with funds available for internet service providers and local governments to do immediate network equipment upgrades to improve capacity and connect rural and Indigenous communities with high-speed internet.

Rogers continutes to invest in B.C. and by leveraging support from the Connecting BC program, they have announced a number of expansions in 2021:

- February (from the provincially funded COVID-19 Response Intake) 29 existing cellular towers have been upgraded to provide additional cellular coverage and broadband services to 52 B.C. communities (in and around Vancouver Island, Okanagan, Cariboo, Central and Northern B.C.).
- April Providing reliable connectivity along Highways 16 (also known as the Highway of Tears) and 14, with construction beginning in the Spring of 2021.
  - Highway 16 building 12 new cellular towers to close key gaps and provide 252 kms of new highway cellular coverage, and coverage at three provincial highway rest stops. This helps close key gaps along this corridor and means that there will now be near continuous coverage along all 720 km of this northern highway through to Prince George.
  - Highway 14 seven new cellular towers to be built along the route from Sooke to Port Renfrew, providing essential connectivity to those who live, work and visit this area of Vancouver Island.

### Regulatory

 Rogers is very interested in passive utility infrastructure<sup>1</sup> and future considerations would help implement 5G including:

- Rogers holds valuable spectrum<sup>3</sup> in B.C. and is very interested in the upcoming federal 3500 MHz spectrum auction anticipated to open in June 2021.
- Regulatory challenges exist that could impede Rogers' expansion efforts in B.C.
  - In December 2020, and January and February 2021, Rogers responded to a Canadian Radio-television and Telecommunications Commission (CRTC) proceeding regarding regulatory measures to make access to poles owned by Canadian carriers more efficient.

<sup>&</sup>lt;sup>2</sup> 5G stands for fifth generation and is the latest advance in cellular technology. Experts predict 5G can connect 500 times the number of devices versus 4G. These devices will help governments manage natural disasters, potentially saving lives and businesses. 5G will bring us the 'real-time' economy with low latency and high capacity.
