PROJECT DESCRIPTION

Kitselas Development Corporation has previously worked to execute meaningful, safe construction projects in the northwest of British Columbia, and is proposing to launch a new Health, Safety, Security and Environmental Development Services (HSSE) services business.

The proposed All Nations Safety Services Company will provide Health, Safety, Security and Environmental development services to other First Nations throughout British Columbia. This will include the development of HSSE programs, safety manuals, auditing and RFI/RFP mentorship. First Nations personnel will be mentored during

this time to gain accreditation to perform auditing abilities and expertise to lead the development of HSSE programs.

The All Nations Safety Services Company will work to build an online training platform, which will allow community members living in remote communities to access the courses at their own pace and the training will be facilitated by an instructor in class. Training will also be provided on site as needed by Engineering, Procurement Companies generating a consistent revenue stream. The online training would also work as a safety training database allowing proper timing of safety ticket renewal and an understanding of the First Nations personnel capacity during the life of construction projects.

The All Nations Safety Services Inc. Company will be owned by Kitselas Development Corporation and will initially be supported by the technical expertise of Xi Safety Inc. ensuring existing relationships and a depth of industry experience are leveraged to their full potential. The project aims to ensure First Nations and Non-First Nations contractors have the safety processes in place to work successfully with LNG projects in British Columbia.

The All Nations Safety Services Company will work to partner with existing First Nations and industry groups to maximize capacity development and community participation on LNG projects. Examples of organizations may include but not be limited to the First Nations LNG Alliance, the First Nations Energy and Mining Council and the BC LNG Alliance.

The All Nations Safety Services Company will partner with a designated training provider such as the BC Justice Institute to deliver NCSO training in northwest BC. Trained NCSO, (National Construction Safety Officer's) will be placed under the mentorship of senior HSSE project managers to allow individuals the opportunity to gain valuable project experience.

Rationale for Recommendation:

This project is set to provide First Nations communities the ability to fully participate in the LNG supply chain and local contracting opportunities as negotiated in Impact Benefit Agreements.

Kitselas Development Corporation previously provided prime contractor services for the clearing of utility and gas line corridors for BC Hydro with the Northwest Transmission Line as well as 90km of the Pacific Trails Pipeline through Kitselas and Haisla Territory. These opportunities provide neighboring First Nations and Non-First Nations employment and contracting opportunities.

The following is a list of expected outcomes Kitselas is committed to developing throughout the scope of this project:

- Increased community engagement and communication with large general contractors.
- Increased collaboration among First Nations in securing contracting opportunities.
- Increased First Nations management experience in construction and project execution.
- Increased project certainty through community support.
- Increased revenue streams to communities through indirect opportunities such as site orientation and remote training.
- Elimination of misaligned training through database development.
- Safe work sites and increased community accountability for project execution.




