**ISSUE:** Parkland Fuel Corporation's (Parkland) acquisition of Chevron Canada R&M ULC, which operates Chevron's Canadian integrated downstream fuel business

#### BACKGROUND:

- On October 2, 2017 Minister Ralston received a letter and media release from Bob Espey, President and CEO of Parkland Fuel announcing the completion of Parkland's acquisition of Chevron Canada R & M ULC.
- The acquisition was first announced in April 2017 but has only been finalized in October.
- Parkland Fuel is a Red Deer, Alberta based publicly traded company and Canada's largest independent marketer and distributor of petroleum products.
- Chevron Corporation is a California headquartered global energy company with operations in 180 countries.

#### **DISCUSSION:**

- The acquisition is reportedly valued at \$1.46 billion.
- The properties acquired include 129 Chevron-branded fuelling stations in the Metro Vancouver area, marine fuelling stations, an aviation fuel business which supplies Vancouver International Airport and the Trans Mountain pipeline Burnaby refinery.
- With the completion of the transaction Parkland now owns and operates more gas stations than any other company in Canada – gas station companies include Pioneer Gas and FasGas.
- In 2016 Chevron Corp. posted its first annual loss since 1987 and is in the midst of a two-year plan to sell between \$5 and \$10 billion in assets in 2016 and 2017.

#### **NEXT STEPS:**

- Mr. Espey has suggested that if the opportunity presented itself he or a member of his Senior Leadership team would be happy to meet with Minister Ralston.
- A meeting with Mr. Espey or his colleagues is not necessary at this time.
- A future meeting would be worthwhile should the opportunity present itself to better understand the company's plans to operate its new assets and its expanded role within the BC economy.

Calgary, Alberta (October 1, 2017) – Parkland Fuel Corporation ("Parkland") (TSX:PKI), Canada's largest and one of North America's fastest growing independent marketers of fuel and petroleum products, announced today the closing of its acquisition of Chevron Canada R & M ULC which operates a downstream fuel business in British Columbia and Alberta.

"This acquisition provides Parkland with British Columbia's strongest fuel marketing business and will make Parkland the exclusive distributor of Chevron-branded fuels. With this acquisition, Parkland is also acquiring the Burnaby Refinery, a proven asset that directly supports our core fuel marketing business in an important region, and enhances our supply advantage," said Bob Espey, President and Chief Executive Officer of Parkland. "We are extremely pleased to welcome the Chevron Canada refining and marketing employees to the Parkland team. We believe in and are committed to investing in these assets, and the local employees who will help us grow in BC and beyond."

Parkland closed the transaction on October 1, 2017 at 00:59am (Calgary time).

Parkland will update its 2017 Adjusted EBITDA guidance concurrently with the release of its Q3 2017 financial results.

- 129 Chevron branded retail service stations principally located in the Greater Vancouver area

**ISSUE(S):** This meeting is likely to serve as an introduction to the Mining Association of BC (MABC) and it is expected that MABC may wish to highlight the importance of mining to the well-being of the provincial economy and as a key foundation supporting the broader goals of government.

#### **BACKGROUND:**

MABC has been the voice of the producing industry in B.C. since 1901 and represents the collective needs and interests of operating coal, metal and industrial mineral mining companies and two smelters. MABC also maintains partnerships with suppliers, industry associations, educational institutions, and business affiliates.

The mining sector is very important to the B.C. economy. According to MABC data, the number of people working in direct operations jobs in B.C. was 9,329 in 2016. Gross mining revenues for the B.C. mining industry were \$8.7 billion in 2016 and capital expenditures were \$1.4 billion. The mining industry is one of the safest heavy industries in B.C. with a strong safety record. A healthy mining sector is key to supporting the social, economic and environmental goals of the province.

The Ministry of Jobs, Trade and Technology (JTT) works closely with the Ministry of Energy, Mines and Petroleum Resources (EMPR), the lead ministry for mining in B.C., to support mineral exploration and mining companies, suppliers and associations in the mining sector. EMPR has a positive and constructive working relationship with MABC.

#### **DISCUSSION:**

Mining Awareness

- MABC have indicated their top issues around mining are:
  - Raising awareness of the contribution of the mining sector to the economy of B.C.
  - Raising awareness of how mining contributes to a low carbon future.
  - Highlighting the success stories related to Indigenous relations by the mining sector.

MABC has previously met with the Minister of Energy, Mines and Petroleum Resources to discuss the issue of raising awareness or the importance of mining to B.C., as well as issues of competitiveness, regulation and investment strategy. EMPR are actively and positively engaged with MABC on these issues.

JTT supports mining activity through a number of specific activities, including:

- Network of 14 trade and investment representative offices in key markets such as Japan, South Korea, India, China, South East Asia, the United States, and Europe that have the ability to connect B.C. mining companies with new markets, trade opportunities and potential investors.
- Assisting B.C. companies in closing trade deals with overseas investors.
- Facilitating attraction of foreign investment to the province.
- Assisting in the delivery of outbound missions and executive visits from B.C. to Asia and well as inbound missions and executive visits to B.C. from Asia.
- Working with mining companies on issues related to securing the skilled work force requirements of the sector.
- The Major Investments Office works directly with a number of mine proponents including Graymont, New Gold, KSM, Glencore, and Aurico Metals.
- JTT is an active partner with EMPR and other provincial agencies in support of trade shows such as Mineral Round-Up (Vancouver), Prospectors and Developers Conference (Toronto), China Mining Conference (Tianjin).

In addition to the specific JTT activities to support mining in B.C., there are broader government initiatives which support the competitiveness of the mining sector. For example, the September 2017 Budget Update included an announcement to eliminate the PST on electricity which MABC have indicated they are pleased with.

#### SUGGESTED RESPONSE/KEY MESSAGING:

- The BC Government appreciates the significant contribution of the mining industry to the B.C. economy.
- The Ministry of Jobs, Trade and Technology looks forward to continued constructive engagement with MABC on matters such as trade and investment activities.

**ISSUE:** Release of 2018 Federal Immigration Levels Plan

#### **BACKGROUND:**

- Under the Immigration and Refugee Protection Act (IRPA) the Minister of Immigration, Refugees and Citizenship Canada (IRCC) is required to table the Annual Report to Parliament on Immigration by November 1. The report includes an immigration levels plan for the number of permanent residents that will be admitted to Canada the following year.
- On November 1, 2017, IRCC tabled a three year immigration levels plan for 2018-2020. This is a significant shift from one year levels plans, which have been the standard for decades. The new multiyear plan includes higher levels targets with overall admissions of new permanent residents increasing from a target of 300,000 in 2017 to 310,000 in 2018, 330,000 in 2019 and 340,000 in 2020 (Appendix A).
- Economic immigration categories will receive approximately 60% of the increase in admissions over the next three years with the remainder being distributed between Family Class (spouses, dependants, parents and grandparents) and refugee and humanitarian immigration categories.
- The target for Federal Economic High-Skilled immigration has been increased by 16 percent from 73,700 in 2017 to 85,800 in 2020. Admissions targets under the Provincial Nominee Program will increase from 51,000 in 2017 to 67,800 in 2020, representing a 33 percent increase.
- Over the next three years Family Class immigration will increase by 7,000 to further reduce inventories and improve processing times for spouses and dependents.
- The 2018-2020 Immigration Levels Plan is a rolling plan, meaning that each year IRCC will confirm targets for the next three years with cabinet.

#### **DISCUSSION:**

- A multiyear levels plan will ensure greater predictability and stability for PTs and allow for more informed program planning at the federal, provincial and municipal levels, as well as for immigrant serving organizations.
- Provincial nominee allocations are not part of the levels plan and will be determined in late 2017. s.13,s.16
- PTs will have the opportunity to provide input to IRCC in November 2017 regarding the trade-off between improved federal processing times for provincial nominees and increases to PT nomination allocations.
- BC's immigration submission for 2018 requested an increase in PNP nominations from 6,000 s.13,s.1. In light of IRCC's commitment to incremental growth, along with backlog considerations, s.13,s.16
- Based on historical trends and labour force participation rates for recent immigrants, the 12,100 increase in admissions for Federal Economic high skilled streams from 2017 could mean an additional 1,440 skilled workers for BC in 2020, which nearly eliminates the estimated immigration labour gap in BC even without increases to the BC PNP.

#### **CONCLUSION:**

- The shift to a multiyear levels plan will ensure greater predictability for PTs and service provider organizations.
- BC will continue to express its support for higher economic immigration levels going forward and the importance of maintaining multiyear levels planning in the future.
- PNP allocations for 2018 need to be determined as soon as possible to ensure that the BC PNP can plan effectively how best to use its nominations.
- BC will participate in discussions with IRCC regarding PNP allocations for 2018 and will press IRCC to pursue three-year nomination allocations.
- PT PNP allocations will likely be announced in late 2017.

**ISSUE:** Renegotiation of certain provisions in the Trans Pacific Partnership (TPP).

#### **BACKGROUND:**

- The TPP is a free trade agreement that was concluded in October, 2015. It included twelve Pacific countries: Australia, Brunei Darussalam, Canada, Chile, Japan, Malaysia, Mexico, New Zealand, Peru, Singapore, the United States, and Vietnam.
- In order to come into force, six countries that make up 85 per cent of TPP economies needed to ratify the Agreement. This effectively required ratification by both the US and Japan. As the US withdrew from the TPP in January 2017, the Agreement, as drafted, could not come into force.

#### **BC-Hong Kong Economic Relations**

- Hong Kong has a population of 7 million, and GDP of \$427.4 billion. It is the 12<sup>th</sup> largest GDP per capita (PPP) globally. GDP growth is forecasted at 3.0% in 2017.

- Hong Kong investors have a long history of investments in BC's economy, highlighted by Li Ka-Shing's acquisition of the Vancouver Expo site in 1988, and land development of \$2 billion over 20 years.
- Hong Kong is the largest offshore RMB center, and Hong Kong investors purchased over 46% of the BC Government's \$500 million dim-sum bond offering in 2013.
- The Hong Kong-Canada tax treaty, ratified in 2014, creates favourable tax benefits for Hong Kong companies and other Asian investors in North America vis-a-vis Hong Kong's corporate structure.

#### Partnerships BC

Partnerships BC is owned by the Province of British Columbia and governed by a Board of Directors reporting to its sole Shareholder, the Minister of Finance. It is incorporated under the *British Columbia Business Corporations Act*.

Partnerships BC supports the public sector in meeting its infrastructure needs by providing leadership, expertise and consistency in the procurement of complex capital projects by utilizing private sector innovation, services and capital to deliver measureable benefits for taxpayers.

Since 2002, Partnerships BC has participated in 52 projects with a combined capital value of almost \$18 billion in healthcare, accommodation, transportation and energy and utilities.






#### BC Origin Exports to Hong Kong




#### Year-Over-Year % Growth in GDP of Hong Kong






#### BC Origin Exports to Hong Kong




#### Year-Over-Year % Growth in GDP of Hong Kong





**ISSUE(S):** Invitation to a reception and dinner to meet with members of Asia Pacific Foundation Canada's Board of Directors over their shared interests in the evolving Canada-Asia dynamic

#### **BACKGROUND:**

The Asia Pacific Foundation of Canada (APFC) is a not-for-profit organization focused on Canada's relations with Asia. Their mission is to be Canada's catalyst for engagement with Asia and Asia's bridge to Canada. The APFC is well known for its leading research on Asia-Canada relations, including its annual national opinion polls of Canadian attitudes regarding relations with Asia, including Asian foreign investment in Canada and Canada's trade with Asia.

The APFC has worked in partnership with the B.C. government on several projects in the past few years. These include:

- Boosting British Columbia's Exports to Asia a collaborative report between
  the Province and the APFC that provides insights on opportunities and
  challenges with supporting small and medium size enterprises (SMEs) to export
  to Asia. Based on results of the report, Guidebook to Doing Business in Asia
  was developed as a toolkit for SMEs. It provides tips and resources for exporting
  to Asia. Both were released in May 2016.
- Asia Business Literacy Discussion Series as a next step from the Guidebook, the Province and APFC hosted workshops to help B.C. companies gain the knowledge and skills required to export to Asia. To date, four workshops have been held, including in Vancouver, Prince George and Kelowna.
- Asia Pacific Investment Monitor The Ministry provided \$20,000 in financial assistance to the APFC to develop a public web tool to provide more robust information on investment flows between Canada and Asia.
- B.C. Education Curriculum on Asia The APFC and the Ministry of Education partnered to develop new resources to empower B.C. teachers to learn and teach contemporary Asian studies and history. Announced in April 2017, the Ministry of Education is providing \$250,000 in matching funds to the project.

- Asia Business Leaders Advisory Council (ABLAC) ABLAC consists of 28 business and government leaders from a broad range of sectors across the Asia Pacific. ABLAC has been hosted by the APFC to participate in an open and candid dialogue on Asia Pacific relations. In 2016 and 2017, ABLAC was held in Vancouver. The Premier attended the welcoming dinner and the Ministry provided financial assistance. In 2018, ABLAC will be hosted in Toronto.
- India and China Strategies Stewart Beck participated in a roundtable of strategic advisors for the Ministry's India Strategy, as well as provided advice on the Ministry's China Strategy.

#### DISCUSSION:

The Ministry continues to have open dialogue with the APFC on issues and projects of mutual interest. The APFC has suggested the following areas for potential partnership with the Ministry:

- Undertaking research on opportunities in China for clean technology to produce an online map to provide companies with better information on specific opportunities in China;
- 2. An additional Asia Business Literacy Discussion Series workshop on issues around intellectual property and exporting technology.

#### SUGGESTED RESPONSE/KEY MESSAGING:

- Asia remains a priority market for British Columbia to develop partnerships and pursue increased trade and investment.
- JTT looks forward to continuing to work with APFC on joint initiatives to foster greater collaboration with Asia.

**ISSUE(S):** Temporary Foreign Worker Registry

#### **BACKGROUND:**

Minister Bains has arranged to have a meeting with Mr. Mattoo and Mr. Kang from the Kang and Company law firm to discuss temporary foreign workers (TFWs). The focus of the meeting is expected to be the TFW Registry and protections for vulnerable TFWs. Minister Bains' mandate letter includes a commitment to: "create a temporary foreign worker registry to help protect vulnerable workers from exploitation and to track the use of temporary foreign workers in our economy".

Kang and Company is an immigration-focused law firm based in Surrey, with additional offices in Calgary and Montreal. Their services include assisting individuals with a range of immigration needs (including economic immigration, family sponsorship, refugee claims, work and study permits, and citizenship applications) as well as family law, criminal law, personal injury, and real estate. The firm was founded by Mr. Kang in 1992. In 2002 Mr. Kang was appointed as an immigration judge at the Immigration and Refugee Board of Canada. Mr. Mattoo has worked at Kang and Company since 2008. See Appendix A for biographies.

#### DISCUSSION:

The TFW Registry is being led by the Ministry of Labour. Staff from the Ministry of Jobs, Trade, and Technology (JTT) are available to assist Ministry of Labour staff in any way necessary as they research, design, and implement the registry. Preliminary staff discussions have already occurred.

Improving protections for vulnerable TFWs is a high priority at both the federal and provincial level, and staff from both governments have been working closely on exploring possible changes or initiatives that can better protect workers. JTT is generally the lead for interactions with the federal government, with significant

involvement from Ministry of Labour staff. BC staff will ensure that any federal changes coordinate with, but do not duplicate, provincial efforts such as the TFW Registry.

JTT provides \$4 million annually for settlement services for new and potential British Columbians not otherwise eligible for federal services, including TFWs, international students, refugee claimants, and naturalized citizens. Services include information and referral; orientation and community connections; employment supports; formal and informal language training and practice; and trauma counselling for refugee claimants. These services are available across the province through 55 contracted settlement service providers.

In 2016, BC and the federal government worked together to implement a process so that TFWs who are at risk of abuse as a result of an employer not complying with federal or provincial laws can receive a new work permit from the federal government. Provincially-funded service providers can help TFWs in abusive situations file a complaint with the appropriate agency (e.g. Employment Standards Branch) and an application for a new temporary work permit so that they can leave the abusive employment situation.

Through the Open Data website, the federal government has made increasing amounts of data about TFWs publicly available, which provides a sound starting point for tracking the use of TFWs in BC's economy. The available data includes employer name, location, sector, occupation, skill level, and gender. However, personal data about the workers themselves, such as their contact information and when they actually arrive in BC, is not available through federal data collection.

#### SUGGESTED RESPONSE/KEY MESSAGING:

- The Ministry of Jobs, Trade, and Technology will be working closely with the Ministry of Labour as they research, design, and implement the Registry.
- Staff are also working closely with the federal government to ensure that federal
  efforts to reduce the vulnerability of TFWs aligns with the Province's approach.
- In the meantime, the Province continues to provide settlement services to TFWs through the BC Settlement and Integration Services program.

Narindar started the Law Firm of Kang and Company in 1992, after completing his articles with the renowned law firm of Russell and DuMoulin (now Fasken Martineau) in 1991. While engaged in his private law practice, Narindar has served on the Systemic Bias and Multiculturalism Committees of the Law Society of British Columbia, and has been a Member of the International Bar Association and Commonwealth Bar Association.

Narindar was also elected in 2000 by his lawyer colleagues to the National Council of the Canadian Bar Association -British Columbia Branch.

In 2002, Narindar was appointed by the Governor-General in Council as an Immigration Judge at the Immigration and Refugee Board of Canada ("IRB"). In this capacity, Narindar sat at the Immigration Appeal Division, and rendered over 500 decisions on immigration appeals, including on marriage, adoption, medical, and financial refusals by Canadian Immigration authorities, and appeals from deportation orders. While a Judge at the IRB, Narindar, along with his Vancouver colleagues, received the Head of the Public Service Award for 2003. This Award is one of the most prestigious honours that the Government of Canada can bestow. It was given for designing and implementing an ADR (Alternative Dispute Resolution) process for persons appealing to the Immigration Courts.

A litigator and an academic, Narindar has presented various lectures, and delivered papers at the Commonwealth triannual conferences held in Vancouver, B.C. and Kuala Lampur, Malaysia, at the Continuing Legal Education (CLE) courses held for lawyer colleagues in British Columbia, and for the Peoples' Law School.

Narindar is also a former Member of the Tariffs Committee, Legal Services Society of British Columbia, and a former Board Member of the Surrey Delta Immigrant Services Society.

## Federal Government's Consultations

- The Government of Canada conducted public consultations from March 4 to June 2, 2017.
- Input was collected through in-person meetings and teleconferences with Canadian stakeholders, through the publication of a Canada Gazette notice and a dedicated consultation website.
- During the 90-day consultation period federal officials interacted with approximately 600 stakeholders and partners, conducted 70 plenary roundtables and workshops and received 130 submissions from Canadians.
- In general, the public and stakeholder views noted both challenges and opportunties of a Canada-China FTA.
- Canadians said they believe there are significant opportunities for Canadian businesses and consumers (due to the size of market) in China and noted the importance of China for the future of the global economy. Some of the specific

opportunities mentioned include supplying China's demand for high-quality agricultural products and natural resources, government procurement and leveraging China as a source of, and destination for, foreign direct investment.

Challenges mentioned include: an unpredictable and opaque regulatory
environment that lacks transparency and raises costs for Canadian business,
tariffs, permitting issues, establishment requirements, and customs procedures.
Concerns were also raised arising from the nature of China's state-run economy;
the interplay between trade and China's human rights, environmental and labour
rights records; and the inconsistent rule of law in China, especially in relation to
the enforcement of intellectual property rights.

#### **BACKGROUND:**

- The Vancouver Economic Commission (VEC) is an agency of the City of Vancouver with a mandate to strengthen the city's economic future by helping existing businesses, attracting investment, researching the business environment and making policy recommendations.
- The VEC works to position Vancouver as a globally recognised city for innovative, creative and sustainable business by developing strategic programs and initiatives that address each stage of the business growth continuum.
- The VEC has identified key sectors towards which their programs are aimed, including the Technology, Digital Entertainment and Green Economy sectors.
- Specifically, the VEC:
  - Advises business leaders on key growth sectors, Vancouver's investment climate, and living and working in Vancouver;
  - o Connects businesses to talent, capital, and local and international markets; and
  - Celebrates the Vancouver business story by publicizing success stories, staging strategic local and international events, and hosting and leading delegations.

#### **DISCUSSION:**

- In his request for a meeting, Sean Elbe highlighted a number of VEC initiatives relevant to the innovation economy:
  - <u>BC Tech Talent Strategy and Talent Attraction Campaign</u> The VEC has several talent-focused initiatives underway to help meet the current talent needs of Vancouver's knowledge-based companies, develop a local and diverse talent pool for the future, and create a globally-recognized hub for technology and innovation. These include developing the CareerScout job search platform, participating in the B.C. Provincial Nominee Program Tech Pilot, and partnering with other agencies to develop a Technology Talent Strategy for B.C.

- Startup Genome Research Vancouver is rated as Canada's number one startup ecosystem, and ranked 15th in the world, by Startup Genome, a non-profit organization based in San Francisco dedicated to accelerating the economic growth of startup ecosystems worldwide. The VEC is partnering with the BC Tech Association and JTT to continue working with Startup Genome, by providing them with data, connecting them to experts, and through the process understanding where the Vancouver ecosystem's weakness are in order to help address them.
- Vancouver Startup City is a curated ecosystem development and promotion platform which includes the ongoing Discovery Foundation Capital Mentorship Program. In the fall of 2017, during two weeks of curated events, workshops and programs, investors had the opportunity to discover Vancouver's innovative and high-potential startups while sharing best practices.
- Green and Digital Demonstration Program provides access to City of Vancouver resources (i.e. buildings, streets, vehicles, digital infrastructure) for product testing and showcase opportunities, as well as critical follow-on connections and business expansion support from VEC staff.

 There is significant alignment between B.C. Government and VEC goals, and the Province is already actively engaging with the VEC on many of the identified initiatives on a case-by-case basis.

#### **KEY MESSAGING:**

- The B.C. government is committed to ensuring the benefits of technology and innovation are felt around the province, and appreciates the important role municipal governments play in establishing B.C. as a preferred location for new and emerging technologies.
- There is significant overlap between the key sectors on which VEC activities are focused and those supported by the B.C. Government. Provincial initiatives are designed to directly benefit the economic development of these key sectors in Vancouver and across the province.
- The issues and opportunities identified by the VEC are key to supporting and growing the B.C. technology sector as a whole. As such, any additional Provincial investments should be considered through a Province-wide lens, rather than a Vancouver-centric approach.

**ISSUE:** MUJI Vancouver Flagship Retail Store - Pre-Opening Ceremony

#### **BACKGROUND:**

MUJI Canada is launching its BC flagship store in Vancouver (Robson Street) on December 1, 2017. The retail operation will be 14,507 square feet, making it the largest MUJI store outside of Asia. It will carry over 4,500 products, with unique offerings such as MUJI YOURSELF Customization Service (customized MUJI products). BC-based Ethical Bean Coffee is partnering with MUJI for its Coffee Counter.

In August 2017, MUJI established its first BC retail store in Metrotown Mall, Burnaby with Minister Ralston attending the pre-opening. The event received positive coverage by major media outlets. Over 2,000 people lined up on opening day and Mr. Akita advised that sales from the Metrotown opening weekend exceeded the combined sales of all four Toronto stores. In addition to the Metrotown and Robson Street stores, two retail stores are being considered for 2018 - Coquitlam Centre and Richmond Centre.

MUJI has 830 stores in 29 countries with global revenues (2015) totaling over CAD \$3.5 billion. In Japanese, MUJI translates to "no-brand quality goods". The organization is recognized for high-quality, functional products that are reasonably priced. MUJI Canada is headquartered in Toronto and has four stores in the Greater Toronto Area.

JTT and the BC TIR Office in Japan have been working closely with Mr. Toru Akita, President, MUJI Canada to establish its first BC stores. JTT has offered MUJI Canada support and business introductions to potential BC suppliers and service providers as well as local municipalities and economic agencies such as the Vancouver Economic Commission.

#### DISCUSSION:

The Minister's presence at the MUJI Vancouver opening ceremony will provide an opportunity to congratulate MUJI on the launch of its BC flagship store, the largest outside of Asia. MUJI expects 30-50 media outlets will attend the Vancouver opening. MUJI Canada's BC growth plan represents investment and job creation by a leading global retailer. The Vancouver store will employ approximately 180 people. The BC MUJI expansion, according to Mr. Akita, demonstrates strong confidence in the BC economy. The MUJI flagship will be an anchor tenant on Robston Street and contribute to the revitalization of west Robson Street as a downtown shopping core.

Based on existing retail operations, MUJI products will appeal to a wide spectrum of British Columbians and will become a destination for visitors to BC. The MUJI brand attracts loyal international shoppers, and social media has indicated that U.S. shoppers (e.g. Washington State) plan to visit BC as there is no MUJI store in Washington State. The closest U.S. MUJI store is located in San Francisco. MUJI opened a temporary pop-up store in February 2017 at Vancouver's Fairmont Pacific Rim, which proved so popular that reservations were required.

MUJI's mandate for sustainability includes partnering with local suppliers that share its corporate social responsibility vision. Where possible, MUJI is dedicated to local sourcing from BC businesses and hiring local service providers. MUJI's pop-up stores (store-in-store) represent an opportunity for BC companies to introduce their products to a wider group of local and global consumers as well as to enter MUJI's global supply channels. - The 5<sup>th</sup> Vancouver Golden Panda International Film Festival (GPIFF) is an annual film festival held in Vancouver that features international emerging filmmakers from 25 countries and regions and fosters collaborations between international film industries.
- Founded in 2013 by Vancouver-based Orient Start Media Inc., GPIFF is a non-profit organization that has received funding from CreativeBC and the City of Vancouver Cultural Services. Creative BC provided \$2,500 in sponsorship support last year to GPIFF, and committed \$5,000 for this year.
- Matthew Tang is the Executive Director of the Vancouver Golden Panda International Film Festival Committee.
- GPIFF has strong ties to Greater China and has engaged China's dominant film distributor, China Film Co., China's leading cultural investment group, Poly Culture North America, and Alibaba Group's flagship unit, Alibaba Pictures, in the Festival Jury and Industry Forum.
- GPIFF's Red Carpet & Awards is an annual celebration of the arts and will present 14 awards to selected international emerging filmmakers participating in GPIFF.

#### DISCUSSION:

- The event presents an opportunity to promote BC's film and digital entertainment sector and support GPIFF's mission of fostering international collaborations and building a platform to exchange industry insights and experiences.
- BC film and digital entertainment companies primarily export to the US and EU.
   There are, however, opportunities to expand export of film, television and digital entertainment productions and services to the Asia-Pacific and India.
- Hong Kong and mainland Chinese production companies have been leveraging BC's Motion Picture Tax Credits to co-produce with BC companies and employ BC-based talent.
- GPIFF filmmakers and Festival jury members are from the US, Greater China, EU and India where the Province has Trade and Investment Offices to facilitate film and digital entertainment collaborations, exports and investments.
- Mathew Tang, Executive Director, GPIFF confirmed that Poly Culture North America Investment, which is based in Vancouver, is a GPIFF sponsor. The Festival is also trying to establish a partnership with Poly Film.
- Both Poly Film and Poly Culture North America Investment are subsidiaries of the Poly Culture Group. Poly Culture Group has expressed interest in the following three lines of BC business:
  - art auction and management:
  - o cinema and theatre operations; and,
  - film and TV industry investment.
- On August 26, 2017 the Vancouver Sun printed a probing article on Poly Culture's recent BC art venture. The article noted that Minister Ralston outlined in a statement that there would be a review of HQ Vancouver, the publicly funded organization that played a key role in bringing Poly Culture to Vancouver.

**BACKGROUND:** The Champions Table is an initiative resulting from commitments made by the B.C Assembly of First Nations (BCAFN) and the Business Council of British Columbia (BCBC) in their Memorandum of Understanding signed on September 6, 2016. The Champions Table established a dialogue between First Nation and business leaders to explore opportunities, discuss barriers and work jointly to develop and advance a more effective approach to economic development based on reconciliation with First Nations.

The Champions Table is a stand-alone pillar of BCAFN's Economic Development and Fiscal Relations Strategy.

The Champions Table members include eleven First Nation leaders from eight regions across the province, and eleven B.C. business leaders from a range of industries. The Table is scheduled to meet eight times from late June 2017 to November 2018 and work towards the development of policy approaches, pilots and best practices for First Nations and businesses in B.C. This will include the facilitation of 'big ideas' that can accelerate the means to address the social and economic gaps currently faced by First Nations peoples.

The Castlemain Group is acting as the Champions Table Secretariat. Castlemain will provide administrative, research, and policy support as well as aiding in the development of deliverables as directed by the Champions Table.

The Champions Table, in partnership with Vancouver Island University is creating an intensive Indigenous youth internship programme. The recruitment of businesses, and industry and professional associations to host this programme is ongoing.

**DISCUSSION:** Business Council of British Columbia's (BCBC) President and CEO, Greg D'Avignon, has requested a telephone meeting to discuss the Champions Table work plan.

An element of this work plan may include BCAFN's interest to establish an economic development corporation to house an economic development Secretariat. The vision of this Secretariat is to house, coordinate and administer the work currently being undertaken by BCAFN. According to BCAFN's memo to MIRR on May 31, 2017, the Champions Table is designed to eventually comprise the founding Board of Directors of the Secretariat.

On November 2, 2017 at the Terrace BC Nation 2 Nation Forum BCAFN's Chief of Staff Melanie Debassige stated that the Champions Table has now produced a draft policy document that is under review by its Board of Directors. As well, BCAFN's Board of Directors has passed a resolution for the creation of the corporation to house the Secretariat.

#### SUGGESTED RESPONSE/KEY MESSAGING:

 JTT recognises the value of the work being undertaken by BCAFN and BCBC, and believes the Champion's Table and BCAFN's *Economic Sustainability and* Fiscal Relations Strategy's goal of economic reconciliation is important for shared and sustainable prosperity in B.C.

#### Wilf Adam (Chief, Lake Babine)

Chief Adam has been the elected chief of Lake Babine Nation since 2009. Prior to being chief of Lake Babine, Chief Adam was a Commissioner at the BC Treaty Commission for 12 years from 1995 to 2007.



#### Joe Alphonse (Tribal Chair, Tsilhqot'in National Government)

Chief Alphonse is the Tribal Chairman of the Tsilhqot'in National Government and the elected Chief of the Tl'etingox-t'in First Nation.



#### Ian Anderson (President, Kinder Morgan)

lan Anderson is President of Kinder Morgan Canada, a business segment of Kinder Morgan, the largest energy infrastructure company in the United States.

Mr. Anderson's responsibilities include providing executive leadership to Kinder Morgan's operations, growth and corporate responsibility initiatives in Canada. He is leading the company's \$6.8 billion Trans Mountain Expansion Project, which is expected to be completed in 2019.

Mr. Anderson has been with Kinder Morgan and Canadian predecessor companies for more than 38 years. He was named President of Kinder Morgan Canada in 2005.

Chief Bevan has extensive experience in the financial and accounting sector. Having received an education in business administration, accounting an finance, Chief Bevan has worked in various senior finance roles in the private and public sectors for over 25 years.

Chief Bevan does a substantial amount of Board work. He is the Chair of the First Nations Finance Authority, Chairs the First Nations Major Projects Coalition and sits on the board of the First Nations LNG Alliance. Chief Bevan is actively working to bring economic opportunities to Kitselas while at the same time maintaining a respect for the environment.



#### Richard Blanchet (Senior Vice President, Western Canada, Innergex)

Richard Blanchet joined Innergex in 2001 as Vice President –
Development and was appointed Senior Vice President – Western
Region in 2011. Since February 2015, he holds the position of Senior
Vice President – Development, Western Canada and Latin America. Mr.
Blanchet is responsible for the Company's development in Western

He is the youngest of the sixteen hereditary Chiefs of the Squamish Nation, and he is a descendant of the Squamish and Musqueam First Nations of the Coast Salish People. Xalek grew up speaking the Squamish language and his grandfather taught him to hunt and to respect nature. His passion in life, singing, has taken him around the world, representing his people in several singing groups. He strongly believes in sharing the spiritual and cultural values of the Coast Salish people to help educate others, bridge the gap between cultures, and promote closer relations. His goal is to maintain a healthy lifestyle and restore the legacy that his ancestors have left for him. He is grateful to his elders and family for giving him strength, guidance, and discipline.



#### Harley Chingee (Board Member, First Nations Forestry Council)

Harley Chingee is a member and former Chief of the McLeod Lake Indian Band with over 20 years experience in First Nation administration and business management. Currently working as a resource consultant, Mr. Chingee brings a wealth of forest sector policy experience to the First Nations Forestry Council. In the 80's, as a logging contractor, he was instrumental in the creation of Duz Cho Logging Ltd. Owned by the McLeod Lake Indian Band; the company has utilized profits to support legal action defending their rights in their territory. As a negotiator, Mr. Chingee has experience working at all levels of government, and has concluded several public/private resource development partnerships between First Nations, government and industry groups. Mr. Chingee is committed to increasing First Nations access to and involvement in the forest sector.



#### Cynthia Dick (Chief Councillor, Tseshaht First Nation)

Pukłaamaḥ Cynthia Dick. cišaa?aqsup. I was appointed the Chief Councillor of the Tseshaht First Nation in May 2016. Tseshaht is one of the fourteen Nuu-chah-nulth Nations located on Vancouver Island. I graduated from Vancouver Island University with a Bachelor of Arts; Major in Sociology and Minor in Psychology. I have been very active in my community for as long as I can remember. I have experience working with my Nation, the Nuu-chah-nulth Tribal Council and sitting on various committees.

I am very honoured to be the Vancouver Island-Coast representative for the BCAFN Economic Development Champions Roundtable. The partnership between BCAFN and BCBC provides us with the opportunity to take a step towards reconciliation in a meaningful way. It also provides us with an opportunity to continue the work towards creating self-sufficient and self-governing Nations. Together we can create a strong foundation for our next generations to continue the work of building strong, healthy and prosperous communities.



## Byng Giraud (Vice President, Corporate Affairs and Country Manger, Woodfibre LNG)

Byng Giraud joined Woodfibre Natural Gas Limited (part of the Pacific Oil & Gas group) in April 2013 as the company's first North American employee.

Immediately prior he was with Imperial Metals, a Canadian copper/gold mining company. Byng is responsible for corporate affairs including regulatory affairs, government relations, community relations, aboriginal affairs and communications. He is also currently Chairman of Ridley Terminals Inc. a Canadian government owned coal export terminal in Prince Rupert, BC.

In the past he has served as a Vice-President with both the Association for Mineral Exploration BC and the Mining Association of BC. Prior to that Byng served as a senior consultant with a number of top Canadian public affairs agencies.

Byng has extensive political experience at the national, provincial and municipal level, serving in senior advisory roles to provincial MLAs, federal MPs, Senators and with BC Ministers. He has managed or participated in over twenty federal, provincial and local elections across Canada. He has served as a director and Vice-President, Western Canada on the governing council of the Conservative Party of Canada with Prime Minister Stephen Harper.

BC Hydro is currently investing in an unprecedented capital program of refurbishment and expansion of its electricity assets, spending approximately \$2 billion over the next 20 years, including the development of the \$8.3 billion Site C hydropower project.

As part of a new focus on customer service and employee engagement, Jessica led a brand, vision and values refresh at BC Hydro resulting in the company being named #1 most influential brand in BC in 2016, with the company also being named Canada's #1 employer in 2016.

Prior experience includes commercial mediation and negotiation on major infrastructure and industrial projects in BC, Deputy Minister in the BC government for 6 years as well as many other posts in the government under numerous administrations beginning in 1991. #### Nathan Mathew (Chief, Simpcw First Nation)

Nathan was raised in the Simpcw First Nation community by his parents Louie and Ida Matthew, and is the second oldest in a family of six children. He attended Barriere's elementary and secondary schools then went on to graduate from the University of British Columbia with a Bachelor of Recreation Education. He later obtained a Professional Teachers Certificate and a Masters Degree in Education. Nathan has worked as a recreation coordinator, administrator of the Kamloops Residential School, principal of the Sxoxomic school at Esket, a band planner, and the Executive Director of Aboriginal Education at Thompson Rivers University. Nathan also worked as a community development and education consultant throughout the province. He sat on the Assembly of First Nation Chiefs Committee on Education for several years and was active in the development of provincial First Nations educational organizations and programs. He currently chairs the School District 73 First Nations Education Council.

From the period 1976 to 2006 Nathan spent 20 years on the Simpcw Council, eighteen as chief. During this time he was active in community development including: Neqweyqwelsten School, Chu Chua Agriculture Corporation, Simpcw Development sawmill and forest licence activities, and community planning. He was the chairperson of the Shuswap Tribal Council for two terms.

Aside from educational pursuits, Nathan also currently serves as the Rights and Titles Coordinator. He is also very involved with Simpcw's growing community. He helped to develop the Secwepemc Fisheries Commission and the Secwepemc Cultural Education Society, and has facilitated many workshops specializing in strategic planning and goal setting. He also meets with other band councils and government officials in order to preserve and protect Simpcw's land and resources for future generations.



Rick McLean (Chief, Tahltan Band)

Chief McLean was elected as chief of the Tahltan Band in June 2016.



#### Ralph Nilson (President, Vancouver Island University)

Dr. Nilson holds and a B.A. from Simon Fraser University, a M.Sc. from Southern Connecticut University and a Ph.D. from the University of Oregon.

He has extensive teaching and administrative experience at undergraduate and graduate levels in Universities across Canada and the United States and developed an active research program in physical activity, population health and community development. He advocates for excellence in teaching and scholarship.

He has been actively engaged in working with communities and recognizes the important role of the university in the economic and social prosperity of the region it serves.

He received his college diploma in Business Management in 2007 and was elected Chief of McLeod Lake Indian Band in 2008. Derek has achieved successful re-elections in both 2011 and 2014.

Since 2008, the McLeod Lake Indian Band has been able to eliminate \$18 million dollars of debt. Now, the McLeod Lake Indian Band's Chief and Council has strategically positioned the Band to take advantage of the many opportunities within our Traditional Territory and also to develop and build community projects that will benefit all Members of the McLeod Lake Indian Band.

In July 2014, the McLeod Lake Indian Band developed, constructed and opened Tse'khene Food and Fuel, a community gas station, which assists in serving the needs of McLeod Lake and its' surrounding communities.

In addition, McLeod Lake Indian Band is very proud to announce the construction, operation and sole ownership of Duz Cho Forest Products, a cant mill that will utilize waste wood which normally would not have been used.

Duz Cho Logging, also owned by McLeod Lake Indian Band was awarded the FPAC/AFN Aboriginal Forest Products Business Leadership Award in 2012 recognizing outstanding business leadership and community involvement in the forest products industry.



#### Nathan Parenteau (Chief, Saulteau First Nations)

Chief Parenteau has been the elected chief of Saulteau First Nations since 2014.



#### Bob Redden (Founder and President, EDI)

Bob is a Registered Professional Biologist and the President of EDI Environmental Dynamics Inc. (EDI) a consulting firm that provides environmental management as well as aquatic and terrestrial biological services to all major natural resource sectors across Canada.

Founded in Prince George in 1994, EDI has expanded to seven office locations in BC, Alberta, Saskatchewan and Yukon and now conducts hundreds of projects annually throughout Western Canada and the Arctic. #### Tamara Vrooman (CEO, Vancity)

Under Tamara's leadership, Vancity has gained international recognition for its values-based banking model. Vancity was the first Canadian financial institution invited to join the Global Alliance for Banking on Values, an independent network of the world's leading sustainable banks and banking cooperatives. In 2014, Pope Francis asked Tamara to participate in a Vatican Summit entitled *The Global Common Good: Towards a More Inclusive Economy* with 70 leaders from around the world. Tamara also spoke about Vancity's model with the Dalai Lama at the 2014 *Heart-Mind Summit* in Vancouver.
