and maybe choose some terrific Alberta craft beer instead. This is one good step to waking BC up to the fact they can't attack our industry without a response from us. Now of course, this action will harm the BC wine industry. And I honestly wish it didn't have to be this way. Good trade relationships built on rules are critical to a functioning economy. And the fact of the matter is that Alberta has always been the most likely to follow these rules and play by these rules of any province in the country so we don't take this lightly. But let me be clear: Albertans didn't want or invite this fight. Alberta will not stand by and be the only province impacted by another province's refusal to play by the rules.

In Alberta, we play by the rules and we did play by the rules and we secured the approval of a new pipeline to tidewater to export energy products that support tens of thousands of jobs across the country. We did so by working with industry, with workers and the community to protect the environment in this province and across the country in an unprecedented way. We did play by the rules. It was and is an historic achievement for our province and for our country. And we will not let the Government of BC hold Alberta's and Canada's economy hostage and jeopardize the economic security of hundreds of thousands of working families across this province and across this country. In Alberta we don't back down. This is our economy. These are our jobs. It's also our country.

And Albertans' rights - and Canadian's rights -- must be respected. So I'm happy to take your questions.

Reporter: You mentioned this idea that you played by the rules and they didn't but does two wrongs make a right because this I think will abrogate the [inaudible] agreement, right?.

Notley: Our province has always been one that promotes the free trade of goods and that promotes it as a leader across the country and promotes the growth of that ability.

Reporter: I think [inaudible] the New West Agreement, right?

Notley: You know, we, our province has always been one that promotes the free trade of goods and that promotes it as a leader across the country and promotes the growth of that ability. And it's because we know that that makes Canada stronger as an economic unit. So we know that when that free trade of goods is impeded it doesn't help Canada to function as an economic unit, we get that. But the reality is that for too long Alberta has been the province that suffers the consequences when other provinces don't do that. And we are just getting through the end of a recession. We are just trying to recover. We are working our way towards a recovery. We are not there yet. We cannot have a situation where we have a, we sell our product for almost half of what it would otherwise be able to secure on the market. That just can't be. And having another province suggest that they can pass regulations that so fundamentally go against what we know to be the law, in an effort to harass investors and to harass a project that is otherwise lawful, is just not a way to run the country. So I don't like it. And you are right, it does, it's not the best solution for Canada.

Which is why of course what we would prefer to see is B.C. to back down and the federal government to come in strong and articulate that they will not allow this purported ability of the government of B.C. to pass these laws to stand. Kim?

Reporter: I was wondering what makes you think this will have such an impact on changing, or getting the B.C. government to back down, because even on some large industries, when you've got wine, up against oil, it's almost laughable.

Notley: Well, you know, I don't know that it is. I don't think the people that work in interior B.C. in the wine industry would suggest that their industry is laughable. And I know that's not what you meant, but I think that we need to make the point. This is one where the vast majority of that industry is one

where they sell into Alberta. And so it will have an impact on them and that is the point that we are trying to have an impact on them. And it's one where Albertans have already indicated a pretty strong willingness to participate in that anyway. So that's the point that we are making and it's not the only point. We have other measures that we are looking at, but this is the first one.

Reporter: Have you communicated that to the Premier Horgan, or the B.C. wine industry at all?

Notley: No, that's what we are doing right now. There is also I believe, a byelection in Kelowna right now.

Reporter: You had mentioned before this is a fight you said between B.C. and the rest of Canada, but by escalating the trade war, it becomes really the fight between Alberta and B.C. --

Notley: I don't think it does, because I think what this does is Alberta, as I've said, has led the country in terms of this promotion of free trade of goods throughout and across our country and we have led the country in terms of economic growth in a number of different fronts. And I think by sending this message it has implications across the country because what we are doing is this whole effort to consolidate the trade between provinces in our country and to ensure that we operate more effectively as an economic unit. This puts a point on the fact that you can't pull one string, like B.C. is purporting to do, without the whole sweater, as I've said before, starting to unravel. And the message is not just to B.C., it's to Canada.

Reporter: Is there a risk that this could galvanize anti-Alberta sentiments in this area, in the Okanagan, or do you hope that it [inaudible] that they would want to be on side?

Notley: We certainly hope not, because you know, we are going to be reviewing this moratorium on these purchases on a regular basis as we evaluate the response from the federal government and from the provincial government. We hope that this doesn't have to stay in place for very long. As I've said, Albertans like BC, Albertans like BC wine. This is not a stage of play that we want to have in place for a long time. I think that it's also fair to say that people in interior B.C. probably have a better understanding than many, about the critical role that Alberta's resource industry plays in their local economies, in the interior of B.C., whether it's by way of Alberta tourists coming through, or whether it's by way of resource workers who work in our oil and gas sector, but live and pay taxes in interior parts of B.C. and rural parts of B.C., so I actually think that there's a lot of places where those communities fully understand the import of our energy industry and how the industry is suffering right now as a result of our inability to get our product to market in an efficient and effective way.

Reporter: You mentioned the by-election of the premier of Kelowna, do you think that this wine boycott is having an effect on the outcome of that election?

Notley: Well I don't know, I'm not sure who expected to win what in that by-election, but I suspect it will be a matter of discussion.

Reporter: [inaudible] after the newest trade agreement as Saskatchewan was facing when they had the license plate brouhaha, are you prepared to stomach five million dollars' worth of fines for Albertans then?

Notley: The cost of not going ahead with the Kinder Morgan pipeline is roughly a billion and a half dollars a year, just to the Alberta treasury, so yep.

Reporter: Premier, this has never been your style, you've been quiet diplomacy. Remember when Quebec [inaudible], there's no point to picking fights with people, yet here we are, we're pretty much

down and as you say, we're two weeks to go and we're fighting for the U.S. trade agreement and now we're violating U.S. sanction. Is your fight with Ottawa, I mean, is that, how do you feel about the fact that your style of leadership isn't working in Canada and make a pig's breakfast of it all to make Ottawa do something about it?

Notley: Well you know, I think at the end of the day you use diplomacy as effectively as you can at every opportunity that you can and I think that we shouldn't forget that that strategy has gotten us a long way here. We have a federal government approval of a pipeline to tidewater that is well underway and I was quite comfortable, and I think the people of Alberta were quite comfortable to play by the rules to enable, or to support even, B.C.'s registration of their concern about that approval through the appropriate mechanisms using the appropriate vehicle. What happened last week is they threatened to do something which was illegal and they did so with the clear understanding, in my view, that they knew it was illegal and with the clear understanding that what they are trying to do was send a message to investors and to harass the project. And that is a different thing that we have moved outside of what are the constitutional division of powers in this country. We have moved outside of a respect of rule of law and we have moved outside of a respect for past practice and the way things are done in mature political arrangements, and in so doing it unfortunately attracts a different response.

Reporter: Does Justin Trudeau need to do his job?

Notley: There is no question that as we've said all along that we need the Prime Minister to step up in a very focused way to make it very clear that under no circumstances will the province of British Columbia be allowed to pass regulations which govern what goes into a pipeline and this is what we have said all along and I've said this before and I'll say it again I had a great deal of appreciation for how the Prime Minister addressed the crowds in Nanaimo on that issue. He was pressured and he made it very clear that Kinder Morgan is going to go forward. However, that does not deal with the fact that the province of British Columbia is threatening right now to go outside the rule of law with respect to and try to pass laws which fly in the face of our constitutional arrangement and that in my view is something we need to see and hear from the Prime Minister.

Reporter: Last week your first retaliatory measure was to end the intertie talks between Alberta and BC now there's a report in the Globe and Mail that suggests those talks already ended.

Notley: No, that's inaccurate. With the greatest of respect to the BC Ministry of Energy, who is also a friend, that information that she had was incorrect. The fact of the matter is the political conversations between political folks had essentially been delayed or stopped as a result of the ongoing conversations around Kinder Morgan but in fact government officials particularly through AESO had been having technical conversations to sort of engage in the work that needed to be done in advance to facilitate a potential expansion so that work was actually going on. That last meeting was on January 15th of 2008 or 18 and in fact those meetings were underway and those conversations were happening and those are the ones that we indicated last week would be suspended as well.

Reporter: Premier I've just got a couple questions as part of my continuing policy of getting as many questions in as Graham. I take it that you've ruled out any action via the Kinder Morgan Pipeline, through the Kinder Morgan Pipeline in the sense that you might slow the taps down, because that would violate your criterion of hurting Alberta business. There's a lot of talk today about that because of an article in our papers. Is that true that you've ruled that out? Next question would be on what condition will we hear new measures? I understand you've talked about new measures. Will it depend on BC's response? If BC drops their thing you'll drop this, presumably. But is it going to depend on BC's reaction whether we get more of this, or are we going to have a stage rollout of more measures?

Notley: So part of a stage rollout of more measures is not talking about all those same measures on the same day. So we do have other measures that we have in mind that we are working on right now, and we will move forward with them as we see how this matter unfolds. And there are two ways in which we can find resolution on this. One, the BC government can drop the fifth plank of the five planks that they rolled out last week. Or conversely, the Government of Canada can make it very clear that they have every intention to combat that fifth plank should it happen, should the BC government move ahead.

Reporter: Well the federal government is always and forever saying that this will go ahead, but what do you need from the federal government? Do you need a special cabinet from Ottawa giving a timeline, a firm timeline, to get it going and shove everything else off the table? I'm just not exactly clear what you expect. I mean, I presume if you heat up the battle between Alberta and BC to such a point that Ottawa is going to get alarmed that they might take some action, but what exactly do you need? You've got the words, what do you need?

Notley: The Government of Canada has a number of different tools that it can use to stop the Government of BC from threatening the investors with an unconstitutional and illegal law. And I'm not going to walk through their tools for them, but I know that they have them. And thus far they have not spoken specifically to the fact that the BC government has threatened an unconstitutional and illegal law. And so right there we know that they need to do more. As far as next steps, as I say, we are working every day on more that we can do to stand up for Albertans, to stand up for Albertan jobs, to stand up for the Alberta economy, and to quite frankly stand up for the Canadian economy, because I've been talking to people over the last two or three days from across this country, leaders from across this country, who see this dispute for what it is which is a significant threat to the integrity of the national economy as our country is perceived internationally by the investors we need to attract. We simply have to get past this stuff, and we need the federal government to demonstrate a willingness to get there.

Reporter: Hi, Premier. Two Questions. First off, can you tell me what kind of device you received from your officials in terms of whether this breaks the Canada Free Trade Agreement between provinces as well as the New West Partnership? What did they say on that front?

Notley: Well you know, I think for the time being we're going to reserve our right to talk with officials in confidence, but what we do know is that roughly 70 million dollars a year flows to BC vineyards from Alberta purchases. And we also know that many Albertans expressed their desire to engage in some kind of their own communication to BC about this particular action on the part of the BC government. So certainly we know that the AGLC has the authority to lift and not lift certain products, and for the moment that's what's going on with respect to BC wines.

Reporter: Just to follow up, I want to talk about the proportionality of response. You said this is going to be about 70 million dollars in wine that, presumably over the course of a year, would not be ordered. You're also saying that the costs for not proceeding with this pipeline are about 1.5 billion dollars a year. I guess I'm wondering are you looking for a dollar for dollar retaliation against the province of BC here as you escalate to these measures?

Notley: Well I mean, we're not quite to that point yet. I mean obviously that's of course the cost that, that's the benefit to Alberta once the pipeline is up and running fully. You know, rough estimates there. So what we're saying is that it's very, very, very important so when it comes to fines that might be payable, we have to consider those in those larger terms. But that being said, you know we're not obviously going to escalate to a 1.5 billion dollar consequence, but what we are trying to do is make the point that Alberta is just tired of being the province that is constantly the unattended consequence of other province's opportunistic decisions to flout the law. And in particular in BC's case, it is a

particularly flagrant, and opportunist decision. One that absolutely rejects the rule of law, and we just can't make transnational, cross-country economic decisions and flagrantly reject the rule of law. We just can't operate that way.

Reporter: Hi, Premier. Switching gears a little to a cryptocurrency mining. Big Players here like Bitfury are already eyeing Quebec with cheap and clean power which threatens to attract miners away from this province, despite its natural advantage. Is the government doing anything to help these companies to ensure that they stay in Alberta?

Notley: I think we'll have to get someone to follow up with you on that question, because I wasn't quite sure. Sorry, I'm going to have to get back to you on that. I'm sorry, but we will definitely get someone to follow up with you.

Reporter: Good afternoon, Premier. Could you tell us where you're at with the possibility of launching a court challenge? And how successful are you in getting the federal government to actually come onboard and do something, perhaps in concert with you on this file? I mean, would you be looking at that in terms of the court challenge, them maybe launching the court challenge as well? I mean, so where are we at with the court challenge? And number two, where are you at with convincing the federal government to do more than just repeating the same sentence over and over again, that the pipeline will get built?

Notley: Well, on the matter of the court challenge, we are getting updated legal advice every day, and you will hear more from us pretty quickly on that. There's no question that we have opportunities to engage in a court challenge, and expect to do that notwithstanding that we're dealing with a threat versus an actually implemented regulation. So we have every intention of going forward with that and we'll be happy to talk about that when we get to that point which should be pretty quick. As far as the federal government goes, as I've said, there's a number of ways in which the federal government can assert its authority here and make clear the way this matter needs to be addressed going forward. Certainly participating in a court challenge is one of those ways, it's not the only way, but it is one. And obviously as you know, I've been quite open publicly about calling on the federal government to step on this one and I'm going to continue to do that.

Reporter: But is the federal government telling you that they are prepared to actually do something. Are you still at the stage of trying to convince the federal government that they actually have to do something?

Notley: I would say at this point the federal government is saying they are looking into, they are considering their legal options is what we've heard, and so the answer to your question is that I don't know yet.

Reporter: I'm looking at the issue of escalating this trade war. There is obviously the problem of unintended consequences. Are you afraid of BC, British Columbia's restaurants boycotting Alberta beef, for example or other Alberta products?

Notley: I think there is no question that escalation is always a possibility and you know I think just as things that we do run the risk of hurting our business which makes it very, you know, it's a very careful thing you have to do to figure out when you do one of these things what consequences happen domestically when you do it and I think that's the same kind of consideration that the BC government would have to go through. I don't know that they have the same ability to legislate boycotting of Alberta beef with liquor distribution. Liquor distribution is something that is, you know, statutorily in the purview of government to do in terms of what's in and what's out. I mean, we've long since had a practice of deciding each and every product that's in and each and every product that's

out and the same as the case for BC for stuff that goes into them. It's a different model with respect to Alberta beef.

Reporter: How about Alberta beef? You're big on getting our breweries up.

Notley: Well, quite honestly, that's a whole other area, another opportunity for us because right now Alberta imports a heck of a lot of beer from BC and it would not actually be a bad thing for Alberta should more Alberta beer be drunk so that is a thing that we're also looking at right now

Reporter: How many weeks of stock does the warehouse have left? When is Alberta going to run out? How long can this go on before we have nothing in storage?

Notley: I'm not exactly sure what their inventory is. There is no question we do have an inventory at the AGLC already but I'm pairing today's announcement with a call to Albertans to in the meantime think about where they order their wine from, whether they be restaurants as the lovely lady in Fort McMurray demonstrated or whether they be people going shopping, you know, this afternoon to buy wine for this weekend. I think that there is a number of different tools that we have at our disposal and this is one of them.

Reporter: You're not going to pull wine off the shelves, though.

Notley: Well, we don't own the shelves so I think that would be a little scary to people if we did that.

Reporter: If a liquor store was to order from the warehouse they would still get it shipped to them, right. If there was reserve stock left over in the central warehouse.

Notley: The AGLC will tell us how much reserve stock is there so I certainly don't want to be speaking out of turn. I suspect that probably if I were a small retailer I wouldn't be looking to order that stock right now because I'm pretty sure that Albertans are not going to be quite as keen to buy BC wine as they might have been a couple of weeks ago.

Notley says Alberta currently imports about 17 million bottles of wine worth \$70 million annually from B.C. wineries.

So I'll leave that to hang there, and I'm sure there will be some questions on that, but I want to reinforce, I will not be distracted from the task of working to make this government effective for all BCers.

Reporter: In terms of Rachel Notley's comments, she's accusing you, your government, of breaking the rules. Those are her words. Breaking the rules as they were set out in the constitution. What's your response?

Horgan: Well, I just disagree with her. We are currently in court with respect to the Kinder Morgan process, the pipeline, and until we get a resolution from the federal court, that is an open question. When it comes to our rights, my rights as the Premier, George's right as the Minister of Environment, to consult with BCers about putting in place protections for our environment and our economy, I see no ground for the Premier to stand on.

Reporter: And will you take any retaliatory action against the Alberta government for them banning BC wine?

Horgan: No, I have no intention of responding each day to events in other jurisdictions. I will say that I have been, our office has been in touch with the wine institute and other suppliers as well as Lana Popham, Minister of Agriculture, is reaching out to growers across the Okanagan. We stand with our wine industry. It is a quality product, and I know anecdotally that other provinces are emptying their shelves of BC wines so that there will be more to export to Ontario, Quebec, and other jurisdictions.

Reporter: Ms Notley said today she took this action against BC wine so [inaudible]. So what role does our wine have in this dispute?

Horgan: Well I think just the comment, and again I didn't hear the Premier say that, but if it is as you suggest, for a leader of a government to go to another jurisdiction to take action against a third jurisdiction strikes me as provocative. I would suggest issuing a press release, talking about our intention to consult with BCers, is not provocative. It's not starting anything. And the Premier of Alberta has taken a course, but I'm not going to be distracted by that. I'm going to focus on the things that matter to BCers.

Reporter: Ian Anderson, the head of Kinder Morgan Canada, said he wrote you a letter saying [inaudible]. Do you owe him a meeting to discuss your plans?

Horgan: Mr Anderson has had access to government officials since the government was sworn in. I've seen him at a number of events that I have attended. The Business Council, among others. He has met with officials in my office. We're in court right now, and I don't see a useful or productive meeting with Mr Anderson until we have resolution in that regard.

Reporter: Premier Notley is saying that after the events of the past couple of days, there could be further actions. How concerned are you by those comments, and how long can this go on before someone has to blink?

Horgan: Certainly I would hope that we've seen the end of the back-and-forth. I deliberately wasn't available to you yesterday, because I don't believe it's in anyone's interest to have duelling premiers. It's well known that Premier Notley and I have been friends in the past. It's well known that we share the same political flag. And that may be interesting to political observers, but at the end of the day, that's secondary to my obligations to the people of BC. And that's my ultimate

Reporter: In the statement you did put out yesterday, you said that if Notley disagrees with what the BC government is doing, she should go to court, and that's the place to do it. I will remind you last week, you told us that there was nothing to take to court, and there wouldn't be anything for a year. So she's facing re-election, you're saying she should just sit on this for a year and not take action?

Horgan: No, I'm not saying that at all. I'm saying that when we have an intentions paper, which we expect to have by the end of the month, that will outline what we propose to do, then the Premier will have something to talk about. But at this point, all we've done is announce our intention to consult with BCers. And I don't recall saying it would take a year. I think someone else might have said that.

I said our intentions paper process normally takes a number of months, that we would hope to have the consultation completed by the end of 2018 or early 2019. But the point that I was making is that we take a number of months to do a thorough and robust consultation, not only with First Nations, but stakeholders, industry, and the people of BC, and that's what we do with all regulations in the Ministry of Environment.

Reporter: [inaudible] And the buildings that were sold off by the Liberal government, and they were sold for below market value. Are changes being made to ensure that this doesn't happen again?

Horgan: Well, you'll recall when the BC Liberals were divesting BCers of public assets to balance their budgets, we spoke very aggressively against that. There were very vivid examples of large parcels of land being sold for less than appraised value, certainly less than assessed value. We want to make sure that that doesn't happen again, but I have to say at the outset, it's

not our intention to sell public assets at this point in time, but we will certainly strengthen whatever rules are in place to protect the public interest.

Reporter: So you mentioned you spoke to Premier Notley. Will you explain to us what was part of that conversation, and did you ask her to stop the retaliation?

We are acting, I believe, as a responsible government, protecting the interests of our citizens. And it's as simple as that.

They're very concerned about this. So you mentioned that BC wine shelves are getting cleared out. They're feeling [inaudible]. What would you say to them?

We're in court, making that case. And we're taking an additional step to ensure that we have regulatory protections in place, should there be a catastrophic spill, that we're in a position to protect the public interest. That's not a war, in my opinion. That's good government. And that's the difference between my perspective and the perspective of the government of Alberta at this time.

Now with respect to escalation, that again is entirely in the hands of Premier Notley, not me. I'm not responding in any way other than saying I will defend our wine industry. I've made that clear to proponents here, and I make that clear to all BCers. That's my job. I'm here for BC, not for Alberta.

Reporter: With all due respect, comments in a Kelowna newspaper attributed to Lana Popham...

Horgan: Again, I think that's an unfair characterization of what Lana was doing in Kelowna, and it happened to be a question that was asked of her, and she has the same concern I do, your viewers do, and all BCers do, that you enter into trade relationships with your partners in confederation and they choose to disregard them, I think that's quite a bit different than disagreeing on industrial projects.

Reporter: Yesterday three ministers met with the senate and announced that the deadline for legalization of cannabis will likely come a number of weeks later than previously announced. What does BC make of this? You signalled yesterday that BC would be later this summer, that people would first be able to buy cannabis. Are you happy with this delay, and what will it mean for BC?

ISSUE: Government of Alberta's boycott of the purchase of BC Wines by the Alberta Gaming and Liquor Control Board

BACKGROUND:

On February 6, 2018 Alberta Premier Rachel Notley announced its intent to implement measures to boycott BC wines including the immediate halt of imports by the Alberta Gaming and Liquor Commission (AGLC) and stepped up enforcement of Direct to Consumer sales (Alberta wine boycott). These measures were in response to its opposition to BC's request for further review of the Kinder Morgan Trans Mountain pipeline expansion project (Trans Mountain project), Alberta has not released, to date, written or specific details on the Alberta wine boycott measures.

In response, Premier Horgan issued a statement on February 6, 2018 stating BC's support for its wine producers and the intent to respond to the Alberta's "unfair trade actions". In an interview on February 7, Premier Horgan further stated that BC will not seek retaliatory action but reiterated BC's intent to defend the BC wine industry.

In 2017 BC was estimated to export about 17.2 million bottles or over 1.4 million cases worth an estimated \$70 million in wine to Alberta.

BC and Alberta are parties to both the New West Partnership Trade Agreement (NWPTA) and the Canadian Free Trade Agreement (CFTA) which include specific trade obligations and dispute settlement provisions.

The BC Wine Institute (BCWI) met with the Minister of Agriculture, the Honourable Lana Popham on February 6, 2018 and with representatives of the Ministry of Jobs, Trade and Technology and Liquor Control and Licensing Branch of the Ministry of Attorney General on February 7, 2018.

ISSUE: Government of Alberta's boycott of the purchase of BC Wines by the Alberta Gaming and Liquor Control Board

BACKGROUND:

On February 6, 2018 Alberta Premier Rachel Notley announced that the Government of Alberta (Alberta) was immediately implementing measures to boycott British Columbia (BC) wines including the halt of imports by the Alberta Gaming and Liquor Commission (AGLC); and stepped up enforcement of Direct to Consumer sales. These measures were in response to its opposition to BC's January 30th, 2018, announcement that BC was proposing a second phase of consultations and regulations to improve preparedness, response and recovery from potential spills (i.e., Kinder Morgan Trans Mountain pipeline expansion project).

In response, Premier Horgan issued a statement on February 6, 2018 stating BC's support for its wine producers and the intent to respond to the Alberta's "unfair trade actions". In an interview on February 7, 2018, Premier Horgan further stated that BC would not seek retaliatory action but reiterated BC's intent to defend the BC wine industry.

In 2017, BC exported an estimated 17.2 million bottles or over 1.4 million cases of wine worth an estimated \$70 million (wholesale) to Alberta.

BC and Alberta are parties to both the New West Partnership Trade Agreement (NWPTA) and the Canadian Free Trade Agreement (CFTA) which include specific trade obligations and dispute settlement provisions.

The BC Wine Institute (BCWI) met with the Minister of Agriculture, the Honourable Lana Popham on February 6, 2018 and with representatives of the Ministry of Jobs, Trade and Technology and the Liquor Control and Licensing Branch of the Ministry of Attorney General on February 7, 2018.

The Parties that actually participate in the Panel proceedings have access to written submissions, etc. prior to the oral hearing. Other Parties and the public have access no later than the start of the oral hearing. There are certain provisions to protect confidential or competitive information.

4. What is the difference in "rights" bw Complaining Parties and Intervenors at panel stage?

Tighter timelines - Intervenors have only 21 days to file their written submissions after the Party that requested the Panel has filed its initial submission; whereas the responding Party has 45 days. There are other things that are at the discretion of the Panel – I seem to recall cases of Intervenors getting less time for oral arguments and being denied the opportunity to file supplementary written submissions. Intervenors also cannot appeal Panel reports.

5. Who are BC's current panellists?

BC has not yet appointed panellists to the CFTA roster. BC can choose a panellist appointed to the roster by another CFTA Party.

6. If an Appeals panel is requested, must the request be granted?

Yes.

7. What is the "specified period of time" that the Complaining Party can request a Compliance Panel?

If and when a Panel finds in its report that the measure violates the Agreement, it will stipulate a time period (e.g. six months) for the Party to do what is necessary to make those measures compliant. A Complaining Party may request a Compliance Panel either one year following that Panel report, or alternatively, following the time period otherwise stipulated by the Panel (six months in our example).

The government of British Columbia has today, **February 19, 2018**, notified the Secretariat that it is requesting consultations under the Canadian Free Trade Agreement, specifically under Article 1003 (Consultations), with the Government of Alberta in regards to measures restricting the trade of wine (see attached).

In accordance with Article 1003.4 "A Party that considers itself to have a substantial interest in the matter, within the meaning of Article 1004.11, may participate in the consultations by delivering written notice of its intention to participate to the other Parties and to the Secretariat within 10 days of the delivery by the Initiating Party to the Replying Party of a request made under paragraph 1." By the Secretariat's calculation if a Party wishes to participate in the consultations they must notify the Secretariat and all other Parties by no later than **March 1, 2018**.

Also, in accordance with Article 1004.2 "A request to establish a Panel may not be made sooner than 120 days after the Initiating Party delivered a request for consultations to the Replying Party under Article 1003.1, but shall be made no later than three years after delivery of the request for consultations." By the Secretariat's calculation a panel could be initiated by either the initiating or replying party no sooner than **June 19, 2018** and not later than **February 19, 2021**.

Thank you, this will be the first dispute process under the CFTA.

Pursuant to Article 1003 (Consultations) of the *Canadian Free Trade Agreement* (the “CFTA”), I am writing to inform you that the Government of British Columbia is hereby requesting consultations with the Government of Alberta regarding certain measures that act to restrict of the sale of British Columbia wine in Alberta. In British Columbia’s view these measures are inconsistent with Alberta’s obligations under the CFTA.

1. Measures Subject to Consultation

The measures at issue here are the Government of Alberta’s direction to the Alberta Gaming and Liquor Commission (the “AGLC”) to put a halt to the import of British Columbia wine into Alberta and the AGLC’s implementation of that direction (collectively, the “Measures”). In the course of consultations additional non-compliant measures may become apparent and British Columbia reserves the right to add any such additional measures to its complaint.

2. Applicable Provisions of the CFTA

A preliminary assessment of the Measures indicates that the following provisions of the CFTA are most relevant in the circumstances:

- Article 201 (Non-Discrimination)
- Article 301 (Right of Entry and Exit)
- Article 316 (Non-Discrimination)
- Article 317 (Commercial Considerations)

If during consultations other provisions of the CFTA appear to be applicable we will bring them to your immediate attention.

3. Summary of Complaint

British Columbia is of the view that the Measures discriminate against British Columbia wine and restrict its movement across provincial boundaries. In addition, the implementation of the Government of Alberta's direction by the AGLC is not consistent with commercial considerations. The CFTA requires Alberta to extend non-discriminatory treatment to all British Columbia wine and to allow its free movement across provincial boundaries. The CFTA also requires the AGLC to make its purchases of wine solely in accordance with non-discriminatory commercial considerations.

BACKGROUND:

On February 6, 2018 Alberta Premier Rachel Notley announced its intent to implement measures to boycott BC wines including the immediate halt of imports by the Alberta Gaming and Liquor Commission (AGLC) and stepped up enforcement of Direct to Consumer sales (Alberta wine boycott). These measures were in response to its opposition to BC's request for further review of the Kinder Morgan Trans Mountain pipeline expansion project (Trans Mountain project), Alberta has not released, to date, written or specific details on the Alberta wine boycott measures.

In response, Premier Horgan issued a statement on February 6, 2018 stating BC's support for its wine producers and the intent to respond to the Alberta's "unfair trade actions". In an interview on February 7, Premier Horgan further stated that BC will not seek retaliatory action but reiterated BC's intent to defend the BC wine industry.

In 2017 BC was estimated to export about 17.2 million bottles or over 1.4 million cases worth an estimated \$70 million in wine to Alberta.

BC and Alberta are parties to both the New West Partnership Trade Agreement (NWPTA) and the Canadian Free Trade Agreement (CFTA) which include specific trade obligations and dispute settlement provisions.

The BC Wine Institute (BCWI) met with the Minister of Agriculture, the Honourable Lana Popham on February 6, 2018 and with representatives of the Ministry of Jobs, Trade and Technology and Liquor Control and Licensing Branch of the Ministry of Attorney General on February 7, 2018.

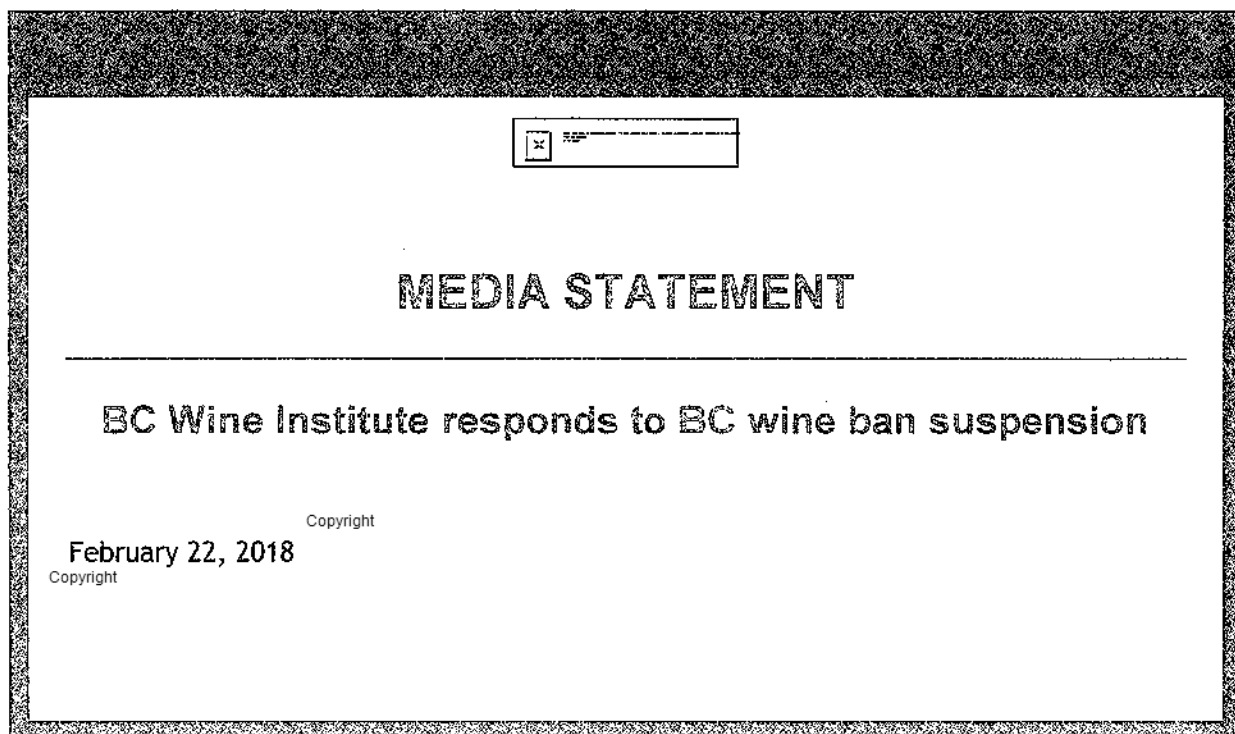
