- We understand the Federal Government has approved the sale of Retirement Concepts to Cedar Tree Investment Canada Inc.
- The federal government has exclusive jurisdiction for matters of international trade, under various trade agreements entered into by Canada and under the Investment Canada Act.
- In making a determination as to whether a proposed investment "...is likely to be of net benefit to Canada....", the Federal Minister is only obliged to consider the economic/financial factors set out in section 20 of the Investment Canada Act:
- I can confirm that the BC Government was consulted by the federal government under the Investment Canada Act, but only under the scope of the Investment Canada Act. Under the Investment Canada Act, I am not allowed to divulge what those discussions were.
- That said, there are further checks and balances that go along with any transition of ownership of a residential care facility.
- B.C.'s Assisted Living and Residential Care regulations outline requirements of applicants for registration or licensing when there is a change in ownership. These regulations are in

- place to protect the health and safety of residents and persons in care irrespective of ownership.
- This includes a review by the Medical Health Officer, who is an independent statutory decision maker.
- This review is conducted to ensure that the purchasing company or individuals is able to meet the needs of patients and provide quality care.
- The priority of the ministry and health authorities is, and will continue to be, the care of patients.
- Now that the federal government has approved this sale, we will wait for the medical health officer or the Registrar to approve Cedar Tree to operate.
- We expect the transition to be seamless, with patients residing in these facilities continuing to receive the same quality of care and services.
- Retirement Concepts has assured patients, families and staff that it does not intend to make any changes to the day-to-day operations, patient care, staff or leadership.
- The Seniors Advocate has said that we need to let the process transpire, and has also pointed out that we have legislation in place that allows the health authorities and the Registrar to continue to monitor these facilities.
- The Seniors Advocate analyzes and reports on quality of care in all care facilities in B.C., and in that role, will continue to

focus on quality indicators to ensure the best care is provided for seniors.
