1. We get really busy near the end of each month because we have to redline all the travel for the Minister.
2. Quarterly the expenses for each quarter goes out to open info for reporting to the public.
 - a. It does not look good if there is no travel for the whole quarter. When there are flights on the PCARD and no record of the travel.
3. Because each area has a budget when the receipts and travel are put in on a timely matter it makes keeping track of your budget easier and more up to date.
4. We have 10 working days to process all travel claims. So if there is an error or they are missing something. You can wait up to another 10 days to get it processed by the time we receive the information.
5. Even though I do them on time and get them out prior to the 10days. When it's vacation time we are short staffed so receiving 10 to 20 claims all at once can make it hectic on our end. Because they have their clients travel to do to.

These are just a few things to consider when holding onto travel expense too long.
