# Minister Chow – Personal Travel to China

# **SUGGESTED RESPONSES:**

- Minister of State for Trade George Chow was on a personal trip to China from s.22
- No government resources were used to plan this trip, and no government funds were used to pay for travel expenses.
- Minister Chow was not travelling in his role as the Minister of State for Trade and he was not representing the Province on this trip.
- Minister Chow was not involved in the decision to postpone the China leg of the forestry mission to Asia.
- As a private citizen and a member of the Yue Shan Society, Minister Chow had a meeting with Guangzhou City officials on December 7, 2018
- Minister Chow's itinerary included leisure travel to Guangzhou, Xi'an and his ancestral home town in the s.22

### BACKGROUND:

Minister of State for Trade Chow was on approved vacation leave from s.22 travelled to China on a personal trip during his leave, departing Vancouver s.22 s.22

Because of the timing of the trip and the Dec. 10, 2018 decision by the Province to postpone the China leg of the Asia mission, there may be questions about Minister Chow's presence in China.

The Overseas Chinese Affairs Office of the People's Government of Guangzhou Municipality posted photos of a Dec. 7, 2018, meeting with Minister of State for Trade Chow. The photos were posted Dec. 10, 2018. The minister attended that meeting in his role as a member of the non-profit Yue Shan Society, not as MLA and not as Minister of State for Trade.
