International Trade Commission ruling on newsprint duties

Minister of Jobs, Trade and Technology, Bruce Ralston, issued the following statement today in response to the U.S. International Trade Commission's (ITC) finding of no injury on B.C.'s Catalyst Paper's newsprint exports to the United States.

The ruling means that the combined countervailing and antidumping duties of 20.26 per cent applied by the U.S. Department of Commerce to B.C.'s Catalyst Paper's newsprint products since its final antidumping and countervailing duty determination of August 2, 2018 will no longer apply. The duties that had been collected to date will be refunded.

"Today's ruling means that Canadian newsprint producers, including Catalyst, will no longer have to pay these unwarranted duties. We're very pleased with the outcome and we're glad the ITC has made the right decision based on the evidence before it.

"This case was launched by a single Washington State mill. Although it is now over and the duties will be refunded, the damage it has inflicted on Catalyst and other Canadian producers, is disturbing.

"The pulp and paper industry is an important contributor to B.C.'s economy. Catalyst's B.C. operations support about 6,500 direct and indirect jobs across the Province. Government has worked hard with a broad range of local and provincial stakeholders, including local mayors, MLAs, as well as others and will continue to vigorously defend B.C.'s interests against future unfair U.S. litigation.

"The governments of B.C. and Canada demonstrated clearly during the investigation that they had not been subsidizing Catalyst's operations, and we're satisfied by today's decision by the ITC."
