More on the presenters

Dr. Siamak Arzanpour (pronounced: See-oo-mak Arzan-poor) is one of the 8 recipients of a 2018 Innovation to Commercialization award. This award program was launched in 2017 to support researchers who want to advance their discoveries or inventions towards products that will improve health outcomes, benefit society, and enrich the health innovation ecosystem in BC.

Siamak (pronounced: See-oo-mak) is an associate professor in School of Mechatronic Systems Engineering at Simon Fraser University. He is working on a wearable robotic exoskeleton that could help people with lower limb disabilities, such as spinal cord injuries, walk again. His award is co-funded by the Rick Hansen Institute.

Dr. Chelsea Pelletier received a 2018 Convening and Collaborating award to support a team project that brought together stakeholders to explore how to improve physical activity levels in Northern BC.

Convening and Collaborating awards were launched by MSFHR in 2017 as short term grants aimed at bringing teams of researchers and research users together to plan activities and events that encourage the use of evidence in practice, policy and further research.

Dr. Eugenia Socias (pron: *Oo-he-nia So-ci-as*), an Assistant Professor in the Division of AIDS at the University of British Columbia and research scientist at BC Centre on Substance Use. She is one of 17 scholars awarded last year. With her award, co-funded by the St. Paul's Foundation, Eugenia (pron: *Oo-he-nia*) will conduct clinical trials to evaluate evidence-based treatments for opioid use disorder.

The Scholar program is one of MSFHR's flagship programs, offered since 2001. Over the past 17 years, this program has supported more than 400 early-career researchers who are building leading-edge health research programs as well as training a new generation of scientists.

Dr. David Huntsman is a Professor in the Departments of Pathology and Laboratory Medicine and Obstetrics and Gynaecology at The University of British Columbia (UBC) and is the Dr. Chew Wei Memorial Professor of Gynaecologic Oncology. He is currently the Director of the BC multidisciplinary ovarian cancer research team (OvCaRe), Medical Director of the Centre for Translational and Applied Genomics (CTAG) at the BC Cancer Agency, and co-Director of the Genetic Pathology Evaluation Centre (GPEC) at the Jack Bell Research Centre, VGH.

Dr. Huntsman's research has led to development of predictive and prognostic tissue based cancer biomarkers for ovarian cancer and a wide variety of other tumour types. His team created a blueprint for subtype specific ovarian cancer control and have been leaders in the application of novel genomics technologies to ovarian cancer. His research has attracted collaborative industry projects from Sanofi, Novartis, Astra-Zeneca, and Pfizer.

Dr. Huntsman is the recipient of

- the inaugural Virginia Greene leadership award for ovarian cancer research and advocacy in 2011
- the Karen Campbell National Award for Excellence in Ovarian Cancer Research in 2012
- the William E. Rawls Prize for contributions to cancer control in Canada in 2014
- the Gerald Award for Translational Research and Pathology from the Memorial Sloan Kettering Cancer Center in 2016
