Thank you for your prompt response, with confirmation that a member of the Legislative Assembly will make a statement about the Holodomor, and Genocide Awareness month. Please note that the Holodomor bus will be in front of the Legislature on Monday, April 1, not on April 2 as you state in your e-mail.

I plan to be present in the gallery to represent represent the Ukrainian Canadian Congress (UCC), Victoria Branch. I will let you know tomorrow, or Friday am at latest, who else from UCC may be available to attend. I have requested Roma Dzerowicz, of the

Canada -Ukraine Foundation (CUF) to also attend, and will advise you once I hear back from her. As she is the Tour bus' primary contact at all stops I assume she certainly will wish to be present in the gallery as well. The Foundation is the principal organizer of the National Holodomor Awareness tour, and has worked with community organizations across the country, including UCC in Victoria, to organize visits to high schools for classroom presentations, and for the general public to take in the audio-visual presentations in the bus. Please have both organizations acknowledged, but with CUF receiving the main recognition for its significant undertaking in making the Canadian public aware of the Holodomor through the National Holodomor Awareness Tour.

Honorable Rahlston,

I refer you to the recent exchange of e-mails between Hon. Andrew Weaver and Motria Koropecky, member of the Ukrainian Canadian Congress (UCC), Victoria Branch regarding the Holodomor National Awareness Tour bus being in Victoria on Monday, April 1. Arrangements have been confirmed via Luba Lisun, legislative staff, for the bus to be parked in front of the Legislature for the general public to access from 8.30 am to 5 pm. I spoke with Amanda in your Victoria office today who did not know if you had already been apprised of this event.

Nataliya Jatskevich, President of UCC Provincial Council, has informed me that she is to meet with you on April 5 to discuss a formal Holodomor proclamation by the BC government. I was present in the public gallery when you put forward a private member's bill several year's ago, that unfortunately never got to second reading. I note from Mr. Weaver's reply to Motria Koropecky that he will be asking his staff to now work with your office to initiate an official Bill rather than a proclamation.

Given your pending meeting with N. Jatskevich on April 5 obviously no formal announcement can be made by your government about the Holodomor on April 1. However, if possible, I kindly ask that you inform the General Assembly of the Holodomor bus being on site at the Legislature on April 1 and invite all Members and legislative staff to take the opportunity to take in the 20 minute audio-visual presentation on the bus. Given Mr. Weaver's personal interest in the Holodomor, I assume he would strongly endorse such an initiative. The added significance of the Holodomor bus beginning its national tour in Victoria on April 1 is that several years ago the Canadian government officially designated April as Genocide Awareness month. If an

announcement were to be made in the House would it be appropriate to have members of our Congress and the Holodomor Awareness tour present in the public gallery. If so please advise about what time that might occur.

My sincere apologies for the delay in contacting you regarding this event on April 1. There is much information available on the Holodomor National Awareness Tour website.

I refer you to the recent exchange of e-mails between Hon. Andrew Weaver and Motria Koropecy, member of the Ukrainian Canadian Congress (UCC), Victoria Branch regarding the Holodomor National Awareness Tour bus being in Victoria on Monday, April 1. Arrangements have been confirmed via Luba Lisun, legislative staff, for the bus to be parked in front of the Legislature for the general public to access from 8.30 am to 5 pm. I spoke with Amanda in your Victoria office today who did not know if you had already been apprised of this event.

Nataliya Jatskevich, President of UCC Provincial Council, has informed me that she is to meet with you on April 5 to discuss a formal Holodomor proclamation by the BC government. I was present in the public gallery when you put forward a private member's bill several year's ago, that unfortunately never got to second reading. I note from Mr. Weaver's reply to Motria Koropecky that he will be asking his staff to now work with your office to initiate an official Bill rather than a proclamation.

Given your pending meeting with N. Jatskevich on April 5 obviously no formal announcement can be made by your government about the Holodomor on April 1. However, if possible, I kindly ask that you inform the General Assembly of the Holodomor bus being on site at the Legislature on April 1 and invite all Members and legislative staff to take the opportunity to take in the 20 minute audio-visual presentation on the bus. Given Mr. Weaver's personal interest in the Holodomor, I assume he would strongly endorse such an initiative. The added significance of the Holodomor bus beginning its national tour in Victoria on April 1 is that several years ago the Canadian government officially designated April as Genocide Awareness month. If an announcement were to be made in the House would it be appropriate to have members of our Congress and the Holodomor Awareness tour present in the public gallery. If so please advise about what time that might occur.

My sincere apologies for the delay in contacting you regarding this event on April 1. There is much information available on the Hododomor National Awareness Tour website.
