Carol Anne is currently authoring 'Indigenomics- a Global Power Shift' Carol Anne has led the establishment of a line of thought called #indigenomics- building and developing local Indigenous economies.

Carol Anne's work has been recognized with a BC Aboriginal Outstanding Business Achievement Award, a Creating Wealth Award from the National Indigenous Council of Elders and Business of the Year Award from the Nuuchah-nulth Economic Development Corporation.

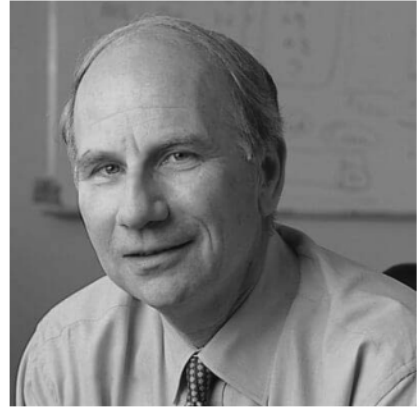
Dr Eric Werker
