I hope this email finds you well. This is Enrico Saltarelli from ART-ER, the Emilia-Romagna regional agency for research, innovation, attractiveness and internationalization. We met on June 7th 2019, when Minister Ralston received our Minister Simona Caselli and the Emilia-Romagna regional delegation.

As agreed, I am following up on the brief conversation we had after the meeting to reconnect and discuss the prospective collaboration between INNOVATE BC and ART-ER. For this reason, I would also like to introduce to you the Head of the Europe and International Unit, Ms. Valeria Bandini, whom, with my direct support, will be in charge of coordinating the effort on our side.

The Emilia-Romagna region is seeking like-minded regional representatives to initiate collaborations in the field of research and innovation, as well as to attract investments.
