Ralmax Group of Companies – Ralmax plans to invest \$50 million in a new dry dock at its Point Hope Maritime shipyard on Victoria's harbour that is expected to double employment

- **Fortinet** The American multinational cyber security company announced a large expansion in Burnaby with 1,000 new tech jobs.
- **Microsoft** Is adding 50 new mixed reality jobs in Vancouver and is expanding its Technology Education and Literacy in Schools (TEALS) philanthropy program to team-teach computer science with B.C. high school teachers. Microsoft has also partnered with BCIT in this endeavour.

It is expected that the Port of Prince Rupert will become Canada's second-largest port in the next five years.
 - On Sept. 5, 2019, the Port announced it is receiving \$153.7 million from the federal government to help fund three projects to facilitate continued growth and enable further trade development at the Port.
 - A study by the Port also found that employment associated with moving trade through northern B.C. to the Port of Prince Rupert has grown to 6,200 jobs in 2018 from 5,200 two years earlier. Annual wages associated with those jobs averaged \$87,200, the study said.
- West Coast Olefins Calgary-based West Coast Olefins announced its intention to build a
 petrochemical manufacturing facility in Prince George for the production of plastic pellets
 for export to Asia. Capital expenditure is estimated at \$5.6 billion to \$6 billion and would
 employ about 1,000 permanent workers, plus about 5,000 during peak construction. The
 project would be the largest private-sector dollar investment in Prince George's history.
- Pacific BioEnergy Corporation Japanese trading company Sumitomo Corporation
 acquired a 48% stake in Prince George's Pacific BioEnergy Corporation, the second-largest
 manufacturer of wood pellets in Canada. This investment has supported jobs for people in
 Prince George and increased exports to foreign markets. In January 2019, Pacific BioEnergy
 announced two significant new long-term contracts with Japanese power producers.

In 2017, POSCO Daewoo committed \$8.2 million to the project in B.C.'s north-central interior near Fort St. James. (Kwanika is undergoing a pre-feasibility study and expects to publish a report Q2/2019.)

- **Essel Group** After a year of engagement by our India trade and investment representatives, **Zee Studios International**, a major Indian film and television conglomerate, has established a significant presence in B.C., with plans to employ up to 100 people.
- **Fortinet** The American multinational cyber security company announced a large expansion in Burnaby with 1,000 new tech jobs.

- **Microsoft** Is adding 50 new mixed reality jobs in Vancouver and is expanding its Technology Education and Literacy in Schools (TEALS) philanthropy program to team-teach computer science with B.C. high school teachers. Microsoft has also partnered with BCIT in this endeavour.
- **Apple Inc.** In July 2019, Bloomberg reported in that Apple will lease two floors at a new office tower under construction in downtown Vancouver as the company joins other tech giants in expansion plans in the city. The report came out the same week as a study by real estate services firm CBRE found that Vancouver is surging as a top destination for tech companies.
- Workday On Vancouver Island, in August 2018, major Silicon Valley-based tech company Workday expanded its presence in Victoria with the opening of a 17,000-square-foot office, signalling confidence and continued job growth in the Victoria tech sector.

•

- **WeWork** The Manhattan-based firm WeWork has expanded rapidly in Vancouver, opening an 80,000-square-foot, five-floor facility in fall 2017, followed by a second 53,000-square-foot office. In May 2018, WeWork added five additional floors of space near Waterfront Station, increasing its number of workstations in Vancouver to 3,800.
- **DP World** Dubai-based DP World's Fairview Terminal expansion is to begin in spring 2020. Construction will require 150 full-time workers over three years, and it will create 300 full-time jobs at the Port of Prince Rupert. In addition to the construction and full-time jobs, the project will create additional jobs in trucking, trans-loading and logistics services to support the growth of the facility. The terminal is served by all three of the world's major container shipping alliances and is one of North America's fastest-growing container cargo ports, handling a record one million TEUs (20-foot equivalent units) and 27 million tonnes of cargo in 2018.
- Port of Prince Rupert The Prince Rupert Port Authority has completed a container terminal master plan that identifies the potential to develop multiple terminals and six to seven million TEUs of capacity. The master plan cited the potential for further expansion of DP World's Fairview Terminal and development of a second container terminal at the Port of Prince Rupert's South Kaien Island site. It is expected that the Port of Prince Rupert will become Canada's second-largest port in the next five years.
 - On Sept. 5, 2019, the Port announced it is receiving \$153.7 million from the federal government to help fund three projects to facilitate continued growth and enable further trade development at the Port.
 - A study by the Port also found that employment associated with moving trade through northern B.C. to the Port of Prince Rupert has grown to 6,200 jobs in 2018 from 5,200 two years earlier. Annual wages associated with

those jobs averaged \$87,200, the study said.

- West Coast Olefins Calgary-based West Coast Olefins announced its intention to build a petrochemical manufacturing facility in Prince George for the production of plastic pellets for export to Asia. Capital expenditure is estimated at \$5.6 billion to \$6 billion and would employ about 1,000 permanent workers, plus about 5,000 during peak construction. The project would be the largest private-sector dollar investment in Prince George's history.
- Pacific BioEnergy Corporation Japanese trading company Sumitomo
 Corporation acquired a 48% stake in Prince George's Pacific BioEnergy
 Corporation, the second-largest manufacturer of wood pellets in Canada. This
 investment has supported jobs for people in Prince George and increased
 exports to foreign markets. In January 2019, Pacific BioEnergy announced two
 significant new long-term contracts with Japanese power producers.
- **POSCO Daewoo** Korea's largest trading company is a joint venture partner with Vancouver-based Serengeti Resources in the Kwanika copper-gold mining exploration project. In 2017, POSCO Daewoo committed \$8.2 million to the project in B.C.'s north-central interior near Fort St. James. (Kwanika is undergoing a pre-feasibility study and expects to publish a report Q2/2019.)
- San Group Inc. Langley-based San Group announced it is investing \$60-\$70 million to build a sawmill in Port Alberni, providing jobs for about 135 people about 50 during construction, plus 85 permanent jobs. This will increase production and utilize the full range of species. The mill will process a range of different sized logs (waste wood) often accrued from normal harvesting techniques, but not used. Construction is scheduled to begin this spring, with hopes to be cutting wood by the summer. San Group exports forest products to 21 countries.
