Hi Tara,

Thanks for this note.

BC continues to be enthusiastic about hosting the winter meeting in principle, but we need to understand under what conditions hosting an in-person conference is possible.

At first glance, the following restrictions/health guidelines would have to be lifted:

- Max. 50 people gatherings in BC;
- Border closed to non-essential travel;
- 14 day quarantine period.

We have to speculate on when these conditions might be lifted. Under BC's Restart Plan, we are currently in Phase 3. Singling out the max-50 gatherings order (includes conventions), public health officials have said the order will not be lifted until Phase 4, which is when a vaccine is available, there is community immunity or broadly successful treatments are available.

This gives us serious pause about whether or not it's realistic to plan for an in-person meeting in November.

We would be pleased to support pursuing a virtual conference, including organizing BC-themed discussions, virtual meetings, virtual tours...

Happy to discuss further.
