# What is the Connected Coast project?

- This includes 56 Indigenous communities along B.C.'s coast.
- Connected Coast is led by CityWest in the north and the Strathcona Regional District in the south.
- Connected Coast work includes installing a sub-sea fibre line from Prince Rupert over to Haida Gwaii, around Vancouver Island and to the Lower Mainland, bringing fibre connections to landing sites in B.C. coastal communities.
- Once activated, other coastal communities like Ahousaht will be able to enjoy reliable internet access at speeds comparable to urban centres on the mainland.
- Questions about project timelines, schedules and progress are best directed to CityWest and the Strathcona Regional District.

We've just been advised that PS Jennifer Rice is going to the Bella Coola Valley this weekend. She's apologized for the very short notice but asked us to provide and update on the connected coast project. Also, she'd like to know what relationship the Province has with the local internet/comms provider there. She's been booked to meet with them and wanted to know the latest information.

Here's what I have from the May 10<sup>th</sup> briefing note on the Connected Coast project. Please advise if there are any updates to this information and if I can share these details with PS Rice.

## PROJECT SCOPE:

The Connected Coast project involves the installation of a new sub-sea backbone transport cable along the west coast of BC. The project leads are CityWest Cable & Telephone Corporation (CityWest) and the Strathcona Regional District (Strathcona). They have partnered to own and operate the fibre line.

The Connected Coast project does not include last-mile builds, but once the landing sites are complete, the new fibre backbone will enable increased last-mile internet speeds and reliability.

The project <u>originally</u> envisioned 154 landing sites, including 56 Indigenous communities representing 44 First Nations. Once the due diligence review by ISED is complete, the total number of communities is expected to be reduced by six to 148.

Total project investment is \$45.4 million, co-shared between the federal and provincial governments.

- \$22 million will come from the Connect to Innovate program, administered through Innovation, Science and Economic Development (ISED)
- \$12 million will come from Indigenous Services Canada
- \$11.4 million will come from the Province, through the Connecting British Columbia program administered by the Northern Development Initiative Trust (Northern Development).
- The total aggregate amounts as committed by the major funders for the CityWest and Strathcona projects is unchanged, apart from the added scope for connecting Tlowitsis First Nation. All Nations Trust Company Pathway's to Technology project will be contributing an estimated \$187,600 in new funding.

# PROJECT UPDATE & STATUS:

# Federal update

CityWest's portion of the Connected Coast project has

completed federal due diligence and is with the ISED Minister, the Honourable Navdeep Bains, for approval, afterwhich a contribution agreement will be sent to CityWest.

Strathcona's portion of the project is completing its due diligence with ISED and the project is anticipated to be approved by Minister Bains thereafter. Once approved, a federal contribution agreement will be sent to Strathcona. ISED is currently estimating 3 weeks to when the contribution agreement will be sent to Strathcona for signing. ISED has missed previous target dates for the completion of project due diligence.

# Project changes from ISED due diligence process

As a result of federal due diligence seven sites have been removed because ISED determined the communities were supplied with a 1 Gbps point-of-presence in the community and residents were served at a minimum of 50/10 Mbps. Sites removed from the project are: Deep Cove, Tseycum First Nation, Malahat First Nation, T'souke First Nation, Toquaht First Nation, Ucluelet First Nation and Ucluelet (end of bay). Some descoped sites will receive a new landing site (but no point-of-presence) for future use and other sites will not receive a landing site because they already have sufficient network infrastructure. The value of the reduced scope is estimated at \$1.5 million. The decrease in scope resulted in \$1.5 million being reallocated to remaining sites to connect anchor institutions.

A new site landing site and infrastructure has been added to serve the Tlowitsis First Nations. The scope change is estimated at \$375 thousand, which will be covered by contributions from ISED and from the All Nations Trust Company's Pathways to Technology project.

## Provincial update:

Once the federal Minister Bains provides final project approval and the contribution agreements are sent to the recipients, Northern Development will obtain copies to develop their agreements with the recipients (project leads). It is anticipated that NDIT will take two weeks to issue the Connecting British Columbia program contribution agreements from the time they receive the approved federal agreements.

The Boards of CityWest and Strathcona are expected to review and approve the contribution agreements from ISED and Northern Development at their respective board meetings. Once the agreements are executed by CityWest and Strathcona, then the project leads will proceed to with an open procurement(s) to select suppliers for the fibre, fibre deployment and for a project manager for the installation. The form and timing of the procurement(s) for CityWest and Strathcona will be determined by their project leads.

# CityWest Board of Directors update

On April 2, 2019, Bob Long, Chair of the City of Prince Rupert wrote to Jill Kot, Deputy Minister of Citizens' Services, regarding risk management concerns for the project. He raised some options to mitigate risk, including: Discussing with other telco's the possibility of sharing the cable risk, proceeding with a procurement process to assure value for the investment, separating the project into smaller portions, and investigating the purchase of insurance to mitigate project risk. See ATT-1.

On April 25, 2019, Deputy Minister of Citizens' Services, Jill Kot, responded to Chair Bob Long concerns and offered to meet to discuss how the Province can assist to achieve important milestones for the project. In addition, program area staff have offered to meet with the CityWest Board of Directors to address any outstanding concerns the Board may have and any associated risk prior to signing of the federal contribution agreement and a meeting date is pending. See ATT-2.

# Project procurement process

Applicants whose projects are selected under ISED's CTI program (and co-funded under the Connecting British Columbia program) will be required to comply with a number of government policies and expectations. Recipients will be expected to use a fair, competitive and transparent process to ensure best value for money when supplies, equipment and services are purchased or personnel are hired.

# **KEY QUESTIONS:**

# What work has been done since the initial announcement of Connected Coast?

The project has been undergoing due diligence with the Connect to Innovate team at ISED. This required a site by site review of the applications. Due to the number of sites of the Connected Coast project, the due diligence has been a long and involved process for both proponents.

# Is this project now delayed? For how long?

The project is going through its required cycle of due diligence determined by ISED. ISED's Connect to Innovate program was overwhelmingly oversubscribed and program staff are moving as quickly as possible. The Connected Coast project will proceed as soon as the contribution agreements are finalized and signed with ISED and Northern Development. The length of time to complete the due diligence by ISED was unexpectedly long. Other projects nationally have experienced similar delays with approvals received by ISED prior to the January 2018 Connected Coast project announcement date.

Recent updates from Connect to Innovate staff indicate that final project approval for the CityWest portion of the project is imminent and once approved will send a contribution agreement to CityWest.

Final project approval for Strathcona's portion of the project is still undergoing due diligence and ISED expects to receive final approval in the coming weeks, afterwhich a contribution agreement will be sent to SRD.

# Has any construction commenced?

Construction will not commence until contribution agreements are signed and the project leads have completed their procurement process. It is anticipated that CityWest and Strathcona will provide a detailed project plan as soon as the contribution agreements are signed.

# When will we actually see tangible progress on the ground?

Until contribution agreements are signed and procurement process is complete, it is difficult to determine the timing for the project to reach specific communities. The detailed project plan that follows the signing of the contribution agreements will provide realistic timing for tangible benefits to be reallized by communities. It is still anticipated that the project will take up to 3-years to complete.

# What are Citywest/City of Prince Rupert's concerns and what is being done to allay those concerns?

The Chair of the Board of CityWest, Bob Long has identified four areas where the organization is working to mitigate risk. The Deputy Minsiter of CITZ has reached out to Mr. Long for a meeting, and CITZ staff have offered to attend a Board meeting to assist resolving outstanding issues.

# Will the project now be modified/reduced in scope?

As a result of the due diligence process with ISED, the project has been reduced in scope to 148 communities from 154. Additional scope changes (to increase or decrease landing sites) may result from detailed engineering studies and consultations.
