**ISSUE:** Changing Family Day from the second Monday to the third Monday in February.

#### BACKGROUND:

Family Day was established as the second Monday in February based on consultations with British Columbians from across the province, as well as with educators, the tourism sector and broader business sectors. BC's first Family Day was in 2013.

All other Canadian jurisdictions with a February statutory holiday celebrate it on the third Monday in February. President's Day in the United States is also on the third Monday.

#### DISCUSSION:

Certain sectors, especially tourism, support having BC's Family Day on the second Monday because they benefit from two distinct long weekends. They can attract customers from within BC on the second Monday and tourists from outside the province on the third Monday. The Canada West Ski Areas Association estimates incremental visitor spending at BC ski hills on Family Day 2016 to be \$7 to \$10 million. The Greater Vancouver Board of Trade and the BC Chamber of Commerce fully support the current timing of BC's Family Day on the basis of the benefit to the tourism and resort economy.

Since 2013, however, others have expressed support for moving BC's Family Day to the third Monday to align with the holiday in other jurisdictions. Some examples:

- According to an online survey, independently conducted by Insights West from Oct.31 to Nov. 2, 2017, most British Columbians (71%) were in favour of changing B.C.'s Family Day to the third Monday of February.
- The Surrey Board of Trade is very supportive of the proposal to align Family Day with other provinces, stating that "we have heard from our members, particularly those that have business connections and clients throughout Canada, that they experience difficulties that have a financial impact... we believe the economic benefit derived from alignment will greatly assist our members and especially the

small and medium sized businesses across the province." (Letter to Premier Horgan, Oct. 23, 2017)

- The Burnaby Board of Trade has also expressed support for moving Family Day.
   (Letter to Premier Horgan, Jan. 5, 2018)
- An online petition that began in 2015 to change BC Family Day from the second
  to the third Monday in February to align the holiday with other jurisdictions has
  attracted more than 20,000 signatures (see
  <a href="https://www.change.org/p/unitefamilyday">https://www.change.org/p/unitefamilyday</a>). The petition argues that business
  owners and those who conduct business across Canada and North America are
  often required to work on BC Family Day.

The primary concerns with having a holiday in BC that is not consistent with the rest of the country are that businesses with multi-jurisdictional locations face operational challenges, and that families cannot unite with loved ones from outside of BC when time spent with family is the intent of the holiday.

Media has reported that the Premier is considering changing when Family Day is held in B.C., to make it harmonize with other provinces.

A Regulation is required to change the timing of Family Day in February.

#### **OPTIONS:**

1. Move Family Day to the third Monday in February starting in 2019.

Burnaby Board of Trade is also supportive and has stated: "For companies which conduct business in other parts of Canada or in the United States this misalignment of holidays can create a barrier to commerce and trade and can be a significant inconvenience."

#### Public Requests to Harmonize BC Family Day with Other Provinces:

- Each year around Family Day, government receives letters and emails from a few individual British Columbians requesting that Family Day be changed to the third Monday in February.
- The Surrey Board of Trade recently submitted a written request to change the day. The B.C. Chamber of Commerce's recently published 2015-16 Policy and Positions Manual contains no position on the subject.
- An on-line petition to change the day, which was started in 2015, has over 18,000 signatures to date. CBC has a separate on-line poll in which 65% of the over 7,000 votes to date are in favour of moving Family Day to the third Monday.
- The principle reason cited for the change is to align BC with other jurisdictions that have a statutory
  holiday on the third Monday in February. This would enable family members and friends in different
  jurisdictions to celebrate a holiday together. As well, businesses that operate inter-jurisdictionally
  would not have to work on Family Day because other jurisdictions are celebrating their holiday on
  the same day.

# Opponents of Harmonizing Family Day with Other Provinces

In our portfolio, notably both TIABC and the Canada West Ski Areas Association are opposed to changing the date to harmonize with other provinces. TIABC has launched an advocacy campaign asking people to send letter to Premier Horgan.

As you'll see in the news article in the background below, CWSAA President Christopher Nicholson says his organization's members "definitely support the current date for both economic and social reasons."

The Greater Vancouver Board of Trade and the BC Chamber of Commerce support the current timing of B.C.'s Family Day, as they recognize the benefit to the tourism and resort economy to have a distinct week. Their view is that this enables tourism and ski resort businesses to host tourists from other provinces one week, and British Columbians another – extending holiday weekends over two weeks instead of one, generating more revenue and economic benefits across two weekends.

# Advantages of Second Monday for British Columbians:

- The second Monday in February provides BC residents a holiday when ski resorts, other attractions, highways and ferries may not be as crowded.
- With out-of-province visitors coming on the third Monday, BC's holiday on the second Monday provides local businesses with the economic benefits of two long weekends.
- The Canada West Ski Areas Association estimates incremental visitor spending at BC ski hills on Family Day 2016 to be \$7 to \$10 million.

# History of Family Day

B.C. Family Day was established as the second Monday in February based on consultations with British Columbians from across the province. The first B.C. Family Day was celebrated in 2013.

The consultation received more than 31,000 votes and 3,000 comments were received through the web poll component of the public engagement regarding the date preference (between holding the holiday the second or third Monday in February). Of those that expressed a preference, almost twice as many supported the second Monday of February. The Province also consulted with educators, the tourism and broader business sector to understand the economic and social impacts and benefits to their areas.

\*Note: Some key messages in this document originated from the Ministry of Labour and Ministry of Jobs, Trade and Technology.

# Reasons given by Previous Gov't for BC Family Day on different date than the rest of Canada

The Family Day Act (Bill 53) received Royal Assent on May 31, 2012. Bill 53 allowed for the observation of Family Day to commence in February of 2013, on a date to be set by regulation. Setting the date by regulation allowed Government to consult with British Columbians prior to confirming the timing of the statutory holiday.

Government undertook a public engagement process in May 2012. British Columbians were asked to provide input into whether they preferred the second or third Monday of February for Family Day. The web poll component of the Family Day website received over 31,000 selections, along with over 3,000 comments. Of those who expressed a preference, almost twice as many supported the second Monday in February.

Also in May 2012, Government engaged in consultations with various business and industry stakeholders, as well as school superintendents. The ski and tourism sectors expressed strong support for the second Monday of February.

Based on the results of the public engagement and business and industry consultation, a decision was made to hold the holiday on the second Monday of February.

#### **ADVICE AND RECOMMENDED RESPONSE:**

- The Premier has stated that we will change Family Day to line up with other provinces.
- I have heard from many families and businesses that the change will be welcome.
- This change will mean people can plan time with friends and family in other provinces, and businesses who have employees located in different provinces will find efficiencies by having the holidays aligned.

# Petition to Change BC Family Day Date

# **ADVICE AND RECOMMENDED RESPONSE:**

- The Premier has stated that we will change Family Day to line up with other provinces.
- I have heard from many families and businesses that the change will be welcome.
- This change will mean people can plan time with friends and family in other provinces, and businesses who have employees located in different provinces will find efficiencies by having the holidays aligned.
- Changes are not being considered for 2018, but we will be looking at a timeline that works for British Columbians.
- We will be engaging British Columbians to ensure this is a smooth transition, including businesses in travel and tourism.

# IF PRESSED ON WHY

- Choosing the date of BC Family Day was done five years ago, but over time we've seen that there are significant implications to a unique date.
- Because BC's holiday is not consistent with the rest of the country:
  - Businesses with multi-jurisdictional locations, banks and federal agencies are having operational challenges; and
  - Families can't unite with loved ones from outside of BC; which of course, time spent with family is the intent of the holiday.
- There are certain sectors, such as tourism, that benefit from two

For companies which conduct business in other parts of Canada or in the United States, this misalignment of holidays creates a barrier to commerce and trade. ## Burnaby Board of Trade Reiterates Call to Move BC's Family Day


After five years of inconvenience for the business community caused by a misaligned BC Family Day statutory holiday, the Burnaby Board of Trade (BBOT) is reiterating its call for the provincial government to align Family Day with the holidays of neighbouring jurisdictions by moving the date to the 3rd Monday of February starting in 2019.

While British Columbia has a statutory holiday (Family Day) on the 2<sup>nd</sup> Monday of February, seven other provinces observe holidays on the 3<sup>rd</sup> Monday of February, which is also a federal holiday in the United States of America. For companies which conduct business in other parts of Canada or in the United States, this misalignment of holidays can create a barrier to commerce and trade and can be a significant inconvenience. When offices in BC are closed for Family Day but firms are operating in all neighbouring jurisdictions, local businesses are unable to service their interprovincial or American customers and may be unable to capitalize on potential sales or other opportunities. Then, come the 3<sup>rd</sup> Monday in February, the employees of those same local businesses may largely be sitting idle as they are unable to reach those same clients who are then closed due to their own holiday.

A survey by the BBOT of its members on this issue generated its largest ever response and showed that, of those businesses with a preference, fully 90% preferred Family Day be moved to the 3<sup>rd</sup> Monday in February to align with the holidays in other jurisdictions.

In addition, respondents were asked about the impact of the misalignment of Family Day on their operations: 50% of respondents reported requiring someone to work on Family Day despite the holiday to deal with customers and clients from out of province, and of those 37% had to specially open their offices on Family Day, 43% had at least some employees putting in time from home, and 54% had their owners or managers working on Family Day.

Would you prefer Family Day be aligned with the holidays in most other Canadian provinces and the USA, which are on the 3rd Monday in February?



The misalignment of Family Day causes inconvenience, increased costs, and lost opportunity for businesses of many sizes and in myriad industries. From the financial services sector which still has to operate when markets in Toronto or New York are open, to the film and television industry which must stay open on Family Day to coordinate with the industry hub in California, to any company that has customers, ships product, or does business outside of BC, the misalignment of Family Day is an unnecessary inconvenience and burden to most BC businesses.

The solution to this problem is to align BC's Family Day with the February holidays of the rest of Canada and the United States which are observed on the 3<sup>rd</sup> Monday in February. Therefore, the BBOT is asking the provincial government to move Family Day and make this year's holiday the last one that is so misaligned with our neighbours.

- The Premier has stated that we will change Family Day to line up with other provinces.
