Hi Selena;

The records created by the section 3 committee are government records – the committee is performing a review of the LRC at the direction of the Minister, and as contracted members the records they create to deliver the contracted for service are subject to the *Freedom of Information and Protection of Privacy Act* (FOIPP). They clearly meet the definition of "service providers" in Schedule 1 of FOIPPA.

Notes taken during public consultation would be records related to the service; the details of where the records are stored does not determine whether they are government records or not. While members should be encouraged to not use personal email to do government work, we acknowledge it sometimes occurs – those are still government records.

The FOIPP Act grants information rights to people to access records "in the custody or under the control" of the public body (Ministry of Labour). There is no "quasi-judicial" function to this committee to exempt it's records from the operation of the FOIPP Act. If the ministry received an FOI request for the committee's records, we would not be able to credibly take the position that those records are not under our control.

Does this answer your question? I'm copying Tracy as I understand an aspect of FOIPP application may have already popped up regarding this committee.

ISSUE: Remuneration for the new Labour Relations Code panel (Section 3 Committee)

BACKGROUND:

Section 3 of the Labour Relations Code (the Code) provides that the Minister of Labour may appoint a committee of special advisors to: undertake a continuing review of the Code and labour management relations; provide to the Minister an annual evaluation of the manner in which the Code is functioning and to identify problems that have arisen under its provisions; and to make recommendations on the need for amendments to the Code or on any specific matter referred by the Minister.

The first Section 3 Committee was established in 1997. Since 2002, the committee has been retained in a largely informal, advisory capacity that is called upon by the Minister for legal advisory services as required. The Minister called upon the Committee for advisory services in 2002 and a public report was tabled in 2003. Subsequent reports that were tabled in 2006 and 2007 were not released publicly and were for the purposes of providing direct technical advice to the Minister.

The committee's members have historically been retained through one-year contracts (General Services Agreements) that have been renewed annually. Each contract had a compensation amount of \$20,000. Services provided by each committee member were drawn down from this contract amount, payable at \$.17 which is consistent with the charge out rate when retaining external counsel through Ministry of Attorney General's (MAG) Legal Services Branch. If no services were provided during the year, no payments were made. The contracts for the section 3 committee members expired March 31, 2017 and have not been renewed. The General Service Agreements have been within \$25,000 threshold for direct award contracts.

DISCUSSION:

On February 6th, 2018, Minister Bains appointed a new Labour Relations Code review panel in accordance with Section 3 of the Code. As with the previous committee, the panel will be comprised of three lawyers (one representing the interests of employers, one representing the interests of unions and a neutral chair, see Appendix A). The services required are to: provide legal advisory services to the minister, in confidence or

in the format of a report that may be made public. This work is anticipated to be intensive for a period of a few months (i.e. February-August 2017) and intermittent/as needed thereafter.

The Ministry of Labour has consulted with PSEC on the approach for providing remuneration to the review panel members and whether Treasury Board Directive 2-17, Remuneration Guidelines for Appointees to Ministry and Crown Agency Board applies to this technical advisory committee.
