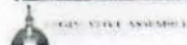

I've been working to organize a naloxone training for when the Executive Assistants are in Victoria, and with help from Layne we have found a date and time that will work! I'm really excited to invite you all (EAs, MAs, Caucus staff) to attend on Wednesday May 30<sup>th</sup>, 8:30 am-9:30am. Yay mornings!

We are lucky to have Griffin Russell teaching the workshop. Griffin is the Harm Reduction Coordinator for Vancouver Island Health Authority and has a lot of experience with training groups about harm reduction and naloxone use.

Griffin's key focus in his work is promoting equitable access to harm reduction supplies across Vancouver Island, including safer sex supplies, safer injection and inhalation supplies, Take Home Naloxone, and affiliated information resources and clinical care. His job includes educating and training staff, both externally and internally, focusing on cultural safety, person-centred care and trauma-informed practices to promote safe spaces and interactions with care providers.

In the workshop Griffin will teach participants how to recognize an overdose, how to respond, and how to administer naloxone. This will include the opportunity for hands on training (with oranges!) to practice administering naloxone. All participants will receive a naloxone kit to take with them once they have completed the training.

This training is absolutely optional but I highly encourage everyone to attend if they are able! It is a really great opportunity to learn about harm reduction and naloxone from an expert in the field. Griffin's work helps keep people alive and safe on Vancouver Island and we are fortunate that he is willing (and happy) to take some time out to come visit us at the Leg and train us.

A calendar invite will follow—please RSVP so we can have an idea of numbers for the workshop, and so that Griffin knows how many naloxone kits to bring with him. I hope to see you there!
